



### JOHNS FAMILY BIBLE RECORD.

We are indebted to Mrs. Willie Johns Parish, of Roanoke, Va., for the following copy of a family Bible record. She states that Col. John Johns lived at New Store, Buckingham county. Edmund Winston Johns became a noted divine of his day.

From another source it is learned that Col. John Johns and Elizabeth Winston were married in 1766; that he died about 1821 and she in 1784 or 1788. Glover Johns, named below, married in 1803, Martha (born in Buckingham, 1780, died 1828) daughter of Joel Jones, and died in 1834 in Miss. Glover and Martha Johns had John Jay Johns, born June 27, 1818, in Buckingham Co., Va.; married Jane Amanda Durfree, and died April 3, 1899, at St. Charles, Mo. Glover and Martha Johns also had a daughter, Mary, who married William Cowan.

It has been stated that Elizabeth, wife of John Johns, was a daughter of Judge Edmund Winston, but this is a mistake. His daughter Elizabeth (1783-1856) married Dr. Bennett W. Moseley.

Gloucester county, Virginia, from Mr. Thomas Hanks. Captain Fox died before 16 April 1683 when his "son and heir" Henry Fox was granted a patent for this 200 acres which his father had purchased of Mr. Thomas Hanks and also an additional 100 acres "newly taken up" for the transportation of two persons into the Colony.<sup>4</sup> This three hundred acre tract is described as being in the counties of Gloucester and New Kent as the dividing line of the two counties ran thru it.

The loss of the Gloucester and New Kent court records makes it impossible to gain information from these once valuable repositories of authentic facts. We are positive that Henry<sup>2</sup> Fox was the eldest son and heir of his father Captain John<sup>1</sup> Fox, however, the records and traditions which have come to us indicate that Captain Fox left three other children:

1. Henry Fox, of whom more hereafter.
2. Ann Fox who married Chillon White of Gloucester county.<sup>5</sup> By deed dated 4 March 1703 Chillon White of Gloucester county bought land in St. John's Parish, King William county, from Henry Fox, Gentleman.<sup>6</sup>
3. Jane Fox who married Richard Johns. His will dated 12 January 1703 was admitted to probate before the King William county court 20 March 1703.<sup>7</sup>
4. John Fox, of whom I have no further information.

HENRY<sup>2</sup> FOX, GENTLEMAN, OF  
"HUNTINGTON", KING WILLIAM COUNTY, VIRGINIA

The first we know of Henry Fox is in 1683 when he was named in a land patent as "son and heir" of his father Captain John Fox.<sup>8</sup> On 6 June 1699 Henry Fox patented additional land in King and Queen county lying in what was then called Pamunkey Neck.<sup>9</sup> The following year on 24 April 1700 Henry Fox was

I have seen the statement a number of times in print that Richard<sup>4</sup> and Rose were the parents of thirteen children; it seems possible that some of those usually listed among the thirteen were grandchildren; two of his sons, Charles<sup>5</sup> and Zachariah<sup>5</sup>, settled in Amherst, where, and also in Nelson, they have numerous descendants today. A third son, Peter<sup>5</sup>, whose wife was named Anne, and doubtless was Anne Hackley, describing themselves as "of Spotsylvania County in the province of Virginia", sold in 1767, his portion of the Amherst land, "which was devised to me by my father Richard Taliaferro". Zachariah<sup>5</sup>, the father of Richard<sup>4</sup> died in 1726, the year in which Richard<sup>4</sup> and Rose were married; Zachariah<sup>5</sup> the son of Col John<sup>2</sup> died, presumably in the same year in which his will was probated, 1745, and certainly left no son. The inter-marriages between the descendants of Charles<sup>5</sup> and Zachariah<sup>5</sup>, in Amherst and Nelson have produced an involved relationship interesting genealogically, and typical of the early Taliaferros. In this connection a recent communication from Mr. Charles Elkin Drummond, of Amherst, may be quoted;

"Charles<sup>5</sup> and Zacharias<sup>5</sup> Taliaferro, who came to Amherst prior to 1758, were the sons of Richard and Rose Berryman Taliaferro, of Caroline Co.

"Charles Taliaferro married Isabella McCulloch; issue ten children. John, their third son, mar. Elizabeth, a daughter of Col. William Loving, issue six children; Isabella, their 6th daughter, mar. Zacharias Drummond; they were the parents of my father, Henley Drummond.

"Benjamin Berryman T., the 5th son of Charles, and Isabella (McC), mar. Mildred, a daughter of Major James Franklin; issue ten children; Mary Ann, their 4th child, mar. Richardson Henley, and they were the parents of my mother, Elizabeth (Henley) Drummond.

"Zacharias T. son of Richard and Rose, mar. first a Miss Boutwell; issue, nine children; Mary Boutwell, their 6th child, mar. Henley Drummond, son of John and Martha (Henley) Drummond; issue, six children; Zacharias, their third son, mar. Isabella, the 6th child of John and Elizabeth (Loving) Taliaferro, and, as stated above, were the parents of my father, Henley Drummond.

"Both of my grand-mothers were Taliaferros, the grand-daughters of Charles Taliaferro. My great-grandmother Drummond was also a Taliaferro, being the daughter of Zacharias<sup>5</sup> brother to said Charles<sup>5</sup>—the Mary Boutwell Taliaferro mentioned above".

On page 28\* Mr. Nicklin states that "Col. John Taliaferro, son of Charles<sup>2</sup> and Mary (Carter), of Caroline Co, lived in Williamsburg:
