Whereas by a former instrument of writing in the nature of a Deed of trust made by the said Winston to the said William Bentley, Efford Bentley & John Gills now of record in the Court of Amelia Co. conveying all his land in said County of Amelia to them in trust for the benefit of his four sons Samuel, Benjamin, John and William with a reserving clause in said Trust deed to sell all or part of said land with the concurrence of the Trustees, if it should be thought more advisable than to sell other property, and whereas the said Trustees have consented to a sale made to Moses Overton of 92,10/80 acres on condition that the said Winston shall secure to his said sons other property as an equivalent to the land. Know ye then that in consideration of the above sale of land to Moses Overton, I the said Winston do hereby grant bargain and sell unto the said William Bentley, Efford Bentley and John Gills, the following property, viz; Randolph, a negro man and

Lucinda, a woman, with all all my stock of horses, hogs, cattle & sheep, my household and kitchen furniture, utensils to be by them divided among my said four sons at my death in such manner and in such proportions as they may be entitled to in consequence of the sale made of their land as aforesaid to said Moses Overton and I do moreover by these presents give grant and hereby convey to my daughter Sally all my right to Judy and her children with her future increase for her and her heirs forever, which said negro woman Judy was given to my wife by her brothers during hers and my life, and by them afterwards given to my said daughter Sally. Nevertheless my intent and meaning in these presents are that the possession and use of all the aforesaid property is to be retained by me during my life anything however expressed to the contrary notwithstanding.
