And the said *Hugh Johnston* his Executors, Administrators, or Assigns, may make any Purchases at any Public Sales of Confiscated Property, (except such as shall be ordered by the Legislature for special Purposes;) and this INDENT shall be received in Payment.

For the true performance of the several payments in manner abovementioned, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the aforeaid ACT.
