So, apparently between 1800 and 1814 he moved to Tennessee. I have searched the 1810 Federal Census but didn't find him, but am going to the Archives again tomorrow to search to see if he was in S. C. or Tenn in 1810. His first son, Mathew, born April 1, 1799 was evidently born in Fairfield County, S. C. and is the one shown on the 1800 census.

The land grant given Joseph Kelley in Union County/(across Broad River from Fairfield) might have been Joel's father.

The Kelley's Mill on Enoree River Jan. 12, 1797 might have been connected with our Kelleys.

Elijah Kelley (drawn for jury duty in Spartanburg County, July 16, 1796) was probably his brother, if not his father. The names Elijah and Elisha have appeared in every generation, even until today.

The Kelleys you listed serving in the Civil War may have been his nephews. He and his sons were living in Bradley County, Tenn. I'm not sure Joel was living at the time of the Civil War. So far, I've traced him up to 1855 when he made his last application for Bounty land, because of his service in the War of 1812. He was 80 years old in 1855 when he made application. He was granted 80 acres in Bradley County, Tenn.
