Restorer Matthew Fletcher has met with Gottshall, McLeod, and Clamp to assess the Joseph Kerr memorial: see attachments. One of the four tablets below the obelisk has the following inscription:

After receiving a regular
Education at Yale College
And the public honors of that
Institution
He was trained at the school
At Litchfield
To the profession of Law
In the practice of which he was
Afterwards established
At Augusta, in Georgia.

The monument is marble, expensive, and likely imported from Italy. Joseph Kerr, Yale Class of 1816 and the Litchfield Law Scholl Class of 1817, a native of Rowan County North Carolina and a young practicing lawyer in Augusta, illustrates the national impact of early non-South Carolina colleges/schools here and the communication between the North and South in the early days of our republic. 40 Litchfield Law School (Connecticut) graduates during the school's existence between 1774 and 1833 were South Carolinians. Among them is John C. Calhoun in 1805. 1/5 of the nearly 1000 graduates were from the South. The Litchfield Law School educated 97 members of the US House of Representatives, 28 US Senators, 2 vice-presidents, Supreme Court justices and governors. It was really the first full-fledged, but proprietary, law school in America. Calhoun, by the way, graduated from Yale in 1804, and ¼ of the Litchfield students were Yale graduates. The tablet, mentioning both Litchfield Law School and Yale, is important in providing local documentation of this national connection. For example, John M. Clayton (Secretary of State under Zachary Taylor) and the artist George Catlin (who painted Native Americans) were students with Kerr in the law school class of 1817, as was Benjamin Huger Rutledge (1798 – 1850).

The immediate goal is to complete restoration by the end of June 2014 and have the public event to dedicate the monument and explain Kerr's significance by the end of November. The eventual goal is that this will be a seed project which will lead to the more complete restoration of the Community

Cemetery. The restoration of the monument itself in a professional way will cost \$4500 as is disclosed on the proposal from Matthew Fletcher which is attached.

 The result will be an established awareness of the Newberry Village Cemetery in Newberry as an historical asset to be preserved. Three organizations would be recognized at the dedication and presentation: Newberry County Historical and Museum Society, the Yale Association of Central South Carolina, and the SC Humanities Council. The historical data collected will be housed with the Society. The desired response of further restoration may take years. The attendance at the dedication/presentation and response of the media will help gauge its immediate impact.
