pounds four shillings and three pence
to Benjamin Ladd jun^r for ten pounds
eight shillings and six pence. And
to any other person or persons
in the same Situation as that of
Mr McCants, & Benjamin Ladd Sen^r
and jun^r -

Ordered that the Resolution be sent to the House of Repre-
