Richard Owings I bought 384 A from Thomas Lightfoot, "The Ranger", Anne Arundel Co, moved to Baltimore Co. Name spelled Owins, Owens, Owings, Owinger. He was Capt of the Rangers on Potomac River Oct 1697 - May 16, 1701. - Son Richard offered for sale 329A in Md Gazette (of Annapolis)

Richard Owings II b. Ann Arundel Co. latter half of 1688. died in Baltimore Co. 1736; married in Baltimore Co. ca 1710 to Sarah Hart, only dtr /o Stephen + Catherine Hart. Stephen died 1696-7. Catherine m ② John Scott ③ Henry Knowler. Sarah inherited from all three.

Richard Owings III m. Ann Stonestreet, d/o Edward Stonestreet of Charles Co., Md., sold her property in Baltimore Co., moved to Laurens Co., SC in 1787. - 8 children

Richard Owings IV In Revolutionary War - served 6 mo in Capt. John Roger's Co. + 6 mo in Capt. Chew's Co. under Col. Williams. Richard's will dated 8/13/1828 (Laurens Co. Will Bk-D-1, p. 266) names his 9 children. Dates of Richard + Sarah's death + birth of 8 children in Bible of Mrs. J. A. Owings, Norfolk, Va. Richard's Rev. Army Service given in South Carolinians in the Revolution by Sara S. Kruid, his pension Application S. 9449.

Richard Owings V died intestate, but 6 sons are named in settlement.

Mancil + Mitchell Lipscomb Owings - the app. dates are from 1850 + 1860 Census Records
