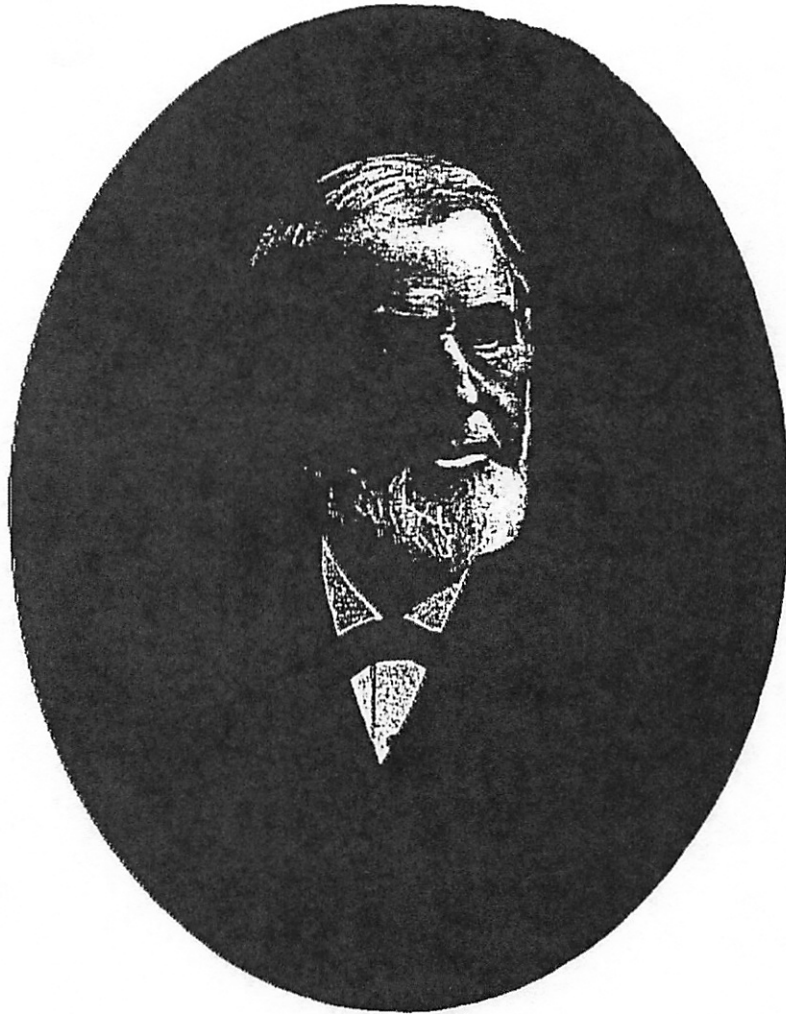

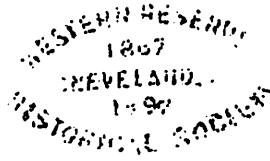

INTRODUCTION.

In this progressive age,—this age of investigation and research,—when everything of the past, present, and the future, is challenged; when knowledge of the minutest atom is studied by the microscope, and with the telescope the broad arch of heaven is closely scanned for new constellations, and perhaps for a new sun with its revolving planets, one need not make any apology for a desire to learn something of his ancestors,—where they lived, their moral character, their social position, their business qualities, and the influence they exerted on their time and generation and upon their descendants. We are all more or less under hereditary influences, and it will be wise for us all to learn their strength and character, in order to combat the evil and cultivate the good.

My father, during the latter part of his life, made a genealogical record of his immediate ancestors. At his death that record came to me, and some eight years since I commenced to extend and enlarge it; in fact, to look up the genealogy of the Ladd family. But I was not then aware how much time, labor, and life's energies it would require. My intention, at first, was to compile a simple genealogical record of the family, but I had not proceeded far with the work before it became evident that to make the book interesting it should contain traditions, scraps of history, and biographical sketches. This change in the scope of the work necessitated much additional labor.

The record is made mostly of the descendants of Daniel Ladd, who took the "oath of Supremacy and Allegiance to pass to New England in the Mary and John of London, Robert Sayres, master, March 24, 1633," and who settled first at Ipswich, next at Salisbury, and then went to Haverhill with Rev. John Ward and eleven others, and was one of the original settlers of that town.

We also have the names of quite a number of Ladds, who without any doubt are descendants of Daniel, but we regret to say that there is a "link" connecting them with him which we have not been able to find.

We have quite a number of the descendants of Joseph Ladd, who we feel confident was a younger brother of Daniel Ladd, and who came over at the same time he did. We also have a record of some of the descendants of John Ladd, who arrived at Burlington, N. J., in 1678. Then we have a John Ladd, who was in Virginia in 1678, and descendants of William and Amos Ladd, of Virginia, who are supposed to have been sons of John of 1678. We shall give a brief record of the Ladds of England, though the ancestors of Daniel Ladd in England have not been traced.

We find the name spelled De Lade, Le Lade, Lad, Lade, Ladde, and Ladd. There is a tradition that the first Ladds came to England from France with William the Conqueror, and settled at Deal, Kent county.

We take great pleasure in stating that all, with very few exceptions, bearing the name of Ladd, or connected therewith, of whom we have solicited information, have kindly and promptly sent us all the facts in regard to themselves and their ancestors of which they were possessed. We would be glad to mention them all by name, but space will not permit. We will therefore only mention the names of a few of those who have rendered special aid and assistance: Alexander H. Ladd, of Portsmouth, N. H.; Charles H. Ladd, of Washington, D. C.; Francis Ladd Cutter, of New York; Matthew J. Harvey, of Epping, N. H.; Miss Maria S. Ladd, of North Hero, Vt.; Nathaniel W. Ladd and David M. Ladd, of Boston; Miss Elizabeth M. Ladd, of Benson, Vt.; William Dudley Ladd, of Concord, N. H.; George W. Ladd, of Bangor, Me.; Mrs. Ellen C. Conklin and Miss Mariana C. Ladd, of Brooklyn, N. Y.; Gardner P. Ladd, of Groveland; Lewis A. Ladd and Dyer S. Smith, of Deerfield, N. H.; and Joshua Ladd Howell, Philadelphia, Pa.

This record has been compiled with great care, and extra effort has been made to have it correct; and yet we are aware that in it many errors may be found, but we trust there will be none which will mar its interest or impair its value.

One great trouble in obtaining correct results has been the

large repetition of christinn names, which in some cases became badly mixed ; and it required a great deal of time and patience to unravel them.

ABBREVIATIONS.—Bo., born ; ma., married ; dau., daughter ; d., died. When towns are mentioned, but not the State, it means Mass. ; *thus*, John Ladd, Haverhill, — John Ladd, Haverhill, N. H.

LADDS OF ENGLAND.

While no special effort has been made by me, or by any one to my knowledge, to trace in England the ancestors of Daniel Ladd, who came from London in the *Mary and John* in 1633, a brief record of some of the Ladds of England may be not only interesting, but may, at some future time, be useful as a reference to any one who desires a more extensive knowledge of the character and genealogical record of those who bear the name of Ladd.

We learn from Edward Wilds Ladd, of London, that his ancestry, the "first Lads, came to England with William the Conqueror from France—settled at Deal, Kent county, where a portion of land was granted them, eight miles from Dover,—Downes,—name spelled Lad, Lade, Ladd; his remote ancestors were seafaring people, Government pilots at Margate."

This looks reasonable when we remember that William the Conqueror first landed in England at Pevensey in the southeast part of Sussex co., moved his army to Hastings, which he fortified, and where the great "battle of Hastings," in which he won the right and title to the Crown of England, was fought. Dover, Deal, and Margate, in Kent co., are not far from Hastings, in Sussex, and it seems natural that many of William's followers should settle in Sussex and Kent counties. Elsewhere we find that "not many generations after the Norman Conquest the name of De Lad appears among the owners of land in the County of Kent, and ever since that day descendants of that family, spelling their name variously, according to the changes of time and circumstances, De Lad, Le Lad, Lad, Laddle, and Ladd, have held land in that and adjoining counties.

"Hastead, in his *History of Kent*, says the family is one of good antiquity in this county, in several parts of which they were possessed of land which still bears their name.

"In Snodland, near Rochester, and in Acris, there is an estate called Lad's, which had owners of that name in King Edward's

first reign, and at Eleham * * there is one called 'Ladwood,' which is elsewhere spoken of as a Manor. * * * Boswick, now called Boyke, is a Manor in the south part of the parish, which in very ancient times was the residence of the Lads, who in several evidences are written De Lad. He also alludes to other lands that were owned by them.

"In the History of Hampshire, one William Ladd is mentioned as a juryman in 1294 in the reign of Edward I. In the History of Surry it is said that in 1325 King Edward II. bought the Manor of Henle from Walter De Henley, of which he granted the custody to Walter, Bishop of Exeter, but the next year revoked the grant and transferred it to Walter Lad. This Manor contains 1344 acres, and yields a net revenue for the year of £17 11s. 10d. From 1713 to 1722 John Ladd represented Southwark, in Surry, in Parliament, and was created a Baronet in 1740."

LADE OF BOUGHTON HOUSE.

John Pryce Lade, Esq., of Boughton House, Co. Kent, is a magistrate of that county, and Major in the East Kent Regiment of Militia.

LINEAGE.

John Ladd, senior, of Eleham, Co. Kent, dying in 1476, left a son John Ladd of Eleham, who d. in 1527, having had by Alice his wife, with other issue, three sons: 1, Stephen, father of Thomas Ladd, of Otling; 2, John, father of Nicholas Ladd, of Wooton, whose eldest son Nicholas, of Swingfield, Co. Kent, gent., d. in 1669, leaving a son, Nicholas of Swingfield, buried at Hythe in 1699; and 3d, Thomas Ladd, of Barham, whose son, Thomas Ladd of Barham, m. Elizabeth, sister and heir of Thomas Mumbra, of Sutton, near Dover, and d. in 1602, aged 76, leaving, with daughters, a son Vincent Ladd, of Barham, who m. in 1575 Agnes, dau. of Vincent Denne, Esq., of Denne Hill, and d. in 1625, having had with other issue Robert, of whom presently; and Thomas of Barham, gent., who m. 1614 Margaret, dau. of William Denwood, and d. 1662, leaving, with other issue, two sons: 1, Vincent, bo. in 1615, father, by Eliz-

abeth Knowles, his wife, of an elder son, Thomas, who ma. and had issue, and 2d, Thomas of Warbleton, Co. Sussex, father of Sir John Lade, M. P., created a Baronet in 1780. (See Burke's Extinct Baronetage.) Mr. Vincent Lade's eldest son, by Agnes, his wife, Robert Lade, Esq., of Barham, Recorder of Canterbury in 1668, ma. in July, 1619, Mary, dau. of William Lovelace, of the Friary of Canterbury, and d. in 1666, leaving, with younger issue, a son, Lancolet Lade, Esq., barrister at law, who d. in 1687, leaving, by Elizabeth Barrett, his wife, with other issue, two sons, Vincent, of whom presently, and Philip, of Barham, gent., who ma. Catharine Nethersole, and had numerous issue. The former, Vincent Lade of Archbishop's Palace, and afterwards of Burgate, ma. Ann, dau. of Kitè, Esq., of Hond House, in Bleane, and by her, who d. in 1720, left, at his decease in 1730, with other issue, who d. unm., two sons: John, the elder, bo. in 1695, ma. in 1723 Mary, dau. of William Frend, gent., of Wingham, and d. in 1766, leaving two dau. Ann ma. Isaac Ismay, of London, merchant, and Sarah ma. Charles Topping, of London. The younger son, Michael Lade, Esq., bo. in 1698, ma. 1st, in 1723, Eliza Evel, by whom he had two dau. who d. young. He ma. 2d, in Oct., 1730, Elizabeth Dodd, of Haverhill, widow, and by her was father (with a dau. Elizabeth, ma. to Benjamin Brown,) of two sons. Michael, the younger, barrister in law. ma. Sophia, relict of James, 6th Baron Cranstown. The elder John Lade, Esq., of Boughton, bo. 18 April, 1734, ma. 12 June, 1757, Hester, dau. of Hills Hobday, of Faversham, and had (with one dau., Hester, ma. to Will Stacy Coast, of Chartham Deanery,) three sons: John Hobday, of whom presently, William of Jesus Coll., Camb., and Charles, an officer in the army. The eldest, John Hobday Lade, of Boughton, an officer in the army, ma. 2 Jan., 1791, Eliza, dau. of Evers, Esq., and niece of Sir John Powell Pryce, Bart. of Newton Hall, Co. Montgomery, and by her had (with a dau. Marie, ma. to Wastee Brisco, Esq., of Bohemie, Co. Sussex,) a son, the present John Pryce Lade, Esq., of Boughton House.

Crest.—A leopard's head, ppr. Seat.—Boughton House, near Faversham, Kent.

In "Nooks and Corners of English Life," by John Timbs, page 155, there is an expense account of Queen Isabella in 1358. Among many items charged is one of the 12th Sept. After the Queen's death a payment of twenty shillings is made to William Ladd of Shene, (Richmond,) on account of the burning of his house by accident while the Queen was staying at Shene.

1770, May 8. Miss Maria Ladd,¹⁰ aged 11 years, 5 months; in West Cloister. 10—Daughter, and evidently only Child of Nicholas Lade, one of the Abbey Choir. She died, according to the Funeral Book, 4th May. Her father died at Windsor, 9th July, 1783, and was described in the Journals of the day as "Mr. Nicholas Ladd, Senior, gentleman of the H. Ms. Chapel Royal, at St. James, a member of St. Peter's Westminster. father of the Choir of H. M. Chapel of St. George in Windsor Castle, and a member of the Collegiate Chapel of Eton." He was a sworn gentleman of the Chapel Royal, 15 Aug., 1743. His will (signed Nicholas Lade) as of Windsor Castle, Gent., dated 2 June, 1783, was proved 18 Sept. following by his relict Frances. He directed to be buried, if he died in London, in the Abbey Cloister, near his daughter and her grandmother. (See her burial as Mrs. Mary Smith, 17 Sept., 1773.) He bequeathed his real estate to his wife absolutely, and also the interest of £450 for her life, after which the principal was to go to Hannah Lade, widow of his deceased brother Charles Lade, her three daughters, Frances Ann, and Hannah Lade, and his niece Daloe. If his nephew, Charles Lade, who was at Madras when last heard from, should return to England, he was to have his musical instruments.

DANIEL LADD.

- (1) Daniel Ladd took the Oath of Supremacy and Allegiance to pass to New England in the Mary and John of London, Robert Sayres, master, 24th of March, 1633-4.

The first record we find of Daniel Ladd, after his arrival in New England, was at Ipswich, where "the 5th of February, 1637, there was granted Daniel Ladd six acres of land." On this land he built a dwelling-house, which eleven years later he sold to Henry Kingsbury, as we find by the following deed :

This present writing witnesseth that Daniel Ladd, of Haverhill, in the County of Norfolk, husbandman, for and in consideration of ten pounds to him in hand paid, have bargayned and sold and by these presents doth confirm that his bargayne and sale unto Henry Kingsbury, of Ipswich, in the County of Essex, husbandman, all that his house wherin the said Henry now dwelleth; situate and being in Ipswich, aforesaid. In the street called High street, having the orchard and garden of William Payne on the Northwest, a lene towards the Southeast; one end abutting on the said street; butting at the other end on the land of Thomas Safford. To have and to hold the said house with the land about it, and all the appertences and privelidges thereto belonging; unto the aforesaid Henry Kingsbury and his heirs for ever.

In witness whereof I have hereunto set my hand and seal, 31 of March, 1648.

We next find him at Salisbury, where, Oct. 29, 1639, "According to ye first division of ye town of Salisbury there was granted unto Daniel Ladd one acre, more or less, for a house lot, lying between the house lot of John Ayer and Robert Pitts; also there was granted him four acres, more or less, for a planting lott, lying between the planting lotts of John Clough and Willie Allen, butting upon the highway leading to the mill and the great swamp, lying towards the ferrie."

Also there was granted him two acres, more or less, of meadow, lying between the lotts of Anthony Sadler, &c.

1640, 7th 9 mo. Att a Gen. Meeting of y^e freemen there was granted unto Daniel Ladd two acres meadow, more or less, lying to the eastward of the Elder's meadow towards Hampton.

Y^e 20th of 12 mo., 1642, at a general meeting of y^e freemen, it was ordered y^t y^e 22 lotts granted on the east side of Merrimack and Pauwau River shall be to these persons that have drawn lotts for y^m. Daniel Ladd's lot No. 21. All y^e lands granted to these (22) persons above named to be layed out at y^e West end of y^e second range of lotts on the West of y^e Pauwau River and to be contained between y^t and y^e great pond on y^e West. 15th of y^e 11th mo., 1643. At a generall meeting of the freemen there was granted unto John Ayer, Daniel Ladd, John Clough, John Dickson, two acres of meadow, each of them, lying upon the north-east side of y^e little River, over ag^s. Mr. Dow's and Mr. Munday's Meddow.

Ye 12th of April, 1654. These p^rsents wittnes y^t I, Daniel Ladd of Haverhill, in y^e County of Norfolk, have bargained and sold unto Vallentine Rowell of y^e same County in Salisbury, four acres of planting land n^t comonage belonging thereto att Salisbury old towne, bounded by John Clough on y^e south west, and Willis Allen on y^e North East and Swamp at y^e lower end and y^e highway at y^e upper end, for and in consideracon of a valuable consideracon Allready pay'd w^{ch} four acres of planting land more or less and comonage y^e aforesald partce or grantee is to have and to hold to him, his heirs, executors and use'gns forever. In witness whereof I have hereunto sett my hand: DANIEL LADD. his T marke.

This bill of Sale was acknnowledged by Daniel Ladd to be his act and deed in y^e Court held att Salisbury, y^e 11th of y^e 2^d mo., 1654.

L me THO: BRADBURY, rec'd.

Daniel Ladd removed from Salisbury to Haverhill, and was one of the original settlers of that town.

Chase, in his history of Haverhill, says: "The first company of settlers in the wild woods of Pentucket (Haverhill) was as follows: William White, Samuel Gile, James Davis, Henry Palmer, John Robinson, Christopher Hussey, Jobu Williams, Richard Littlehale, Abraham Tyler, Daniel Ladd, Joseph Merrie, Job Clement."

Laud granted Daniel Ladd, as per Town Records:

Six acres of accommodation, Four acres to his house lot, more or less; Robert Clements bounding on the East, and Henry Savage on

the West; Five acres in the plain, William White on the East and John Williams on the North.

Nine acres up the great river, Thomas Ayer on the East, and George Brown on the West, Four acres of meadow in the east meadow, more or less, Joseph Peasley on the south and George Brown on the north. One acre and a half of meadow in the pond meadow; James Davis, Sen., on the south, and Robert Clement, Jun., on the north; one acre of meadow at Hawkes' meadow; John Davis on the south, and Thomas Whittier on the north. All these parcels are so much as is expressed, more or less.

It was acknowledged by John Robinson at a town meeting on the 16th of April, '49, that Daniel Ladd had bought six acres of accommodations of him, which the town granted him.

Daniel Ladd's 2d Division, containing twenty-seven (27) acres of upland be it more or less, with sixteen acres of ox common, and a half, bounded by George Corley and John Hutchins on the west; by a black oak, and a white oak, a red oak and a walnut on the south, by a walnut and a white oak on the east, by two white oaks and an ash on the north; Three (3) acres of meadow lying on Spiket River, bounded by Thomas Davis on the South and Robert Clement on North; and one spot of meadow at Primrose swamp, and another spot at the East meadow, at the head of the meadow that was John Davis's adjoining his own.

For the land that was taken off Daniel Ladd's 3d division we added a piece on the north side of the highway round the meadow that was Goodman Hale's, bounded by the highway and Merrie's creek.

3d Division of meadow containing 5 acres, be it more or less, bounded by John Page on the south, a pine on the east, his own upland on the west and upland on the north of the said meadow, lying in Mistake meadow.

Daniel Ladd, Sen., laid out to Goodman Ladd sixty acres of third division land lying upon Mistake meadow, bounded as followeth, viz. : A swamp by Samuel Gile east, and a black oak west, and a white oak south, and a white oak south-east. This parcel, according to the bounds mentioned being returned under the hands of George Brown and James Davis, Jun., as lot layers and by them allowed to be entered and recorded, was accordingly done, July 20, 1673.

We whose names are here subscribed, namely, James Davis and Robert Swan, Lot layers, having laid out a parcel of land of three score acres unto Daniel Ladd, Sen., which was addition to his third Division and cut off by the line, and it appearing that we were mistaken in the measure, the land wanting measure, having visited the land again; have now settled the bounds as followeth:—

Beginning at a great marked pine tree in a swamp, which is the north corner bounds of a parcel of land laid out formerly to John Ayer, and from thence to a black oak northward, upon the north-side of a pine swamp, and so eastwardly, or north-east to a pine tree marked, standing upon a knoll, to the northward of a hill called John Ayer's Darby-hill, on the north-east side of a small brook, and from thence southward to a marked pine tree on the south, or toward the south-east side of the aforesaid Darby-hill, which is the north-east corner bound of John Ayer's land, and so upon John Ayer's line to the first mentioned bound tree, which land was laid out by us, James Davis and Robert Swan. This parcel coming under the hands of James Davis, Jun., and Robert Swan as lot buyers and being allowed to be recorded under the hands of James Davis, Jun., and Robert Clement, April 4, 1878. Was according to the said return entered upon record April the 4th 1878.

Upon April the 10th 1891 this which followeth was presented to me to be recorded, viz. :

Dated in Haverhill the 21st, 1888.

Daniel Ladd, Sen., having the better part of his third division of meadow at Mistake taken off by the line, and so by that means is content to lay down all his meadow there and to take it up other where. We whose names are underwritten being lot buyers appointed for that end have laid out instead thereof three parcels of meadow and meadow bottoms, as followeth to the said Ladd, viz. :

One piece of meadow by the north-east corner of an oak-hill, which hill is about two miles north-eastwardly from the upper bridge at Spicket river.

The bounds of the meadow are, a white oak marked at the lower end eastward, and so round southwardly and westwardly by upland to another white oak marked, and so cross the brook to another white oak marked, and so eastwardly by upland and across the brook to the first named. The second is a rubbidge piece of meadow bottom about a hundred rods eastwardly of the first, bounded by a pine on the north side, and so round by the upland running westwardly and so by the upland eastwardly to another pine tree marked, and so on to the first named.

The third is a little piece of pretty good meadow, about a half a mile eastward of the second, being bounded in all parts by the upland; with a convenient way to all the said pieces of meadow from said Spicket meadow or bridge.

Laid out by us, JAMES DAVIS. ROBERT SWAN.

Underwritten,—Allowed to be recorded by us. JAMES DAVIS, ROBERT CLEMENT.

As an addition to the return of the three pieces mentioned and entered April 10, 1891. This that follows was underwritten:—Know that wherens, the above writing does express that I, Daniel Ladd, Sen.,

is content to lay down my interest in my meadow at Mistake and to take it up elsewhere; I do hereby declare that on the consideration of the above expressed three parcels of meadow being allowed of record and confirmed to me, I do renounce all my right and interest in that and in every part of that meadow at Mistake before named.

As witness my hand this 9th day of April 1601.

Daniel Ladd Sen.'s 4th division of upland.

The forty third lot in the fourth division with the additions, is laid out to Daniel Ladd, containing one hundred and eighty acres, more or less,—bounded with a white oak marked C. L., thence north ninety poles to a white oak marked L. W., thence west three hundred thirty-two poles to an ash marked L. W. standing at the east end of Mr. Ward's 4th division lot, thence south ninety poles to a black oak marked C. L., thence east three hundred thirty-two poles to the bounds first mentioned; reserving what meadow there may be laid out in it, and what meadow is unlaid out in said lot, exceeding two acres in a piece with a highway to them, having also made allowance for an highway twelve rods wide across the west end of the lot. This lot adjoins on the north side of the 42 lot, laid out to the commoners. This being returned and subscribed by Richard Hassen and James Ayer as lot layers, for the *fourth* division, was accordingly entered June the thirteenth day 1718.

This fourth lot was laid out by the town in 1659, but it would seem that Daniel Ladd's lot in this division was not entered until 1718.

Chase, in his History of Haverhill, page 62, says: "Daniel Ladd doubtless found farming quite a different thing from what most farmers of the present day find it. His house lot was in the village; his planting ground in two places,—a part of it 'in the plain,' from one to two miles east of the village, and the other part 'up the great river,' at least as far, on the west of the village,—while his meadow lands were in seven lots, and as many distinct meadows. East meadow was in the easterly part of the town, three miles from his home lot, while Spicket meadow was at least eight miles in the opposite direction. Pond meadow was two miles north-east; Hawkes' meadow some three miles west; Primrose swamp two miles north-west; and Mistake meadow somewhere in the westerly part of the town.

"When we reflect that in those days 'highways' were at best

but primitive cart paths through the woods, with stumps still standing, hills ungraded, and streams unbridged, and that the land was new, rough, and worked only by great labor, we may have a faint idea of some of the hardships of our first settlers. Had they not been men of iron nerve, tireless muscle, and indomitable energy and perseverance, our now beautiful town, with its unsurpassed mosaic of cultivated fields, green hills, smiling lakes, its majestic river, and murmuring streams, would still be a waste and howling wilderness, the home of wild beasts, and the hunting ground of the miserable aborigines."

In 1646 Daniel Ladd was taxed forty ponnnds (£40.)

At a town meeting, June 12, 1651, it was ordered that Hugh Sherratt, Theophilus Satchwell, Bart Heath, James Fiske, and *Daniel Ladd*, " Shall view the upland that is fit to plough, by the last of March or the tenth of April next, and that they bring in their intelligence to the town by that time."

In 1659, "*Daniel Ladd* and Theophilus Shatwell, having received liberty from the town, erected a saw-mill on Spiggot (Spicket) River. It was built within the present limits of Salem, N. H., and was the first one erected upon that stream. The proprietors were required to pay the town *five pounds* per annum for the privilege."

In 1668, Daniel Ladd was one of the selectmen of Haverhill.

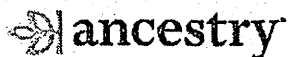
In 1688, Daniel Ladd voted against building a new meeting-house " upon the lot where the old meeting-house stands."

He was a very energetic and enterprising man, and held many positions of trust and responsibility. The records indicate that he was an extensive farmer, and that he dealt quite largely in laud.

In 1675, Daniel Ladd, Peter Ayer, and Thomas Whittier, were appointed to designate what houses should be garrisoned.

From Registry of Deeds, Old Norfolk :

Daniel Ladd, Sen., and his wife Ann of Haverhill, sold George Brown of same place, five acres of planting land in the lower playne, be it more or less, bounded by land holden by William White, on y^e east and at y^e north-east corner wth a white onk marlt, and at y^e same side at y^e River wth a stake, and on y^e west side by land holden by John Williams, Sen., and wth a stake at y^e north-west wth a stake, for and consideration of y^e full sum of five and twenty pounds all ready paid, to have and to hold, &c. Signed by these marks, viz. : This mark,) her mark. March 6, 1681. 1: 208.

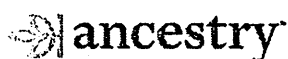

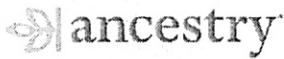
