DR. CURETON WAS THE FATHER OF 16 CHILDREN. THIRTEEN OF WHOM ARE LIVING. OF HIS FIRST MARRIAGE 3 ARE LIVING J.S. CURETON OF GREENVILLE, J.P.CURETON OF CHATTANOGA AND MRS GEORGE LATIMER OF CHESTER.

BY HIS LAST WIFE, WHO SURVIVES HIM ARE MRS.J.D.RATTERREE, AND MRS.RICHARD WILKES, CHESTER, MRS. JAMES WILKES, FAIRFIELD; MRS R.E.YONGUE, PICKENS; MRS. CARRIE ROBINSON, RIDGEWAY; MISS MARTHA CURETON, SENECA; MISS GUSSÆE CURETON, PICKENS AND WINTHROP COLLEGE; MR. CHARLIE CURETON, PICKENS; AND DR. GEORGE CURETON, GREER, S.C.

O.M.ABNEY; MINISTER OF THE DECEASED. THE MINISTER PAID A BRIEF BUT BEAUTIFUL EULOGY TO THE LIFE OF THE DECEASED. HE SAID IN PART "AS A FRIEND, HE WAS FAITHFUL AND TRUE; AS A CHURCHMAN, HE WAS BROAD AND LIBERAL; AS A CHRISTIAN, NOTED FOR HIS STRONG FAITH IN GOD; AS A SOLDIER, HE WAS BRAVE AS EVER CARRIED A SWORD; AS A HUSBAND, HE WAS KIND AND AFFECTIONATE; AS A FATHER, PATIENT, DEVOTED, AND GENTLE AS A DOVE.

AFTER THE SERVICE AT THE CHURCH THE REMAINS WERE INTERRED IN THE PICKENS CEMETARY, THERE TO AWAIT THE RESURRECTION MORN.
