LAW BLANK No. 2-TITLE TO REAL ESTATE-DEED S. W.

THE STATE OF SOUTH CAROLINA,

KNOW ALL MEN BY THESE PRESENTS, THAT

We, Mary Belle Croeland, and Kathleen Lemmon, of the County of Fairfield,

in the State aforesaid, in consideration of the sum of Sixteen Hundred DOLLARS, to us in cash paid unto the undersigned persons by H. G. Phillips, of the County of Fairfield,

in the State aforesaid, the undersigned hereby acknowledge, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said H. G. Phillips, his heirs

and assigns:-

All of our undivided right, title and interest, same being an interest in fee simple, in and to all that certain piece, parcel or tract of land lying, being and situate in the County of Fairfield, State aforesaid, fronting on State Highway No. 219, which bounds it on the South, and being also bounded by lands of W. J. Lemmon on the East; lands of Mrs. Susie Diggins on the West, and by lands of E. L. Stevenson on the North. This is the identical tract of land devised to us under the will of our grandfather, J. M. Lemmon, which will is of record in the office of the Judge of Probate for Fairfield County. Said tract contains two hundred and thirty acres (230) more or less.

The grantors herein agree to have a plat made of the above lands and deliver same to the grantee at their expense.

TOGETHER with all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises before mentioned unto the said H. G. Phillips, his Heirs and Assigns, forever.
