Lewis, Warren

He served as a lieutenant in the militia under Col. Taylor and was in the battle at Eutaw Springs. (Nix, John, S31683); Yearbook, 1893.

b. 9 October 1759, Caroline County, Va. He enlisted during the summer of 1776, while residing in the Fairfield District under Capt. Francis Tidwell and Col. John Winn. In 1779, he was under Capts. Charles Lewis (his brother), John Willing and Col. William Goodwin-In December 1779 or January 1780, he served under Capt. John Smith. In August 1780, he

served under Capt. Charles Lewis and was in the battle at Fishing Creek. He was taken prisoner but, being able to sieze a horse, he escaped. Thereafter, he joined Capt. Joseph Scott and Col. Baker of Georgia. Next, he was under Capt. Lewis and Col. Edward Lacey. During 1782, he served in the militia and provided beef. A.A.4559; 1356; X13.
