This data on Lyles has been compiled from what data is listed in the South Carolina State Archives in Columbia, but does not include the data under Miscellany. However I did check Miscellany for any David Lyles.

### Problem:

- I William Howard Sutton d. 7-9-1905 in White Co. Tenn and married 1-27-1876 to Ella Franciscola Falkner, dtr. of Mary Jane Thompson and William Spencer Falkner of Wilson Co. Tenn.
- William H. Sutton was the son of LeRoy Sutton b. 1813 and son of ElizabethCartwright and George Sutton of Tenn. LeRoy Sutton m. Elizabeth M. Young b.21 Aug. 1816 in Jackson Co., Tenn.
- III Elizabeth M. Young was the daughter of James Young 1788-1860 who married Elizabeth Draper 1788-1871.
- IV Elizabeth Draper was daughter of Thomas Draper 1768-1840 and who married Sallie (Sarah) Liles 1766-1844. They married 9 Aug. 1787 ether in S.C. or in Tenn. They left S. C. and came to Jackson Co. Tenn. Sometime just before 1800.

### Sarah Liles

She is thought to have been the daughter of David Liles and in 1840, David Lyles, aged 84, was in the census of Jackson County, Tenn. as a Revolutionary pensioner and residing in the home of Joshua Draper......Now, Joshua Draper was the son of Thomas Draper and his wife, Sarah Liles.

Thamas Draper of Union County S.C. and a will sg. August 0/M 1811 and pr. 14 Jan. 1812...../Wit. George Bouser, Maher Lyle, and Nathaniel Gordon......I went to Union to study this file and instead of the names in the will, I take estate settlement.....No wife was listed in the will and she was deceased..By dower rights we know that the wife of Thomas Draper Sr. was named Lucy \_\_\_\_ and by other data we know she was named Lucy Colman....The executors of the will were William Draper and Joshua Draper, sons of Thomas Sr. The following men made the inventory: John Thompson, Phillip Coleman, Charles Jones, Nicholas Cavanach, & Aquilla Cavanach.......Buyers at the sale included by the name of Draper:

William Draper Joshua Draper William Toney
Thomas Draper John Burgess Thomas Dean
Phillip Draper Maher Liles Daniel Draper
And many others......The estate was divided into Ten shares and a final division was made 9 June 1813. (continued)

James Draper a share and residing in Warren Co. Ga.

Joshua Draper a share and residing in Va....m. Nancy Wilkins

Abrham Toney and for his children (not named). William was one.

Thomas Dean of Edgefield Co. for his children.

I do not know which Draper Daughters wed Thomas Dean and Abraham Toney....The deceased daughters of Thomas Draper Sr. were named Sarah Draper and Ann Draper and both were married.

Joshua Draper son of Thomas Sr. and his wife, Nancy Draper and residing in Nottoway Co. Va. In 1815 sell all their Union Co. land. Travis Draper sells all his Union Co. land in 1807, no dowery. Thomas Draper Sr. and his wife Lucy Draper sell lands in 1796 to William Chisholm. And many land deeds by Thomas Draper Sr., The last time Lucy signed with him for her dower was in 1803 when he sold to William Kennedy....The last deed made by Thomas Draper Sr. was in 1806 when he sold to Nathaniel Gordon, but in 1806 his wife, Lucy Draper signed no deed....James Draper, the son, died in Warren Co. Ga. 14-Aug-1843....He drew a Revolutionary pension and stated he was married to Obedience Hudson 14-Sept.-1781 and she later drew his pension. James Draper served under Capt. Robert Lyle in S.C. and under Col. William Thompson. Joshua Draper in 1829, in Nottoway Co. Va. Makes affidavit that he is younger brother of James Draper.

The 1790 Census for Union Co. S.C. shows:

LYLES, in Draper files: James Draper served under Capt. Robert Lyle..Maher Lyles helped take inventory of estate of Thomas Draper Sr. as the clerk for John Thompson....Maher Lyle also was on file here...Maher Lyle was a shortened form of his full name which was in full as Mahershalalhashbaz Lyle and under that name he took a land grant of 183a on South Pacolet River in Union Co. the 2<sup>nd</sup> day of December 1811. The Union Co. deed books show him as having bought land prior tp 1811.

I have found Lyles spelled in various way by the clerks and even by the Lyles men themselves, Leisle and Loyle were two forms. I did not detect at first and did not check for land grants under these last two forms of spelling, forms found was as follows:

Some of the Leisle forms, the clerk had a Leslie or Lesley and it was hard to detect what was ment. As stated, I did not check Leisle and Loyle save in a few instances after I discovered these spellings.

Andrew Leisle-a plat marked Bounty for 100a on Tyger River in Berkeley Co. surveyed 20-July-1772 by Alexander Turner and Bounded by vacant land and land of John Robison. The plat was endorsed "Andrew Leisle".

Anne Lyther-a plat on N. E. side of Broad River in Craven and surveyed for her by John Pearson, 8-June-1753 upon her entering for a patent for 100a land as a single woman the 20-Oct.-1752 and all sides of the 100a land being vacant land.

Ephriam Liles-a plat for 100a land surveyed by Joseph Curry, 5-Jan.-1757 on Rocky Creek and all sides by vacant land, and entered for him in Craven Co. the 6<sup>th</sup> April-1756, said plat delivered to Mr. Phillip Raiford for Ephriam Liles.

Ephriam Leisle-A Memorial Tax return made in Charleston for 100a of land granted to him on Rocky Creek and all sides vacant and said 100a granted by King George II the first day Aug.-1758.

Williamson Loyles-a plat surveyed by Enoch Pearson, 11-Nov.-1768 for 350a entered for Berkeley Co. by Williamson Loyles the 4-Nov.-1766 and on a small branch called Beaverdam of the Enoree River. Plat delivered to Robert Allison for Mr. Williamson Loyles. (This was Liles, as I learned later)

James Loyle-a plat for 150a land in Berkeley Co. and between the Broad and Tyger Rivers and all sides by vacant land, surveyed 9-May-1770 by Richard Winn. (This was also Lyle as I later found out.)

Robert Lyell-Was a Captain in the Revolution and later a Major (See #5 James Draper). He owned 700a land in Richland County on Mill Creek (First known as Raiford Creek) and this land was bounded by the lands of Isham Moore, Samuel Brown, Joseph Wyatt, John Thompson, and Lydia Culpepper. This land was bought and same granted the 2-Oct.-1772. (from Green's History of Richland County)

### 17-(misprint from original)

From a Local History of Fairfield County in Traveling Library DAR: "Ephriam Lyles was an early settler in Fairfield on the Broad River in the area which adjoins Newberry County. Ephriam Lyles was born in England in 1732 and came first to Virginia and then later came to Fairfield County S.C. and settled on the Broad River and here he was killed by Indians as he defended his home. The date of his death is not known. The first name of his wife is unknown as well as her her surname. He had two brothers who came also to S.C. from Virginia and they settled on the other side of Broad River in what is now Newberry County. The eldest son of Ephriam Lyles was named Arramanos Lyles and he was the first white child born in what is now Fairfield Co. S.C. but then Craven County. Arramos Lyles was born in 1748 and died in 1817 and married in 1774 to Rebecca Valentine.

Memorials Book 6 page 241 is found the first name of the wife of Ephriam Lyles, dated 23-March-1764, John Lyles makes a tax return in Charleston for Mrs. Anne Liles, the widow of Ephriam Liles for 100a land in Craven Co. at a place called Liles Ford on the Broad River and bounded by a 100a tract of land laid out for Anne Lythes (Also spelled Leythes) and the said 100a originally granted to \_\_\_\_\_blank\_\_\_\_and sold by him with a dower by his wife, Anne Margaret to Ephriam Liles by a deed dated 3-April-1755, and also for another 100a land on Broad River in Craven County originally granted to \_\_\_\_blank \_\_\_\_and sold by him with dower by his wife, Ann to Ephriam Liles by a deed 3-April-1755. Ephriam Liles is now deceased and died intestate and will no will. Anne Liles is his widow and now makes this tax return on behalf of herself and her children, minors. Return made by John Liles and dated 23-March-1764. Here we see and get an idea as to when Ephriam Liles was killed by Indians and before 23-March-1764.

Arramos Liles a Memorial Tax return made in Charleston, 19-Dec.-1769. Arramos Liles states he is now aged 21 and is the son and heir of Ephriam Liles, now deceased, and being the eldest son and heir, under the Law of Primogeniture, is the only heir to the land of his father, Ephriam Liles, now deceased. Arramanos Liles describes the same 200a land above exactly as described in #18, including the blank space for the original grant but after each 100a adds "Ephriam Liles, now deceased and this 100a descended to his eldest son and heir, at law, Arramanos Liles". To this Memorial return is added a postscript "P.S. Anne Liles, widow of Ephriam Lileson behalf of herself and her children, made a return on this same 200a land the 3<sup>rd</sup> day of March 1764, (#18 says 23-March-1764)

Judge Belton O'Nealin his book, "The Annals of Newberry" which was written in the 1840's and published in 1850 states "Three brothers, Williamson Lyles, (see #15), John Lyles, and Ephriam Lyles, came to the Broad River before the Revolution. John and Williamson Lyles settled on the Newberry side, while their brother, Ephriam Liles settled on the Fairfield side. All were too old to take an active part in the fighting of the Revolution, altho John Lyles was a Colonel. Colonel Maybin told me that old man Ephriam Lyles was killed while defending his house and he thought about the beginning of the Revolution". (From #18, we know Ephriam Lyles was killed before 1764) (Further From O'Neal)

Ephriam Lyles, the first settler on Broad River in Fairfield had five sons, as stated to me by Col. Benj. Maybin. All Five sons were patriots in the Revolution. They Were:

Col. Arramanos Lyles as a captain

Col. James Lyles who died at Chester S.C. 1-July-1780 from wonds of battle. He left a widow and 3 small infants. One of the infants was Elizabeth Lyles who wed Col. Benjamin Maybin.

William Lyles, who was known as "Big William".

Ephriam Lyles, who was known as "Big Ephriam".

Henry Lyles

Col. John Lyles-Before the Revolution was captain of the Militia and commanded the Fork Company and by his men called Col.. The Fork being that area between the Enoree and Tyger River. Col. John Lyles was killed at the Battle of Hanging Rock.

All of these sons of Ephriam Lyles served in the Revolution, Two were killed, James and John.

Col. John Lyles, the brother of Ephriam and Williamson Lyles took part in the Snow Campaign. He died 1-Jan-or July 1780. O'Neal states he thinks Col. Maybin may have confused this Col. John with his Nephew, Col. John Lyles.

O'Neal states further: The widow of James Lyles married a second time to a Mr. Goree and had some children by him besides the three Lyles children. One of the Goree children was Lucy Goree who was a half sister of Mrs. Benjamin Maybin (Elizabeth Lyles). Samuel E. Kenner was a step son of Maj. Spencer Morgan. Samuel E. Kenner married as his first wife Miss Patsey Grasty and by her had five children and upon her death married as his second wife, Lucy Goree and by her had 8 children.

Williamson Lyles was too old to fight actively in the revolution. One of his sons, "Little" Ephriam Lyles took an active part in the Revolution. (O'Neal)

Sarah Lyles was married to Thomas Draper Jr., 9<sup>th</sup> of Aug. 1787 and since in #6 Thomas Draper was still residing in Union County, S.C., it would seem logical to me that Thomas Draper wed her in Union County. See # 35 and the Liles who were in 1790 in Union, one was Mrs. Sarah Liles, with herself and three daughters. I have no idea as to whom she was the widow of. Also note in 1793 that Maheer Lyle got lands in Union and was a witness of the will of Thomas Draper Sr.

At a Court held 13-Jan-1820 did appear John Liles and Silas Keller who stated that when the within named Ephriam Liles did sign his will and that he did wed again and has two children by his last wife, Elizabeth Liles. Judge of the Ordinary, Thomas T. Cureton, presiding did revoke the said will of Ephriam Liles under the law passed in 1791 which abolished the right of Primogeniture. The widow of Major Ephriam Liles, Mrs Elizabeth Liles did make an agreement to take only a chil's portion of the estate of Major Ephriam Liles. Whereupon Judge of the Ordinary, Thomas T. Cureton, did order the estate to be divided into 12 equal portions. The widow to take one portion and then one portion to be given to each of the eleven children of Major Ephriam Liles, deceased. This Ephriam I take to be the son of Williamson Liles # 42.

Arramos Liles.....In a Memorial Tax Return dated in Charleston 19-Dec.-1769 states that he is now aged 21 years and is the eldest son and heir of Ephriam Liles deceased and as such under the law is entitled to heir all of this land of his deceased father and thereby makes a return for 200a of land on Broad River at Liles Ford.....Mention as a postscript that the widow Anne Liles on behalf herself and her children had made a return some years before.

From other data.....John Liles who made the return for the widow Anne, was her brother-in-law.

Charleston was the County Seat of all of South Carolina and hence all deeds, wills, and estates from 1670 to 1785 are in Charleston.
