In the Robert Hill notes (or a probate record document I found based on his notes) Thomas W. Macon witnessed a signature for a land sale to William Turner in 1823. We only have an approximate date of birth for Thomas, so it occurred to me that for him to witness this deed, he must have reached the age required for that at that time.

Do you happen to know, or know where I can find out, what the required age would've been in order to witness a signature during that time period? 16? 18? 21?

I just noticed that the very last page appears to be cut off at the end of the last page, which appears to be page 4 of the document? He starts a sentence, "Heartwell..." that is probably finished on page 5.

Outside of my interest in Woodward and Turner, there's this nagging Macon question. We believe that Charlotte Woodward was the mother of Charlotte Turner, but also of Thomas Woodward Macon (another 3rd great grandfather of mine) from her marriage to John. The closest thing we have to proof for that is the deed for their intent to marry. But then, assuming that John is Thomas' father, we don't have anything other than yDNA evidence to connect us back to the main Macon line that includes Heartwell. So, I'm really interested to see if page 5 continues Hill's case 3 to indicate why he assumed John was related to Heartwell Sr. Can I get a copy of page 5?

- I'm hung up at Charlotte Turner, daughter of William Turner (whose death information is unknown) who was the second husband of Charlotte Woodward.
- Charlotte was the daughter of William Woodward and Nancy Barrett, both of whom are buried in Fairfield Co.
- William Woodward was the son of Thomas "The Regulator" Woodward and his first wife, Jemima Collins.
