ALSTON, CHARLES J.P. The widow Mary J. Alston having relinquished her right to administer, Willis Alston was apptd. admr. May 9, 1876 and took inventory in Jan., 1877. Heirs were Willis Alston, Samuel C. Alston, Leonidas Alston (age 14), C.J.P. Alston (age 10), Leonidas Alston (of full age [sic]) and the widow. Willis Alston was apptd. gdn. of the orphan Charles J.P. Alston May 2, 1881, who had received a legacy from the estate of Mrs. M.A. Thompson of Bertie County.

ALSTON, FRANCES A. Gideon H. Macon qualified as exr. Oct. 25, 1875 and took inventory the same date. The dec'd. left many heirs : Miss Amarillus A. Alston (sister of the dec'd.); Mrs. Dorothea E. Daniel (sister of the dec'd.); John C. Alston, Gideon Alston, T.M.C. Alston, Anna M. Arrington, Frances A. Faulcon (wife of James H. Faulcon) and Miriam Allen (wife of C.B. Allen, dec'd.), the last six being children of a dec'd. brother John Alston; Gideon B. Alston, Havana S. Cook (wife of Charles M. Cook of Warren Co.), children of a dec'd. brother Gideon Alston; Gideon A. Harris (Carroll Co., Mississippi) and Stephen Bobbitt (Warren Co.), children of a dec'd. sister Temperance Bobbitt, formerly Harriss; Frances A. Upshur (Le Flour Co., Mississippi), Florence Johnston (wife of F.M. Johnston of Warren Co.) and Gideon H. Macon, children of a dec'd. sister Arabella A. Macon; Frances A. Bobbitt, Gideon C. Bobbitt, N.M. Bobbitt, Elizabeth Bobbitt, Emeline Bobbitt and Dorothea Hammill (wife of T.J. Hammill), children of a dec'd. sister Mary A. Bobbitt, the wife of Charles Bobbitt.

MCPHERSON, JOHN Inventory and account of sales given Dec. 17, 1821 and Jan. 12, 1822 by T. Burgés, admr.

MABRY, MARY J. Albert Mabry qualified as exr. Sept. 3, 1879 and took inventory Dec. 31, 1879. Heirs were Albert Mabry, McKinnie L. Mabry and Mary Albert Arrington (wife of W.H. Arrington).

MACON, GIDEON H. The widow Lou G. Macon qualified as exrx. Dec. 13, 1877 and gave an account of sales Feb. 20, 1878. Heirs were the widow and her minor children : Philemon Jenkins Macon, Hal Thomas Macon, Jesse Madison Macon, Gideon Hunt Macon, Mattie Bell Macon, Lula Jenkins Macon, Francis Atherton Macon, Lizzie Holman Macon and Sarah Jenkins Macon. William E. Spruill was apptd. gdn. of the orphans, Jan. 24, 1878. Said gdn. filed accounts for Gideon (Feb. 22, 1878 to Mar. 8, 1886), Jesse (Feb. 22, 1878 to Mar. 8, 1886), Francis/Frank (Feb. 22, 1878 to Apr. 4, 1889), Mattie (Feb. 22, 1878 to Apr. 4, 1889), Philemon (Feb. 22, 1878 to Feb. 20, 1879), Hal (Feb. 22, 1878 to Feb. 20, 1879), Lula (Feb. 22, 1878 to Apr. 4, 1889), Lizzie (Feb. 22, 1878 to Apr. 4, 1889) and Sarah (Feb. 22, 1878 to Apr. 4, 1889). Mrs. L.G. Macon was apptd. gdn. of Lizzie, Sarah and Frank, Oct. 30, 1889. C.A. Cook, subsequent gdn., filed accounts for Frank, Lizzie and Sarah from Ddec. 26, 1891 to Feb. 22, 1892. (a voluminous record)

MAGUIRE, D.J. Thomas Fitzpatrick was originally apptd. admr. but moved to Baltimore, MD. The widow Bernie Maguire was then apptd. admr., Mar. 24, 1879 and took inventory Mar. 22, 1880. Final account from June 4, 1879 to June 14, 1881 with H.F. Maguire, admr. (sic) Heirs were the widow and two minor children : Thomas and Mary Maguire.

MALLORY, ELIZABETH J.V. Newsom qualified as exr. Nov. 10, 1884 and took inventory Feb. 2, 1886. Account current with the exr. from Nov. 1, 1885 to Aug. 9, 1886. The only heir was Martha E. Mallory (now the wife of Jerry V. Newsom).

MANNING, C.A. John P. Futrell qualified as exr. July 1, 1889 and took inventory Sept. 4, 1889. Account current with the exr. from June 15, 1889 to Nov. 23, 1894. Distributive shares went to Lavinia (Lou) Stephenson, J.H. Futrell, J.P. Futrell, Anna Pope (wife of B.A. Pope) and Adelaide Pope (wife of J.R. Pope).

MANNING, JOSHUA Inventory taken Mar. 13, 1815 by William Whitehead, Sr., admr. Account of sales Mar. 14, 1815. Pheraba Manning was a noticeable buyer.

MANNING, JOSHUA Account current from Mar. 14, 1863 to Oct. 15, 1871 with Turner Bass, admr. Heirs were Lemon, John Henry and McG. Manning (all brothers of the dec'd.), Mary Elizabeth Strickland (wife of Thomas Strickland and sister of the dec'd.), Daniel Manning (half-brother of the dec'd. living in Arkansas) and Mrs. Elizabeth Badger (half-sister of the dec'd. living in Arkansas).

MARSHALL, ALEXANDER John J. Marshall qualified as exr. Aug. 9, 1886 and gave an account current from Aug. 9, 1886 to Aug. 9, 1887. Heirs were J.L. Marshall (a minor), Mrs. M.E. Marshall and John J. Marshall.
