

B. 162-164: 25 Jan 1790, John Franklin of Chester County to William Shaw of same, for £100 sterling, 17 acres, part of tract granted to John Franklin 24 Dec 1772, also part of another pattent dated 20 Jan 1785 to John Franklin, 106 acres in Camden District on waters of Sandy River. John Franklin (L)S, Wit: Samuel Craig, William Rainey (X).

B. 164-165: 15 Sept 1789, Richard Taliaferro & Milley his wife for 92 english guineas, tract granted to Hazel Hardwick and by him conveyed to Richard Taliaferro. Richard Taliaferro (LS), Milley Taliaferro (LS), Wit: Will Boyd John Wright.

B, 167-170: Lease and release. 6 & 7 April 1788, John Yarbrough Senr of State of SC to Littleton Randolph Isbell of Chester County, for £100 sterling part of grant to John Land for 250 acres on north side Rockey Creek adj. Lewis Yarbrough, dated 16 July 1765, recorded in Book ZZ[?], page 161 and sold to said John Yarbrough Senr. John Yarbrough Senr (LS), Wit: Jno'a Hemphill, Daniel Muse Senr, William Yarbrough.

B, 172-175: Lease and release. 25 & 26 Feb 1790, Daniel Comer & Elizabeth his wife of Union County to Allen Degraffenreid of Chester county, for £100 sterling, 200 acres in Chester county on waters of Sandy River, 100 acres granted to Samuel Wells & Conveyed from him to Col. Thomas Fletchall, the other 200 acres granted to said Fletchall and by virtue of an act of the Assembly of this State the same is vested in Daniel Comer. 

Jenkins 2 Dec 1790 before John Pratt, J.P.

B, 349-352: 25 March 1791, Isam Fielding & his wife Elizabeth of Camden District, Chester, planter, to David Hyatt of same, for £20 sterling, tract granted 1 Sept 1768 by SC to Wm Gaston, late of aforesaid province, 100 acres on waters of Fishing Creek adj. Elizabeth Crag, released to James Neely 18 Jan 1769, and recorded in Book D-4, page 61 16 April 1773. Isam Fielding (X) (LS), Elizabeth Fielding (X) (LS), Wit: Benjamin Reives, William Pace [Peace], Williamson Harper (X). Proved by the oath of Williamson Harper 5 April 1791 before Phillip Walker, J.P.

B, 353-355: 29 Nov 1790, Thomas Leonard of Chesterfield County, SC, to Joshua Crook of Chester County, SC, for £75 sterling, 231½ acres in Chester County on a draft of Fishing Creek, part of tract granted to David Leonard, the said Davis Leonard dying intestate and the said Thomas Leonard his son became heir to all his lands,, granted 23 June 1774, the grant containing 146 acres and the above conveyed 231½ acres is to be cut off the south end of said tract adj. Wm Crook. Thomas Leonard (LS), Wit: John McCreary, Alexander Walker, Solomon Crook. Proved in Chester County by the oath of Solomon Crook 5 April 1791 before Phillip Walker, J.P.

B, 355-358: 28 Feb 1791, Peter Jones, Sheriff of Chester County, to James [sic] Wylie, whereas Abraham Wright in the County Court of Chester did implead Archibald Clerk on an action of debt and in October Court in 1790 did obtain judgment, and there should be levied £11 s10 d6 sterling, sheriff sold 22 Nov last 200 acres on Fishing Creek on the ridge between it and the Catawba River, granted 27 Nov 1770 to Archibald Clerk, sold to Francis [sic] Wylie for £7 sterling. Peter Jones sheriff (LS), Wit: Abraham Wright, James McClintock. Proved by the oath of James McClintock 6 April 1791 before John Mills, J.P.

B, 358-360: 15 Jan 1791, Benjamin Reives, planter, to William Harper, planter, for £5, 161 acres between Sherod Willis & Wilson Henderson, William Shadrit, Green. Benjamin Rives (LS), Wit: Wilson Henderson, Jacob Cooper, Thomas Neely. Proved by the oath of Jacob Cooper 5 April 1791 before Phillip Walker.

E, 117-119: 30 Dec 1795, Mary Evans of Chester County to Matthew McClintock of same, for £80 sterling, 100 acres in Chester county on waters of Sandy River on a branch thereof called the south fork, granted to Owen Evans 1 May 1786, surveyed for said Owen Evans 1 Jan 1771, recorded in Grant Book IIII, page 456, and said Owen Evans did convey to Mary Evans by deed 17 Jan 1789, recorded in Chester County Book C, page 357. Mary Evans (Seal), Wit: Owen Evans, James Kennedy, John Willson. Proved by the oath of John Willson 18 April 1796 before John Pratt, J.P. Recorded 17 May 1796.
