Issue of August 13, 1831

Died in Columbia on the 7th instant of Pulmonary Consumption,
Joseph M'Clintock, Esq., aged 35 years. Mr. M'Clintock was a
native of Massachusetts, and graduate of Browns University--A
gentlemen of amiable and unassuming manners and for several years
past a respectable member of the Bar in this place.
