Stephen Mazyck and Alexander Mazyck, Mazyck, late of Charlestown, gentleman, Thant, for £8000 SC money, part of lot 13 June 1775 William Mazyck devised he should not choose to reside and live William did appoint his brother Stephen and Philip Porcher, his kinsman Gabiriel Mary during her widowhood executors. James Guillaudeau of Charlestown, barber, Thant, for £500 SC money, 500 acres of Thickette Creek waters of Broad River sold from Vardry Magby's. James Guillaudeau and Boomer Junr. Proved in Camden District before Geo: Sheed, 7 Nov 1778. Recorded 14 Dec 1778. William Graham made oath that the land was burnt at Mr. John

Z-4, 100-103: Lease & release. 25 & 26 Aug 1778, Timothy McClintock of Parish of St. Marks, SC, carpenter, to James Laman of same, weaver, for £100 SC money, tract granted 26 July 1774 to said Timothy McClintock, 250 acres on waters of Fishing Creek adj. John and William Knox, Abraham Wright, Widow McClure, William McClure, Widow Hannah, widow English. Timothy McClintock (LS), Wit: John Knox, William Knox, Samuel Morrow. Proved in Camden District before Philip Walker, J. P., by the oath of John Knox 28 Aug 1778. Recorded 14 Dec 1778.

Z-4, 103-104: 4 Jan 1772, Thomas Langley of Berkley County, SC, planter, to Joseph Gourley of St. Davids Parish, Craven County, for £200 SC money, 150 acres in Craven County on Jefferys Creek, being the place where John Young lately lived, granted to said Thomas Langley. Tho's Leingley (LS), Wit: Reuben White, Daniel Cane. Proved in George Town District by the oath of Daniel Cain 18 Nov 1775 before Tho's Ames. Recorded 14 Dec 1778.

Z-4, 104-106: Lease & release. 3 Aug 1772, Bartley Clark of Craven County, planter, to Joseph Gourley of same, planter, for £100 SC money, 200 acres, part of 400 acres in Craven County on Jeffreys Creek granted to said Bartley Clark 4 Dec 1771. Bartley Clarke (LS), Wit: Peter Keighley, John Hitchcock. Proved in George Town District by the oath of Peter Keighley 12 Sept 1778 before William Davis, J.P. Recorded 14 Dec 1778.

Z-4, 106-109: Lease & release. 29 & 30 Oct 1778, Samuel Maverick of Charlestown, carpenter, and Lydia his wife, to Cornelius Sullivan of same, carpenter, for £550 SC money, part of lot on north side Guignard Street adj. land of Patrick Bower, Joseph Roper, William Kelsey. Samuel Maverick (LS), Lydia Maverick (LS), Wit: Alex'r Forrester, Tho Lind. Proved in Charlestown District by the oath of Thomas Lind before Geo: Sheed 2 Nov 1778. Recorded 14 Dec 1778.

Z-4, 109-112: Lease & release. 1 & 2 July 1778, Thomas Bourke of Charlestown, merchant, to James Leeson of same, merchant, for £25,000 SC money, three northernmost brick tenements with the lot of land thereto belonging at the south east corner of Broad Street and Church Street in Charlestown adj. John Ward Taylor, Benjamin Huger. Thom's Bourke (LS), Wit: Tho's Horsey, Tho's Phepoe. Proved in Charlestown District by the oath of Thomas Horsey 13 Nov 1778 before Geo: Sheed. Recorded 14 Nov 1778.

Z-4, 113-115: Lease & release. 25 & 26 June 1777, George Adam Keller of State of Georgia, Butcher, to Daniel Gartman of Ninety Six District, SC, Shoemaker, for £100 SC money, 50 acres granted 13 March 1752 to George Adam Keller between Saluda and Broad Rivers on a branch of said River. Georg Adam Keller (LS), Wit: Balthasar Shaffer, George Richardson. Proved in Charlestown District by the oath of George Richardson 9 Nov 1778 before Geo: Sheed. Recorded 14 Dec 1778.

Z-4, 115-119: Lease & release. 4 & 5 Nov 1778, William Strother of Parish of St. George Dorchester, planter, and Dolly his wife, to Thomas Singleton of Charles Town, innkeeper, for £7510 SC money, whereas said William Strother by virtue of the will of his father Charles Strother, late of Charles Town, Butcher, deceased, dated 12 July 1766, as of deed 6 & 7 Feb 1775, to him made by John Cross of Charlestown, Wharfinger, and Sarah his wife, part of lot number 103 in Broad Street, adj. Mrs. Mary Cooper, late belonging to the French Church or congregation, Peter Bocquet, two undivided fourth parts of said tenement, and whereas Mary the wife of Thomas Singleton formerly Mary Strother and widow of said Charles Strother deceased is intitled to one equal fourth part. William Strother (LS), Dolly Strother (LS), Wit: John Blott, Bracey Singleton, Joseph Dewitt, B.
