this our INDENTED CERTIFICATE, for the Sum of *One hundred and fifty pounds* *plus* *the* *arrears* *paid* *and* *owed* *by* *the* *troop* *to* *him* *and* *his* *heirs* *and* *assigns* *in* *the* *year* *1782* *to* *be* *paid* *to* *him* *and* *his* *heirs* *and* *assigns* *by* *the* *Treasurer* *of* *the* *State* *of* *South-Carolina*

the said *John McWaters*
his Executors, Administrators, or Assigns, will be entitled to receive from this Office the Sum of *Seven hundred and eighty Shillings*

on the *first* *of* *October* *1785* for one Year's Interest on the principal Sum of *One hundred and fifty pounds* and the like Interest annually *from* *the* *first* *of* *January* *1783*

The said *John McWaters* his Executors, Administrators or Assigns, will be entitled also to receive, and shall be paid, if demanded, the principal Sum of *One hundred and fifty pounds* on the *first* *of* *October* *1786*

And the said *John McWaters* his Executors, Administrators or Assigns, may make any Purchases at any Public Sales of Confiscated Property, (except such as shall be ordered by the Legislature for special Purposes;) and this INDENT shall be received in Payment.

For the true Performance of the several Payments in Manner above-mentioned, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the aforesaid ACT.

GIVEN under our Hands at the TREASURY-OFFICE, in CHARLESTON, the *fourth* Day of *October* One Thousand Seven Hundred and Eighty-*four*.
