COMPLAINT

The plaintiffs above named, complaining of the defendants herein, allege that:

1. This is an action to quiet title to property situate in the County of Fairfield, State of South Carolina, in the within

named plaintiffs or, in the event that title cannot be quieted in the plaintiffs, for a partition of said premises between the plaintiffs and any persons who may be determined to own interests in and to said premises, as tenants in common with plaintiffs.

2. The premises which are the subject of this action are described as follows:

All that certain piece, parcel or tract of land, lying, being and situate in the County of Fairfield, State of South Carolina, containing 42.5 acres, more or less, and having such special shape and such metes, courses and distances as shown on a plat thereof prepared by R. P. McMeekin surveyed in 1954, and also shown as Tract 4 on a plat of lands of Mobley, recorded in the office of the Clerk of Court for Fairfield County in Plat Book "4" at page 3; said tract being bounded northerly by lands of Katherine Mobley Sweeney, et al. and by the center line of South Carolina Road S-20-32, across which lie lands, now or formerely, of J. D. Mobley and lands of William C. Mills; easterly by lands of Boise Cascade Corporation and southerly and westerly by lands of International Paper Company.

Mobley and David M. Mobley, and her sisters, Eliza M. Kennedy, Sue D. Crawford and Frances Elizabeth Mobley Hall and Martha W. Mobley.
- 5. Mary R. Mobley thereafter departed this life intestate on or about the year 1921 leaving her surviving as her only heirs at law her sons, Samuel Mobley, Arthur L. Mobley, D. B. Mobley, Eugene W. Mobley, John D. Mobley, Edward L. Mobley and David M. Mobley, and her daughters, Martha W. Mobley, Eliza B. Kennedy, Sue D. Crawford and Frances Elizabeth Mobley Hall.
- 6. The said Elizabeth Frances Mobley Hall thereafter departed this life intestate in the County of Fairfield, State of South Carolina, on or about the 8th day of January, 1925, seized and possessed of an undivided 1/11 interest in and to the property described in paragraph two of the complaint and leaving her surviving as her only heirs at law her husband, Daniel Hall, and her children, Sarah H. Arnette, J. H. Hall, Jr., J. Carlisle Hall, John Bratton Hall, J. M. Hall, Daniel Hall, Jr., James Leland Hall, Sue Hall Davis and Bessie Hall Sprott.
- 7. The said David M. Mobley thereafter departed this life intestate on or about the 7th day of January, 1931 in Birmingham, Alabama, as plaintiffs are informed and believe, leaving him surviving as his only heirs at law his widow, Augusta Mobley, and his children, Edward Mobley, David Mobley, Jr. William Mobley, Samuel Mobley, Sr. and Augusta Mobley; by deed dated May 21, 1910 and recorded in the aforesaid Clerk's office in Deed

Book "BB" at page 66, the said David M. Mobley had conveyed to his wife, Augusta G. Mobley, "all my right, title, interest and estate of inheritance that I may now have or may hereafter have as heir of my mother" in a tract said to contain fortynine acres, more or less, which tract is apparently one and the same as the tract described in paragraph two of the complaint.

- 53. The said Dan Hall thereafter departed this life on or about the year 1984 in Birmingham, Alabama, leaving him surviving as his only heirs at law and/or devisees his widow, Ann Hall, and his daughter, Donna Hall, and his son, Dan Hall.
- 54. Sarah Joseph M. Doss departed this life on or about the year leaving her surviving as her only heirs at law her sons, Jimmy Doss, Billy Doss, Tommy Doss and Bobby Doss.
- 55. The tract described in paragraph two of the complaint was known as the home place of Mary R. Mobley and ther late husband, Edward Dixon Mobley, and it was generally accepted among the members of the Edward Dixon Mobley and Mary R. Mobley family that D. B. Mobley would succeed to the ownership of said home place upon the death of Mary R. Mobley, the said D. B. Mobley having remained on the home place and cared for his mother, Mary R. Mobley, and his unmarried sister, Catherine (D. Mobley; that although the deed from Eugene W. Mobley, etalabetto D. B. Mobley referred to in paragraph 14 of the complaint is the only deed of record whereby various members of the Edward Dixon Mobley and Mary R. Mobley family conveyed their respective fundivided interests in the home place to D. B. Mobley, plaintiffs are informed and believe that the other members of the Edward Dixon Mobley and Mary R. Mobley family who did not sign said deed and who were seized and possessed of undivided interests in and to said premises, recognized D. B. Mobley as being the sole owner of the home place and that their respective interests were conveyed or otherwise effectively transferred to the said D. B. Mobley by some method not appearing of record. In any event, plaintiffs are informed and believe that the said D. B. Mobley went into exclusive possession of the property described in paragraph two of the complaint on or about the year 1939 and continued in actual, open, notorious, exclusive, hostile and

uninterrupted possession thereafter until the time of his death in the year 1948; that following the death of D. B. Mobley the plaintiffs herein and their late brother, James Mobley, under whom they claim, have been in continuous, hostile, open, actual, notorious and exclusive possession of the premises described in paragraph two of the complaint up to the time of this action.

WHEREFORE, plaintiffs pray that the defendants may be required to set forth the nature of their claims, that all adverse claims of the defendants may be determined by order of this court; that the defendants be forever enjoined and debarred from asserting any claim whatever in and to said land or premises adverse to the plaintiffs; or if title to said premises cannot be affirmed and quieted then for a partition of said premises by a sale thereof; that the proceeds of such sale may be brought into court and the net proceeds thereof, after payment of all costs, be divided among the parties, according to their respective rights and interests, and for the costs of this action, including a reasonable fee for the services of plaintiffs' attorney in this action; and for such other and further relief as may be just and equitable.
