NATHANIEL MILLER, 11 Aug. 1774: 100 acres in when runout in Tryon County, N. Carolina, on both sides of Tyger River joining his own upper line. Bounded on his own line; NE by the river; NW near John Nichol. Originally granted 22 Dec. 1768 to the memorialist by Govr. Tryon, but by a late resurvey, now falls in S. Carolina, in Craven County. William Demmy. [12-544:3]

DENNY ANDERSON, 11 Aug. 1774: 150 acres, when runout in Tryon County, N. Carolina, on both sides of S fork of Tyger River, including mouth of Reedy Fork. Originally granted by Govr. Martin to Denny Anderson 22 May 1772, but by a late resurvey of the boundary between N. and S. Carolina the tract falls within S. Carolina, in Craven County. Delivered 25 Nov. 1774 to William Denny. WILLIAM MCMACKEN, 11 Aug. 1774: 150 acres when runout in Mecklenburg County, N. Carolina, on both sides of Tygar River, including a place called the Narrow Passage and his own improvements. Originally granted by Govr. Tryon to the memorialist 26 Oct. 1767, but by a late resurvey, now falls in S. Carolina, in Craven County. William Denny. [12-545:2]

WILLIAM CHICKEN, 11 Aug. 1774: 200 acres in Craven County, St. James Santee Parish. Bounded by vacant land. Originally granted 19 Sept. 1758 to Jacob Nicholas Schwartzkopff, and by him conveyed to William Chicken, the memorialist, by L & R 1 and 2 Apr. 1764. Also, 150 acres, part of a grant of 250 acres in Craven County, St. James Parish Santee. Originally granted to Thos. Jones 10 Apr. 1771. The remaining 100 acres is taken away: 35 acres by Edward Jerman, and 65 acres by Govr. Wright, so that no more remains than 150 acres, which said Thos. Jones conveyed to William Chicken by L & R 14 June 1771, bounding SE on William Chicken; NE on vacant land; NW on James Wrights and Danl.
