Victor Neely (Rev. War)

Neel, William

He served in Capt. John Bowie's Independent Company. A.A.5450; Z560.

Neeland, John

He served two months as a cattle collector during 1782 and supplied beef for Continental Line use during 1783. A.A.5468A; G274.

Neele, William

He was in the Second Dragoons under Capt. Francis Moore, Lt. Col. Myddleton, and Gen. Sumter during 1781 and was dead around August 1781. Salley, Doc., p. 81; M363.

Neely, David

He served in the militia and was in the battles at Orangeburg and Congaree Fort. In addition, he served thirty-five days at Fort Lacey under Col. Boggs during 1780. He also served under Capts. Cooper and Isaac Hayne. A.A.4109; A.A.5451.

Neely, George

S4613

After volunteering, while residing in Camden District, on 20 May 1780, he served under Capt. John McClure. He was in the battles at Williamson's Plantation and Rocky Mount under Captain John Steele and Col. Lacey. In 1782, he was elected captain under Col. Lacey and was in an engagement at Congaree. A.A. 5454; R593.

Neely, Hugh

He served forty days as a horseman in the militia during 1781 and supplied sundries. A.A. 5455; R594.

Neely, James

He served in the militia after the fall of Charleston. A.A.5453; T303.

Neely, John

S11140

While residing in Laurens District, he enlisted under Capt. John Wallis. Next, he was under Capt. Daniel Williams in a company of rangers. He was sick and not present when Cunningham attacked Hayes's Station and hung Williams. After Williams's death, he was commanded by Lt. William Farley. (Moved to Ala.) A.A. 5456; T302.

Neely, John

b. 1744, Ireland
d. 1837

While residing in Waxhaw Settlement, he enlisted in the Third Regiment on 24 July 1776. He served under Capt. Eli Kershaw. In addition, he served ten months in Georgia under Capt. Pettigrew and Colonel Jack. He was wounded in a skirmish at Camden. McCall, III, 175; Annuitants Claims; N.A.853.

Neely, Matthew

He served one hundred fifteen days in the militia. A.A.5456B; L322.

Neely, Robert

m. Jane (Jenny) Berry, 8 November 1791 While residing at Fishing Creek, he was drafted under Lt. Joseph Steele, Capt. William Hanna, and Col. Bratton. He was wounded in the head during the engagement with Tories at Cracker's Neck. In addition, he served as a substitute for his father (Hugh Neely) under Lt. William McLane, Capt. Samuel Adams, and Col. Lacey and was marched to the Cowpens, where he remained four months engaged in foraging. (Moved to Va.) A.A.5457; O118.

Neely, Robert, Sr.

He served ninety-five days in the militia during 1781. A.A.5457; L318.

Neely, Robert, Jr.

He served one hundred nine days in the militia during 1781. A.A.5457; L317.

Neely, Samuel

He served in the light horse under Captain Thompson during June, July, November, and December 1780. At sometime, he was a lieutenant. In March 1781, he served as a wagoner and was also a horseman under Capt. Mills during 1781. He was a captain in the militia under Col. Hill during 1781. A.A.5458; M160; Salley, Doc., p. 65.

Neely, Thomas

He served twenty-seven days in the militia during 1782 under Lt. Turner and provided sundries for militia use during 1780. A.A. 5470; L320.

* **Neely, Victor**

He served one hundred nineteen days in the militia during 1781 and 1782. A.A.5451A; X105.

Negley, Gasper

He served in the First Regiment under Capt. George Turner during 1780. Salley, Doc., p. 37.

Negro, Brain

He enlisted in the Sixth Regiment on 7 October 1777. N.A.853.

Negro, Ned

He enlisted in the Sixth Regiment on 25 August 1776 as a drummer. N.A.853.

Negro, Peter

He enlisted in the Sixth Regiment on 14 De-
