It is hemmed like the ordinary handkerchief that is hemmed by hand. It has one hole near the center that would measure something like an inch round and then there are several other rents in it of similar dimensions. This handkerchief passed through the revolutionary war, and through our late civil war and has always been taken the greatest care of and been preserved as a precious relic of the days before the American Revolution.
