The U.S. Census records, indicate that Stephen Nolan Sr. was born in South Carolina. However some researchers believe they came from Union County N.C. or the general area. This well could be correct. Since Union Co. N.C. was created from parts of Anson and Mecklenburg Co's in 1842. This was much to late for our ancestor.

Union Co. S.C. was created from District 96. (in 1796). Dist. 96 was one of the seven original districts, created when S.C. became a state 1788.

However it be, we have good reason to believe Steven Nolan was born in this general area about 1790.

Since the name of Stephen Nolan's father and mother are unknown, the earliest records located to date are the 1840 U.S. Census. ~~the~~ Macon Co. Ala. Macon Co. Ala. Created 1832 from Creek

Indians lands.

In 1840 Stephen Nolan was listed as married, living with wife and (9) children. (7) girls and (2) boys. Macon Co. Ala.

It is not known where Stephen and his wife were married or when.

Since one of the daughters was over 20 years old in 1840. Stephen probably married 1815-20.

Nancy Nolan probably was the oldest child ^{of Stephen Nolan}. She married E.W. Jones, April 15, 1838. It can be presumed that she was not one of the above listed female children. Elias W. Jones married Martha Nolan, July 17, 1845, and also married the third sister Jane Sept. 3, 1846. Jane, better known as Jenny outlived her husband many years. Elias Jones is buried in Smyrna Cemetery a few miles north of Harleton, Texas. (Harrison County) There are no dates on the gravemarker (Name only)

12th Nov. 1862. Harrison, Co. Texas.

Check on their children. Or did they go west with Stephen?

Jenny Nolan-Jones is buried in Eagle Springs cemetery a few miles west of Smyrna Cem. The grave is unmarked, several of her children and other close relatives are buried at Eagle Springs.

Jenny and Elias Jones were the parents of eight (8) children, three (3) daughters and five (5) sons.

Elias and Nancy had two (2) sons. ^{check their sons descendants}

Elias and Martha had no children.

Nancy and Martha both died in Alabama.

Three other children, possibly more died in Alabama or elsewhere.

Dr Joe Funderburk mentions a daughter Lucindia, probably died young.

David Nolan. born Oct. 12, 1824 S.C. and Stephen Nolan Jr. b. circa 1830. were the only known sons of Stephen Sr. and his wife.

The Nolans, Jones and Gillis left Macon County Ala. after 1840 and before 1850.

Stephen Nolan Sr., Stephen Jr., Elias Jones and J. Gillis all located in Harrison Co. TX. about 1854. I have not been able to locate them in 1850.

The 1860 Harrison Co. TX. U.S. Census list S. Nolan - 70yrs. farmer born S.C.

In the same house is listed S. Nolan, female, born S.C. This 30 year old female could be an error. Stephen Jr. is not listed and is known to be in this area in 1860. so some researchers believe the 30 yr. old is Stephen Jr.

Some of our Texas Cousins believe Stephen Sr. had a daughter Sarah that never married, also there are stories of Uncle Jerry Neither can be confirmed. (could be Jeremiah, brother to Stephen of Ala. family)

Stephen Nolan Jr. joined the Confederate Army. March 28, 1862 at Dallas, Texas.

He returned to Harrison Co. and married Catherine E. Gillis Nov. 12, 1863. He was discharged from the army June 27, 1862. His age was recorded as 33 years.

In his narrative; "History of Be-Twix the forks of the Cypress". Dr John Chad Vividly describes conditions in the area of north Harrison Co. Tx. during and shortly after the Civil War. He mentions Stephen Nolan as operator of a lumber and grist mill on Cypress Creek.

Tradition tells us that Stephen Jr. was sorely grieved at the conditions existing in the area. He told his Nephew Sat the end of the Civil War.

Jesse Jones that he was moving to California
So off they went, never to be heard from
again. It is thought that Stephen Sr. and
others of the Nolan family went along, that
is if there were others.

Elias Jones and Jenny remained in Texas,
Many Nieces, Nephews, grandsons and granddaughters
still live around Harleton, Texas.

A reunion is held each year in May. The

David Nolan the eldest of two (r) known sons of Stephen and his wife.

David born Oct. 12, 1824. died May 6, 1891.

David born in ^{N.C.} (N.C.) moved with his parents to Macon County Ala. by 1840.

Since Macon County was created from Indian lands in 1832, (Creek Indian Cession) it is presumed that Stephen Nolan and his family came to this area after 1832. They are recorded in Macon Co. 1840 U.S. Census. This is the earliest known recorded record of this family.

David Nolan married Catherine Cornelia Worthington-Wellington-Weatherington in Macon Co. Ala. Dec. 12, 1845. All three of the above spellings can be found in legal records. Wellington appears on the marriage license and is the only record of this spelling. Worthington can be found on marriage licenses of other members of the family. Cornelia had two brothers Joe and John in the Confederate Army both used Worthington on their Military records also land deeds.

Cornelia was the daughter of ~~Samuel~~ Samuel Worthington and his wife Eliza "Betsy". After Betsy's death, Samuel married Mrs Eliza

David Nolan did not remain a widower very long. He married Catherine Andre Funderburk-Chunn, in July 1863.

Catherine Andre was the widow of James Chunn. James was killed in the Civil War and they had one son James Chunn Jr. Catherine was the daughter of Samuel Robt. Funderburk and Mary Ann Childress. Catherine was born March 8, 1846. She died April 26, 1884 and is buried in Antioch Cemetery.

David Nolan and Catherine Andre were the parents of (12) twelve children, Nine (9) lived to reach adulthood.

971. John Hodge 00010-20100-00

William Hodges was granted land on 23 Mile Creek of Savannah River 5 June 1786, which he sold 8 Nov. 1792 to Jacob Phillips, both at that time of Abbeville District. Whether he was related to John and Abel Hodge(s) of Pendleton c.1800 is unknown. Some if not all of the Hodges appear to be related to a family that was in Pittsylvania (later Henry, now Franklin) County, Va., by 1765, when Isham Hodges bought land from the Heard family.

972. Samuel Norwood 00101-11100-00

Samuel Norwood was related to John Norwood, who sued John Stewart on a note 15 April 1793. Capt. John Norwood was in charge of a garrison at Walton's Ford on Tugaloo River in Pendleton in March, 1785, at which time Jeremiah Files was in his command. In 1800, John Norwood live in what is now Anderson County and Blakely Norwood in Pickens County. Some of the family subsequently moved to DeKalb County, Ga.

973. Shadrack Nolan 11001-31101-00

Shad Nowland was living in Fairfield District, S.C., in 1790, along with Susannah Nowland, and William, James and Steven Noland. Land on branches of 23 and 26-Mile Creeks in Pendleton were surveyed for Shadrack Nolin 5 Jan. 1793; he sold it to Spencer Mitchell 2 April 1799. David and his wife Nancy Noling sold to Shadrack 26 March 1799, land on Crow Creek. In 1800, Susannah also was living in what is now Oconee County and Sherod Nowland in Anderson County. Bryan Noland of Greenville District, S.C., was of a family in Pittsylvania County, Va., before 1767, and in 1790 was living among a number of settlers from Henry (formed from Pittsylvania) County, Va. John Nowlen of Henry County married Catherine, daughter of John Anderson; John Nowlen moved to Georgia and died in Wilkes County before 7 Dec. 1803. His widow married Sterling Jenkins Jr. (Wilkes County Will Book HH, pps. 26, 123). Some of the Pendleton family moved to Jackson County, Ga., before 1820.

Could this David be father of S.P. Noling Sr. ca. 1790?

974. John Bruce 10100-00111-00

Association and several land deal connections indicate that the Bruce family in Greenville and Pendleton Districts may have been related to the William Bruce who moved from Albemarle County, Va., to Surry County, N.C., where in 1790 he was a neighbor to a Stewart family that moved subsequently to Greenville District. Land on Saluda River in Pendleton was granted to William Bruce 4 Jan. 1790 and was sold by Bruce to William Laffoon 20 March 1793, with John Keith from Wilkes County, N.C., as a witness. James Bruce was living on Wolf Creek of 12-Mile Creek 28 Dec. 1792, when land adjacent to his farm was sold by Benjamin Perry to Jonas Hill. This land was granted to Perry 4 June 1786. William Stewart of Greenville District bought in 1801 land on Clear Creek in Greenville from Charles Bruce; he seems to have had some connection with the William Stewart of Pendleton District (not the William Stewart at No. 966 above) who sold 8 March 1796, to William Bruce, land on Carpenter's (formerly Warrior's) Creek, a fork of Saluda River. John Bruce was a witness.

975. Nathaniel Reed 10101-00100-00

Elizabeth Reed of Charleston, S.C., was granted 640 acres on George's Creek of Saluda (now Pickens County) 15 Oct. 1784 and she conveyed it 4 Jan. 1785 to William Reed, doctor of physic, who was still living in Charleston 5 March 1799. William Reed--apparently a different man--was granted 606 acres on George's Creek 1 May 1786 and was of Pendleton 7 Jan. 1791 when he sold the land to John Armstrong of Greenville District; on 3 Dec. 1791, he sold an additional 116 acres of the same tract to William McKamey. Noble Johnson and his wife Sarah sold part of the same tract, 8 Feb. 1792 but the deed does not reveal whether any personal connection existed with Reed. He was also granted 416 acres on Broad South of Saluda River 19 June 1788 and sold this tract 19 June 1789 to Isaac Brock. Still another William Reed, of Greenville District, bought of Humphrey Cobb 8 Oct. 1795, land on
