Page 202 - Andrew Young Allen, Junior to Andrew Allen, Senior, both of Fairfield Co., Camden Dist., for 16 pounds sterling, bargained and sold in open market in common Sale, one horse branded "R.B.", two cows and three yearlings, "being my own good and Lawfull property." Signed by Andrew Allen and dated 18 Jan. 1794. Wit: Jno. Grafton. Acknowledged by Andrew Allen, Junr. before D. Evans, C.F.C., 20 Jan. 1794 and recorded same day.

Page 203 - John Gregg, planter, of Fairfield Co. to Capt. John Woodward, for 36 pounds lawful money, one Negro girl about 14 years of age named Bett, formerly the property of Mr. John Robertson. Dated 15 May 1792. Wit: James Craig, J.F.C. No recording date entered.

Pages 203-204 - William Strother of Fairfield Co., planter, to Capt. John Woodward for 83 pounds, 4 shillings, 8 pence lawful money, three Negroes and one horse, viz, one Fellow about 40 years of age named Bob, one wench about 25 years of age named Phillis and her child Sarah about 3 years of age. Also one black horse branded "E.T." Dated 6 Nov. 1793. Wits: Wm. Robertson and Minor Winn. Recorded 15 Feb. 1793 [sic-1794?]

Pages 204-206 - Joshua Durham to John Grigg of Fairfield Co., for seventeen pounds sixteen shillings five pence, mortgage on one Negro fellow named Peter. If above sum plus interest is paid by 25 Dec. next ensuing, mortgage void. Dated 24 July 1793. Wit: John A. Tharp who proved mortgage 17 Jan. 1794 before S. W. Yongue, J.P. Recorded 15 Feb. 1794.

Pages 206-207 - William Rabb to John Grigg, for 26 pounds sterling, mortgage on one Negro boy named James. If above sum plus interest paid by 1 May 1794, mortgage void. Dated 24 July 1793. Wits: Jno. A. Tharp and Joshua Durham. Receipt to Wm. Rabb for 27 pounds signed by Jno. Gregg 20 April 1794. Mortgage proved by John Allen Tharpe 14 Jan. 1794 before S. W. Yongue, J.P. Recorded 15 Feb. 1794.

Pages 208-209 - John Stip of Barkley Co., VA, to Benjamin Halsey of Fairfield Co., SC, bond for 10,000 pounds sterling current money of S. C., dated 27 Oct. 1791. Condition being that if the said John Stip doth keep Benjamin Halsey, Sarah Halsey and Margaret Halsey indemnifyed from damage from a deed of conveyance of land given by Benjamin Halsey, Sarah Halsey and Margaret Halsey dated 17 June 1785 and acknowledged before John Hitchcock and Amos Davis, Esquires 18 June 1785, said deed given to above bound John Stip, bond is void. Wits: Anderson Thomas, Anderson (X) Pannell and Peter Halsey. Proved by Peter Halsey 15 Jan. 1794 before David Evans, Clerk of the County Court of Fairfield. Recorded 15 Feb. 1794.
