Copy of War Record of George Peay, War Dept., Washington, D. C. The Adjutant General's Office. The records of this office show:

One George Peay (rank not stated) served in the Revolutionary War in Captain Vernon's Company, North Carolina Troops. His name appears on an undated payroll for part of Richard C. Vernon's Company Troop Horse. Ordered out by Governor Martin to guard the Honorable Assembly under the command of William H. Allen, Sergeant, 1781.

His name also appears on an undated payroll of that Company, ordered by Colonel James Martin to collect delinquent deserters, etc. Aug. 20, 1781. No further record of service found.
