pages 300-04: ...I have received a letter from Mrs. John E. Peay...the account of the wounding of John Starke I got from Mrs. Peay herself also from her son George S. Peay whose daughter I married (my 2nd cousin). When I was a small boy Mrs. Peay spent some time with my mother and use to amuse us by telling us of her trials & troubles during the revoly war. Her son George S. Peay and myself have often talked...George S. has often told me he regretted that a true account was not given of the affair in some history in order that his father's aid in the escape might be mentioned...John Starke was born in Kershaw Co...Mrs. Dr. Nelson is a sister of J. W. Starke of Pilatka Florida...his [J. W.'s] grandmother Mrs. Rochelle...She lived on Big Lynch Creek in Kershaw...my mother in law was a daughter of Mrs. Rochelle.

Letter from Jane C. Nelson, Camden S.C., July 24, 1873 to Draper:

...Uncle John Starke's death...buried some 20 miles or more from where I live...not a General at his death, known as Capt...I am in possession of Starke genealogy...originally from England, to Virginia. Thomas Starke and Wilmot Williams had a son Thomas who married Elizabeth Turner, settled in S. C. and had nine children. John Starke you speak of was the youngest, 16 when the war broke out...Elizabeth Peay was the 4th child; Thomas my great-grandfather was the 6th child; John the 8th... [Nelson states that Nicholas Peay rescued John Starke, but see further]

Series 14 VV page 306: Maj. Turner's grandson Mr. McCrory...

Extract of the obituary of Agnes Turner daughter of John Turner: he emigrated from the north of Ireland before the Rev. War; was a Presbyterian; State representative for 14 years, died 1807. his other issue: Molly Peggy married John McCrory; Mattie married James Law; Nancy married David Boyce; Margery married James Dunklin; Betsy married Wm. Hughs; William A. Turner married Isabella Bell his cousin.

Series 14 VV page 312: Scott to Draper, 1873 - It may be possible that John Starke was recaptured and taken to Camden after his rescue by George Peay; if so I never heard my father in law George Peay (a son of George Peay of the Revolution) speak of it. My father in law died in 1854 - 72 years old. He certainly knew the history of his uncle well...George Peay lies buried below Peays ferry on the Wateree river, near the bank and some 2 or 3 hundred yds below the ferry. No tomb stone to mark the spot. His son George told me where he is buried...

Series 14 VV page 319ff: Scott to Draper, 13 October 1873: J. Starke...laying aside his sister Mrs. George Peay's statement...he was rescued by his brother in law George Peay (Nicholas Peay was too young to be engaged in the war and did not rescue him).

...Since I received your last I went down to see Mr. J. E. Peay professionally. He is now in his 80th year and very feeble. He has lost his mind or rather, his recollection of past events and I could not gain much from him in regard to his grandmother who lived and died at his house or rather she lived in a hundred yards of his house for many years before her last husband's death and may possibly when Mr. Mickle died have gone into her grandson's house. I forgot to ask them if she did so when I was there. Mrs. John E. Peay is comparatively a young woman and a lady of good education and recollection. We had a long talk over what our grandmother had said in her life time in regard to Revolutionary incidents...Mrs. Peay says that [the grandmother Mrs. Peay] carried her youngest child before her...the other horse carried her son Austin...Mrs. J. E. Peay says that Mrs. G. Peay gave birth to a child three days after the battle...

page 322 Longtown, July 4, 1873

lst. The lady you mention was my father's mother, her name previous to her marriage with my grandfather Mr. George Peay was Elizabeth Starke; she was the sister of John & Reuben Starke; she suffered much privation during the invasion of this state by the British; her husband and brother were in the army. She had no protector & was alone with her young children, the eldest my father was only 12 years old. When her house and all she had was destroyed, only a little corn was left which she ventured to carry to be ground into meal. My father was returning with the bag when he was fired upon; he escaped with his life but the horse and bag were taken and he at length returned on foot to the starving family, his mother having been in an agony of distress on account of her young son. This occurred immediately after our defeat at Camden, S.C. No alternative remained but to endeavor to follow our army...She was present at the fight at Fishing Creek and at Guildford C. H. N. C. afterwards; three days after she gave birth to another child... I have heard these facts related by herself many times, she became the mother of a large family & after the death of my grandfather married a Mr. John Mickle...& died at the advanced age of 83 years, at my father's house in this place in the year of 1836. George Peay my grandfather a brave soldier remained in the service until peace was declared.

Series 14 VV page 330. From Mrs. John E. Peay, Long Town, Fairfield Co. S.C., Sept. 9, 1873 -

lst. My husband's grandmother was born in Virginia & was the daughter of Thomas and Jane Starke. She was several years older than her brother John Starke. Her parents removed to S. C. before the war...The records of the Peay family were destroyed...Our grandfather George Peay died several years previous to the birth of my husband...my husband was born 19th March 1795; his grandmother's son by her last marriage, John Mickle was born about the same time...My husband's father Austin Peay...Mr. Peay's grandmother went to her relatives near Richmond...She was born Dec. 25, 1754 and died at our father's house Oct. 4th, 1835; she was never a pensioner; [she was buried at the Baptist church in this place - Longtown]. My husband's father's name was Austin Peay, the eldest child, and was born Dec. 25, 1769, his young mother being just 15 years old, & died 4 Dec'r 1839...

page 335 - Our grandmother was born near Richmond Virginia. My husband John E. Peay was born March 19, 1795 and was just nine months older than his grandmother's son by her second marriage; this son John Mickle moved to Alabama...

Page 348ff - the oldest Starke child of the nine may have been Douglas. <u>Williams</u> Starke had six sons - Turner, Williams, Douglas, Reuben, Thomas and John; and three daughters - Mrs. E. Peay, Mrs. Hunter, and Mrs. Scott...
