I thought it would be better to just attach a portion of the family tree as I have it. The first individual is my great great grandfather. He is the son of Rachel Crenshaw Perry and Joshua Perry Jr. We are trying to join the DAR through Rachel and although we have him on a census with her in 1860 and buried in the same cemetery, they want further proof that she was a Crenshaw before marrying Perry. That can be difficult to prove. So that is what we need anything documenting that relationship. She married Perry in SC about 1840 to 1850. They migrated to Florida in 1850 by covered wagon. He was ordained in SC in 1855, he must have returned for this since they were living in Florida. He was an itinerate pioneer preacher in Florida, establishing 10 churches. He is listed in the Baptist Biographies of the Alachua Association, as was his brother listed below him. I believe the Baptist association in that area at the time was called Moriah. The tree is attached.

# JOSHUA PERRY

Joshua Perry (1829-1893) of the Sardis Church in Alachua Association died in 1893. He was a pioneer preacher in many of the destitute localities of our territory, having organized and built up several churches in the years when the field was large and the laborers few. Perry was born in Lancaster County, South Carolina, on January 7, 1829. He was baptized in that County in 1844, and ordained in 1855.

Perry served as pastor of Mt. Zion, Oak Grove, Pine Level, Pleasant Plains, Sardis, and Hopewell Churches in the Alachua Association.
