Perrong, John

He enlisted in the First Regiment on 4 November 1775 and re-enlisted in December 1776 for the duration of the war. N.A.853.

Perronneau, Henry

He served as a lieutenant in the Second Regiment. He was court-martialed for disobedience of orders and neglect of duty. He was acquitted on 14 March 1778 and he resigned on 15 July 1778. Yearbook, 1893; S.C.H.&G., VIII, 21, 74.

Perronneau, James

He served as a lieutenant in the Second Regiment and resigned on 12 December 1777. Yearbook, 1893.

Perronneau, John

He served in the Charleston Militia Regiment under Captain James Bentham during 1778. S.C.H.&G., LIII, 15.

Perronneau, John

He became a second lieutenant in the First Regiment on 17 June 1775 and was a first lieutenant on 9 November 1777. He resigned on 12 December 1777. Yearbook, 1893; Heitman, p. 437.

Perry.

He served as a lieutenant and was killed at Quinby Bridge. Yearbook, 1893.

Perry, Abraham

He served twenty-six days in the militia under

He served eighty-two days in the militia under Gen. Marion. In addition, he supplied pork for the militia. A.A.5867A; H231.

Perry, James

He served in the Colleton County Regiment of Militia under Capt. Thomas McLaughlin during 1775. (Osborne, Thomas, W9217).

Perry, James

He served twelve months in the cavalry under Col. Maham. A.A.5868; P114.

Perry, Jesse S3655 b. 15 March 1755, Granville County, N. C. While residing in Fairfield District, he enlisted and served under various men. He was with Capt. William Lang and Col. Robert Goodwyn on the Snow Campaign. Later, he was under Capt. John Smith and Col. Robert Goodwyn and was out after the Tories. Next, he served three months under Capt. John Taylor and Col. Kirkland and Capt. James Craig and Col. Hunter. In addition, he enlisted for one year under Capt. John Cook and Colonel Arthur Middleton and was in an engagement against the Tories at Juniper Springs. While at home, he was taken prisoner by Col. Thompson (a Tory) and put in prison at Camden. After he was paroled, he went to North Carolina and remained until the war ended. (Moved to Tenn.) A.A.5869; Z105.

Perry, Joe

He served thirty-nine days in the militia under Gen. Marion during 1782. A.A.5870.

Perry, John

He enlisted in the Second Regiment on 4 November 1775 and re-enlisted on 1 November 1779 under Capt. Adrian Proveaux. Saffell, p. 290; N.A.246; N.A.853.

Perry, John

He enlisted in the First Regiment on 4 November 1775 and re-enlisted on 1 February 1780. N.A.853.

He was in the First Regiment in 1783. N.A. 853.

He enlisted in the Fourth Regiment on 11 December 1775. N.A.853.

Perry, William S8944

b. 23 January 1765, Guilford County, N.C. He entered the service on 26 March 1781 under Capt. John Norwood. He was in the battle at Eutaw Springs and was wounded in the thigh. In 1783, he was at Norwood's Station and was in skirmishes against Indians and Tories. (Moved to Va.)

Persons, Richard

b. c. 1748, Va.

He served in the Rangers under Capt. Charles Heatley and Col. Thomson during 1775. S.C. H.&G., II, 189; III, 74.

Perviance, James

He served in the state troops under Gen. Sumter. A.A.5880; X2045.

b. 1760, England

While residing in the Cheraw District, he enlisted on 14 February 1779 under Ensign David Laroch, Capt. Thomas Sparks, Maj. Poe and Gen. Marion. He was in the skirmish against Cunningham at the Forks of the Pee Dee River and was shot through the thigh in a skirmish with Tories at Long Bluff. Capt. Sparks died and William Clark took his place as captain. (Moved to Ga. and Ala.)

Peter, John

He enlisted in the First Regiment on 4 November 1775, N.A.853.

Peterkin, John

He enlisted in the Third Regiment on 1 November 1777 as a drummer. In 1779, he was under Capt. John C. Smith. In addition, he was a servant to Lt. Smith while in prison at Haddrell's Point during 1780. S.C.H.&G., V, 147; VI, 60; N.A.853.

Peterkin, John

He served as a dragoon in the cavalry under Col. Maham during 1781 and 1782. Y1058.

Peters, Elijah

b. c. 1754, N. C.

He served in the Rangers under Capt. Robert Goodwyn during 1775 and served in the militia from 15 April 1781 to 15 January 1782. S.C.H.&G., II, 179; A.A.5883; V641.

Peters, Elisha

He enlisted in the Sixth Regiment on 17 December 1776. N.A.853.

Peters, Henry

He enlisted in the Second Regiment on 4 November 1775 and was discharged on 18 July 1778. He was under Capt. Francis Huger and was wounded at Ft. Moultrie on 28 June 1776. Drayton; N.A.853.

Peters, Jeremiah

He enlisted in the Second Regiment on 8 February 1779 under Capt. Richard Mason and re-enlisted on 1 November 1779. Saffell, p. 294; N.A.246; N.A.853.

Peters, John

He served as a captain. (Byers, Samuel); (Carson, William, S9305).

Peters, Michael

He enlisted in the Second Regiment on 1 July 1779 under Captain Richard Mason and reenlisted on 1 November 1779. Saffell, p. 294; N.A.246; N.A.853.

Peters, Samuel

He enlisted in the First Regiment on 4 November 1775. He served as a corporal under Capt. Thomas Lynch. On 9 December 1775, he was in the guardhouse awaiting a courtmartial. S.C.H.&G., I, 53; III, 198; N.A.853.

Peters, Solomon

He served in the Salt Catcher Volunteer Company under Capt. James Jones during 1775 and later rode express for Col. Richardson. S.C.H.&G., II, 20; Council of Safety, 5 December 1775.

Peters, Solomon

b. c. 1752, N. C.

He enlisted in the Rangers under Capt. Robert Goodwyn on 25 June 1775 and re-enlisted on 12 September 1776. He became a corporal under Capt. John Hennington on 15 March 1779. S.C.H.&G., II, 180; V, 156; N.A.853.

Peterson, Samuel

He served aboard the galley Carolina from 3 August 1779 to 3 March 1780. A.A.2463A½.

Petigru, William See William Petigrew.

Petis, George

He enlisted on 30 October in the Volunteer Company of the Colleton County Regiment of Foot under Capt. Andrew Cummins. S.C. H.&G., III, 127.
