William "The Joyner" POOLE, Sr. was born about 1703 in Prince George County, VA. He signed a will about 1772 in Mecklenburg County, VA. William's will, dated 1772, was recorded November 10, 1777 in Mecklenburg County (Will Book I, page 241). He died before Nov 1777 in Mecklenburg County, VA. Lewis Parham, Reuben Morgan, and James Taylor recorded the inventory and appraisal of the estate of William Poole on March 8, 1779. The value of the estate was listed as 338 pounds, 15 shillings, and 6 pence (Will Book I, page 289). William was both a carpenter and a 'joyner'. Early, there was a difference between the two. Carpenters generally did the rough construction of a building: the framing, flooring, and roofing. The 'joyners' made the window sashes, paneling or wainscoting, the window and door moldings, and finished the stairs. The Pool(e) and the Pettipool(e) families both lived in the same vicinity. By 1811, it appears that there were only members of the Pettipool(e)'s remaining, the Pool(e) families had all migrated elsewhere.

- 1720 The area where William Poole, "Joyner," lived became Brunswick County, it was previously part of Prince George County. It remained unorganized until 1732.
- 1732 On May 2, 1732 the first court of Brunswick County was held.
- 1733 The January 4, 1733/4 Court records show that William was paid for building the County Clerk's office in Brunswick County, Virginia. William also won a lawsuit against John Wall the administrator of Thomas Goldwyn's estate for 1 pound, 15 shillings, 5 pence, in 1733, Brunswick County, VA. St Andrew's Parish: James Fletcher wills (1733); Wm. Poole, Elizabeth Tapley and Lucy Duke are witnesses.
- 1734 William was paid by St. Andrew's Parish vestry for making window shutters and two outside doors for the church that he had completed in 1732.
- 1735 William was a member of the Grand Jury on November 6, 1735 when they returned an indictment against Amy Mitchel for having a bastard child.
- 1736 On March 2, 1736 William was a witness to the sale of 376 acres on the north side of Great Creek by John Evans and his wife, Elizabeth, of Brunswick County. The land was sold to William Browne Jr. of Surry County. The other witnesses were: Edward Cleaton and Hosea Tapley (Brunswick County, VA Deed Book 1, page 259).
- 1737 William Pool, "Joyner", sold George Mabry 400 acres on the south side of the Nottaway River. William's wife, Elizabeth, was mentioned in the transaction. The deed was witnessed by H(inchia) Mabry, Jr., G. Mabry (most likely George Mabry, Jr.), and William Gilliam Jr. (Brunswick County, VA Deed Book 3, pages 430-433). http://members.tripod.com/~htpiii/thejyner/thejyner.htm (1 of 5)4/14/2009 9:53:43 AM Location of Flat Creek, Virginia
- 1737 On March 2, 1737 William bought 160 acres on Flatt Creek in Brunswick County from John Watson for a token sum. Flatt Creek is in the southern part of the county, south west of present day South Hill, Virginia near the North Carolina border. This probably indicates that his first wife, Elizabeth Tapley, had died, and William had married as his second wife, Elizabeth Watson, daughter of John Watson. Witnesses to the sale were: Lewis Parham, Michael Wall, and John Ballard (Brunswick County, VA Deed Book 1, page 430).
- 1740 On October 6, 1740 Philip Roberts of St. Andrews Parish, Brunswick County sold 150 acres of land on the south side of the Roanoke River and the mouth of Grassy Creek for 15 pounds to Samuel Hudson of the same parish and county. William Poole and John Ballard were witnesses (Brunswick County, VA Deed Book 2, page 131).
- 1740 John Ward of Brunswick County owned land on the south of Rose's Creek, described as adjoining the property of William Poole.
- 1744 The October 31, 1744 Vestry records for St. Andrews Parish show William was paid for six bottles of claret wine. Indenture made December 5, 1744, between Andrew Moreman of St. Andrew Parish, Brunswick County, and John Parker of same, £160, both side of Stoney Creek, same being granted to the said Andrew Moreman by Letters patent dated 1 March 1743. Signed Andrew Moreman (bhm). Witnesses: William Poole, John Taylor Duke, Andrew Hampton. Court September 5, 1745, Indenture acknowledged by Andrew Moreman. Deed Book 3, Page 68.

1746 - Indenture made April 29, 1746, between David Lucos and Denes Lark of Brunswick County, Whereas the said David by Indentrue bearing date the day before the date hereof for the Consideration therein expressed did bargain and sell unto the said Deness a Certain Tract or Parcel of Land with the appurtenances thereof Scituate lying &; being in the County of Brunswick Containing by Estimation two hundred acres be the same more or less and is bounded as in the said recited Indenture may appear Witnesseth that the sd. David Lucoss for £10, does release and confirm unto the said Deness Larke into his actual possession. Signed David Lucoss (bhm). Witnesses: Wm. Poole, John Ezell, David Dodd. Court May 1, 1746, Indenture acknowledged by David Lucoss. Deed Book 3, Page 179. Indenture made April 29, 1746 between David Lucoss and Dennis Larke of Brunswick County, 5 Shillings, 200a. Signed David Lucoss (bhm). Witnesses: Wm. Poole, John Ezell, and David Dodd. Court May 5, 1746, Indenture acknowledged by David Lucas. Deed Book 3, Page 181.

- 1746 The area where William lived became Lunenburg County, it was previously part of Brunswick County. The first court was held May 5, 1746.
- 1747 William Pool was on a list of people recommended to Sir William Gooch Barronite, Lt. Governor, as fit to serve as Justice's of the Peace for Lunenburg County.
- 1748 The May Court 1748 list of grand jurors included William Pool, joiner.
- 1748 Lunenburg County list of tithables included William and his oldest son, Robert. A tithes list is a tax list. A son would be listed when he reached the age of 16-21, depending on current laws.
- 1749 -1751- The Lunenburg County list of tithes included William and his sons, Robert and William Jr. FIRST GENERATION http://members.tripod.com/~htpiii/thejyner/thejyner.htm (2 of 5)4/14/2009 9:53:43 AM

- 1750 One William Pool, Gentleman, produced a Commission from the Governor to be a Captain of the militia in Lunenburg County.
- 1750 On June 1, 1750 William was granted 330 acres on both sides of Flatt Creek, adjoining his own property and James Mitchell's, bounded by the Mill Branch. Land grants could be obtained from the King of England through the colonial governors.
- 1750 William received a grant for 87 acres on the lower side of Flatt Creek adjoining Amos Timms on November 3, 1750.
- 1751 William was granted 178 acres on the upper side of Flatt Creek on April 10, 1751.
- 1752 Lunenburg County tithe list included William and [his sons], Robert, William Jr., and Adam.
- 1752 On May 8, 1752 William Pool deeded 100 acres on the south side of Flatt Creek to Robert Pool for love and affection. This was part of the 330 acres William was granted in 1750. Witnesses were: Samuel Bizwell, Ephraim Mabry, and William Pool Jr. William's wife, Elizabeth, released dower.
- 1752 William Pool, 'joyner', sold 87 acres on the north side of Flatt Creek to William Bell, planter, for 15 pounds on June 1, 1752. The land adjoined the property of Amos Timms, Philip Roberts, and Adam Tarpley. Samuel Bizwell, William Pool Jr. and Ephraim Mabry, the husband of William's daughter, Mary were witnesses (recorded Deed Book 3, page 7).
- 1752 William sold 175 acres on the upper side of Flatt Creek to John McLain of Brunswick County for 20 pounds. The deed was dated September 1,
- 1752 and the witnesses were: Samuel Bizwell, Thomas Roberts, and Robert Poole (Deed Book 3, page 56).

- 1753 On March 1, 1753 William Poole deeded 50 acres on the north side of Flatt Creek to Richard Evans, son of Morris Evans, for love and affection. Witnesses were: Ephraim Maybry, Adam Tarpley (Tapley), and Robert Poole (Deed Book 3, page 224).
- 1755 Captain William Poole and Samuel Manning were ordered to procession land. Processioning was verifying property boundaries. William's son, Adam, married Samuel Manning's daughter, Esther.
- 1757 During the March 1757 Court, William and Adam are granted administration on the estate of Robert Pool, deceased (Order Book 4, page 268).
- 1757 On April 2, 1757 William sold 100 acres on Mill Branch of Flatt Creek adjoining Maclin to John Watson, Jr. for one pound for "love and affection." Witnesses were: Robert Bizwell, Rebekah Bizwell, and Adam Poole. Recorded May 7, 1757 (Deed Book 4, page 397).
- 1757 William was a witness to several land sale by Samuel Holmes Sr. on June 30, 1757. Samuel sold land to Isaac Holmes, Samuel Holmes Jr., and to William Holmes. The other witnesses to the sales were: Thomas Taylor, Dennis Lark, and Joshua Mabry. Recorded July 5, 1757 (Deed Book 4, pages 492. 494, and 496).
- 1758 Francis Lett sold land to John Lett on March 1, 1758. Witnesses were: William Poole, John Watson, and Samuel Manning. Recorded March 7, 1758 (Deed Book 5, page 107).
- 1758 On June 2, 1758 William was granted 400 acres on Flatt Creek.
- 1758 William Poole, joyner, sold Ephraim Mabry, planter, 100 acres on Flatt Creek for 30 pounds on July 3, 1758. Adam Poole, Benjamin Smith, and John Watson were witnesses. Recorded July 4, 1758 (Deed Book 5, page 250).
- 1758 William Poole Sr. deeded 200 acres on the lower side of Flatt Creek to his son, Adam Poole, and another 200 acres on the lower side of Flatt Creek to his son, William Poole Jr., for love and affection on November 6, 1758. William's wife, Elizabeth, released her dower rights. The witnesses were: Ephraim Maybry, Adam Poole, William Poole Jr., and John Watson. Recorded November 7, 1758 (Deed Book 5, pages 331 and 333).
- 1759 William is listed as a land owner on September 17, 1759 in Lunenburg County, Precinct 3. The Processioners were: Joshua Mabry, Dennis Larke, and Amos Timm Jr. Adam Pool was present at the processioning.
- 1762 William sold 80 acres on both sides of Wolf Pit Run. This was part of the 330 acres granted him in 1750. Witnesses include William Jr.
- 1763 John Watson's will mentions his son-in-law, William Poole. His will, dated March 6, 1763, was recorded on August 11, 1763 (Will Book 2, page 176).
- 1764 Lunenburg County list of tithables lists William Pool with 2 tithes and 100 acres and William Pool Jr. with one tithe and 50 acres.
- 1765 The area where William lived became Mecklenburg County, it was previously part of Lunenburg County. The first court was held March 11, 1765. http://members.tripod.com/~htpiii/thejyner/thejyner.htm (3 of 5)4/14/2009 9:53:43AM
- 1765 William Pool, Thomas Taylor, and Ephraim Mabry were listed as appraisers for the estate of Lewis Tanner in Mecklenburg County on October 31, 1765. Recorded July 14, 1766 (Will Book I, page 22).
- 1767 On April 17, 1767 William Pool, Thomas Taylor and Goodwyn Taylor signed the inventory of the estate of Roger Tillman. Recorded August 10, 1767 (Will Book I, page 38).

- 1767 On November 4, 1767, William Poole sold 150 acres on the north side of Flatt Creek near Mill Branch. Ephraim Mabry was a witness.
- 1767 William was granted 400 acres on both sides of Mill Branch of Flatt Creek, adjoining Robertson and Manning.
- 1768 On March 12, 1768 William Poole Sr. sold 30 acres on the west side of Flatt Creek to John Watson [sale was to John Jr. as John Sr. died about 1763] for 5 pounds. Elizabeth, William's wife, gave consent. Witnesses were: James Blanks Daws, William's married daughter, Jane Cleaton, and Sarah Daws. Recorded March 14, 1768 (Deed Book 1, page 539).
- 1774 William Poole, Sr., Walter Poole, and William Cleaton sold 100 acres on Flatt Creek adjacent to land of William Poole, Jr., Isaac Watson, and William Cleaton, Jr. The sale was to Crawford and Company of Glasgow. He was married to Elizabeth TAPLEY about 1726 in Brunswick County, VA. Elizabeth TAPLEY died before 1737 in Brunswick County, VA. William

- 1752 Robert received 100 acres of land on the south side of Flatt Creek from his father, William Poole Sr., for love and affection on May 8, 1752. Flatt Creek is south west of present day South Hill, Mecklenburg County, Virginia.
- 1752 Robert was a witness to the sale of 175 acres on the upper side of Flatt Creek by his father to John McLain on September 1, 1752.

- 1753 On March 1, 1753 Robert witnessed a deed transfer by his father to Richard Evans for love and affection.
- 1757 During the March 1757 Court, William and Adam are granted administration on the estate of Robert Pool, deceased (Order Book 4, page 268). He was married to Elizabeth HOLMES about 1747. Elizabeth HOLMES died before 1766 in Lunenburg County, VA. Elizabeth probably died sometime before 1766. Since her father's will, which was probated on July 14, 1766, does not mention Elizabeth but it does name his granddaughter, Elizabeth Pool. She was born in Lunenburg County, VA. Robert POOLE and Elizabeth HOLMES had the following children:

- 1746 The area where William Jr. lived became Lunenburg County, it was previously part of Brunswick County. The first court was held May 5, 1746.
- 1749 -1751- The Lunenburg County list of titheables included William Jr. his father, William Sr. and his brother Robert.
- 1752 William Jr. is in the titheable list with his father, William Poole Sr., and his brothers, Robert and Adam Poole.
- 1752 On May 8, 1752 William Poole Jr. witnessed the land transfer of 100 acres on the south side of Flatt Creek by his father to his brother, Robert Poole, for love and affection.

- 1752 William Poole Jr. witnessed the transfer of 87 acres by his father to William Bell on June 1, 1752.
- 1758 One William Pool was listed as Militia "Sargent" in Lunenburg County. Since William Sr. was a Captain this is probably William Jr.
- 1758 William Poole Jr. received 200 acres of land on the lower side of Flatt Creek from his father, William Poole Sr., as a sign of love and affection on November 6, 1758.
- 1758 William witnessed a transfer of deed by his father, William Poole Sr., to his brother, Adam Poole on November 6, 1758.
- 1759 William Pool Jr. is with his father, William Pool Sr., in the list of titheables with one tithe and 200 acres.
- 1765 The area where William lived became part of Mecklenburg County.
- 1782 William is listed as a Revolutionary War Patriot for donations made to the Continental Army.
- 1784 On May 17, 1784 William Poole, Thomas Tanner, and Samuel Holmes were listed as the appraisers of the estate of John Watson.
- 1800 William Pool Sr. (previously Jr.) is on the personal property tax list in the lower district of Mecklenburg County with his son, William. He was married to Mary HOLMES? Mary HOLMES? died before 24 Oct 1807. William POOLE, Jr. and Mary HOLMES? had the following children:

- 1758 On July 3, 1758 Adam witnessed a sale of land by his father to Epraim Mabry.
- 1758 Adam received 200 acres on the lower side of Flatt Creek from his father as a sign of love and affection on November 6, 1758.
- 1758 Adam was a witness to the deed transfer by his father of 200 acres to his brother, William Poole, Jr. as a sign of love and affection on November 6, 1758.
- 1759 Adam was present at the land processioning by his father on September 17, 1759.
- 1760 Adam sold 200 acres on the lower side of Flatt Creek for 46 pounds to Reuben Morgan on May 3, 1760. Adam's wife, Easter (Esther) released dower. Witnesses were: Henry Deloney, John Speed, and John Speed, Jr. Recorded June 3, 1760 (Deed Book 6, page 92).

- 1760 Adam witnessed the sale of 350 acres of land on the lower side of Flatt Creek by John Patrick to William Blanton on August 2, 1760.
- 1761 On February 14, 1761, Adam received a land grant for 304 acres on the west side of Flatt Creek, adjoining Taylor Duke.

- 9. Walter "Cooper" POOLE RS was born about 1745 in Brunswick County, VA. Date of birth is estimated from census records. He died about Feb 1833 in Newton County, GA. Walter died, intestate, before February 27, 1833, when Hardy K. Poole advertised in the Southern Recorder that he had applied for letters of administration on the estate of Walter Poole, deceased.
- 1764 The area of Brunswick County, Virginia where Walter lived became Mecklenburg County.
- 1777 Walter's father, William Poole died about November 1777. William's will, which was recorded November 10, 1777, left the land and plantation in Mecklenburg County, VA. to his son, Walter, after William's wife's death.
- 1780 On August 14, 1780, Walter and his wife, Lucy, sold 440 acres in Mecklenburg County.
- 1781 Walter was recommended as an Ensign in the Mecklenburg County, militia on May 12, 1781.
- 1782 According to the Virginia State Census, Walter Pool had 7 whites and 3 blacks in his household in Mecklenburg County.
- 1782 Walter sold 100 acres bounded by the land of William Poole, Jr., Isaac Watson, William Cleaton, Jr., and James Taylor on December 20, 1782.
- 1784 On February 8, 1784 Walter Poole, Frederick Collier, and John Haile are listed as appraisers of the estate of Isaac Watson in Mecklenburg County.
- 1784 On August 12, 1784, Walter sold 100 acres joining the lands of William Poole, Jr., Isaac Watson, and William Cleaton, Jr.
- 1789 Walter (X) Poole, Adam (X) Poole, Thomas (X) Mobley, and Elijah Major presented the appraisement of Ephraim Mabry's estate was presented on November 2, 1789 in Camden District, Fairfield County, South Carolina (Will Book 1, page 50).
- 1790 Walter was enumerated in Camden District, Fairfield County with five males, aged 16 and upward and one male under 16. There were no females or slaves in the household.
- 1795 On July 17, 1795, Walter Pool, Adam Pool, and Jonathon Harrison were sworn as constables for Camden District, Fairfield County.
- 1798 Walter was listed as a purchaser at an estate sale in Camden District, Fairfield County on April 20, 1798.
- 1798 On August 30, 1798, Walter sold 118 of the 925 acres he owned adjacent to Rock Creek in Camden District, Fairfield County to George Boatner for eleven pounds, thirteen shillings and four pence sterling.
- 1799 Walter is on the January 16, 1799 list of petit jurors in Camden District, Fairfield County.
- 1799 Walter is on the July 17, 1799 list of petit jurors in Camden District, Fairfield County.

- 1800 South Carolina abolished the judicial districts and re-designated the existing counties as districts.
- 1800 Walter, aged 45 and up, was enumerated in Fairfield District with three males, aged 0-9; one female, aged 0-9 and one female (probably his wife, "Percilla") aged 26-45.
- 1801 On January 31 Walter Poole, cooper (a cooper was a barrel maker), sold 60 acres of the Rock Creek land to William Woodard for thirty dollars. His second wife, "Percilla", signed release of dower in the document.
- 1810 Walter, aged 45 and up, was enumerated in Fairfield District with two males, aged 0-9; 1 male, aged 10-15; two males, aged 16-25; two females aged 0-9; one female, aged 10-15 (His wife, "Percilla", evidently died before the 1810 census). Walter, Adam, and William (aged 26-44, with a wife in the same age bracket) lived adjacent to each other in the Fairfield District census.
- 1820 Walter, aged 45 and up, was enumerated in Walton County, Georgia with one male, aged 16-18; one male aged 16-26 and two females, aged 10-16. The male in the 16-18 age group is repeated in the 16-26 age group; this means there was only one male, aged 16-26. This is most likely Robert T. Poole whose name first appears in the 1830 census. Robert is living seven enumerations from Walter in the 1830 census and he was between 20 and 30 years of age. The females listed are most likely Mourning and Priscilla Poole, daughters of Walter Poole.
- 1825 The March 1, 1825 issue of The Georgia Journal reported that 50 acres of land, the south part of lot number 337, in the 9th District (originally Henry County now Newton County, Georgia), levied on as the property of Joseph Dorsey, to satisfy fifa in favor of Walter Pool.
- 1827 Walter drew land lot 115, District 20, Section 1 (Lee County, Georgia) in the 1827 lottery for his Revolutionary War service.
- 1830 Walter, aged 80-90, was enumerated in Newton County, Georgia with one female, aged 0-5 and one female, aged 20-30. He was married to Lucy about 1765 in Brunswick County, VA. Walter and his wife, Lucy, sold 440 acres in Mecklenburg County in 1780. Lucy died before 1790. Lucy probably died before 1790 as there were no females listed in Walter's household in the 1790 census. Walter "Cooper" POOLE RS and Lucy had the following children:

- 1808 Adam gave slaves, that were part of his wife's legacy, to his children for "love and affection", on February 29, 1808 in Jackson County, Georgia. He appointed William Pentecost as attorney and gave a Negro woman, named Lina and all her increase to his daughters, Elizabeth and Jincy Poole; one Negro boy, named George, to his son David. Recorded on January 11, 1810 in Deed Book E, page 274. He was married to Elizabeth MABRY (daughter of Ephraim MABRY and Mary POOLE) about 1794 in Fairfield County, SC. Elizabeth MABRY died about 1808. Corporal Adam POOL and Elizabeth MABRY had the following

children:

Elizabeth "Betsey" PENNINGTON was born about 1787. She died before 1819 in Tuscaloosa County, AL?. Corporal Adam POOL and Elizabeth "Betsey" PENNINGTON had the following children:

Walter POOLE Jr. 1810 Walter lived in the Missouri Territory between 1810 and 1815. 1816 By the fall of 1816, Walter Poole, his wife, and four children along with several other families, Claiborne Wright, Alex O. and George C. Wetmore, William Mabbitt, Jonathon Anderson, and Charles Burkham were living in the vicinity of Clear Creek and Pecan Point.
- 1819 He lived in the Arkansas Territory from 1819 to 1821. The area later became Miller County, Arkansas and then became part of Texas.
- 1830 One Walter Pool and Nancy Kelly were indicted for adultery on October 27, 1830 in Miller County, Arkansas. The indictment was dismissed on October 22, 1831. Circuit Court Record A, pages 5 and 12. Walter POOLE Jr. had the following children:

- 43. Hardy Keele POOLE was born on 25 Oct 1802 in Fairfield County, SC. Most records show Hardy born in Georgia, however Walter was in Fairfield County, South Carolina in the 1790, 1800, and 1810 censuses. He died on 12 Jul 1873 in Union County, AR. He was buried in Good Hope Cemetery, Union County, AR.
- 1832 Hardy K. Poole drew lot number 1079, district 21, section 2 in the 1832 gold lottery. This lot is located in present day Cherokee or Cass County.
- 1833 The Southern Recorder, Wednesday, February 27, 1833 reported that Hardy K. Poole applied for letters of administration on the estate of Walter Poole, late of said county, deceased (signed) J. L. Hopkins C.C.O.

- 1833 On May 6, 1833 and Hardy Keele Poole was appointed administrator of Walter Poole's estate. A bond of \$800.00 was posted by Hardy K. Poole, Richard Quinn, and Ferdinand Beam.
- 1835 Robert T. Pool purchased Lot #115, 20th District, Stewart County, Georgia from Hardy K. Pool as administrator of Walter Pool's estate. Recorded in Newton County, Georgia, Ordinary Court, Book 6, page 457 in June 1835. This was the land that Walter drew for his Revolutionary War service in 1827.
- 1836 Land Sale by Green B. Turner of Newton Co., GA. to Hardy K. Pool of Marion Co., GA., for \$100.00, LL 337 in 9th Dt. of formerly Henry now Newton Co., 150ac /m/o/l, that part of said lot where Josiah Reed formerly lived. Witnesses were Richard Aycock and Jos. S. Anderson, J.I.C. Recorded March 25, 1836. (Newton Co., Ga. Deed Bk E, page 401).
- 1840 Hardy was enumerated in District 709, Marion County, Georgia. The household included one male under 5, one male 5-10, three males 10-15, one male 20-30, and one male 30-40. There was one female under 5, one female 5-10, one female 15-20, and one female 20-30.
- 1840 Hardy K. Poole was on the September 1840, Grand Jury in Marion County, Georgia.
- 1850 Hardy K. Poole, a 48 year old farmer born in South Carolina was enumerated in LaPile Township, Union County, Arkansas. Also, his wife, Sarah D., aged 35, born Georgia; their son, Thos. P., aged 12, born in Georgia and their daughter, Frances, aged 10, born Georgia. His real estate was valued at \$720.00.
- 1859 Hardy K. Pool recorded a land transaction in Union County, Arkansas on July 1, 1859 (Section 35 Township 19S Range 12W, 40 acres.)
- 1860 Hardy enumerated in Union County, Arkansas with his wife, Sarah, son, Thos. P., aged 22 and daughter, Frances N., aged 19. Hardy was listed as a farmer with real estate valued at \$500.00 and personal property valued at \$500.00.
- 1870 Hardy, aged 68, is enumerated with his wife, Nancy, aged 34; his children, Julia, aged 4 and Ellen, aged 2. Nancy's children, Henry and Mary Craven by her first marriage were also in the household. Hardy's occupation was listed as a farmer. His real estate was valued at \$500.00, and his personal property was valued at \$200.00. He was married to Charlotte VAUGHN on 31 Oct 1824 in Newton County, GA. Charlotte VAUGHN died about 1831 in Newton County, GA. Date of death estimated from Hardy's second marriage. Hardy Keele POOLE and Charlotte VAUGHN had the following children:

44. Robert T. POOLE was born about 1803 in Fairfield County, SC. Robert was probably born in Fairfield District, South Carolina since Walter was enumerated there in the 1790, 1800, and 1810 censuses. He died about 1842 in Macon County, GA. The link between Robert T. Poole and his suspected father, Walter Poole is based on circumstantial evidence. Walter was enumerated in Walton County, Georgia in the 1820 Federal Census with a male in the household between 16 and 26 years of age. Walter is living in Newton County in the 1830 census and the male who was in the household in the 1820 census is no longer there. Robert T. first appears in the 1830 census, living close to Walter, and his age, between 20 and 30, in 1830 matches the 16 to 26 year old who was with Walter in 1820.

1830 - Robert T. Pool, aged 20-30; his wife, Jemima, aged 15-20 were enumerated in Newton County, Georgia. The family was located 7 enumerations away from Walter Pool.

1835 - Robert T. Pool purchased Lot #115, 20th District, Stewart County, Georgia from Hardy K. Pool as administrator of Walter Pool's estate. Recorded in Newton County, Georgia, Ordinary Court, Book 6, page 457 in June 1835. This was the land that Walter drew for his Revolutionary War service in 1827.

1838 - Robert T. Pool was in Macon County, Georgia in the 1840 census; since he is not listed in the 1838 Tax Digest of Macon County, Georgia he was probably still in Newton County.

1840 - Robert T. Pool, aged 30-40; his wife Jemima, aged 20-30; one male, aged 0-5, two males, aged 5-10 and one female, aged 0-5 were enumerated in Macon County, Georgia in District 814, Garden Valley area. The names and ages of the children are probably: Hardy K., aged 2; Lauretta, aged 5; William T., aged 7 and William Ryley, aged 9.

1842/49 - Suspect Robert may have died between 1842 and 1849. Robert's wife, Jemima, is listed as a widow in the 1850 census of Randolph County, Georgia and none of her children are living with her. Children, whose ages coincide with Jemima and Robert's children, start to appear in the January 1842 poor school funding list for Newton County. It appears that Jemima may have moved back to Newton County. Later, the children are shown as living with Miss Priscilla Poole daughter of Walter Poole. Since Robert T. is not listed in the 1850 Mortality Schedule, probably died between January 1842 and June 1849. He was married to Jemima MCGRAW on 27 Apr 1830 in Newton County, GA. Jemima MCGRAW was born about 1813 in SC. 1850- Jemima, aged 45, a widow, born South Carolina was enumerated living alone in a boarding house in Randolph County, Georgia.

1860- Jemima, aged 52, born South Carolina, occupation farming was enumerated in Randolph County, Georgia. Her neighbor, Thomas Mitchell, was enumerated with William Poole, age 36, born South Carolina and his family.

1870- Jemima Boothe, age 57, born Georgia is enumerated in the household of William Ryley Poole in Miller County, Georgia. Suspect she is Jemima McGraw Poole and that she either remarried or the census taker wrote her surname incorrectly. Robert T. POOLE and Jemima MCGRAW had the following children: +147 i. William Ryley POOLE C.S.A..

POOLE was born about 1833 in Newton County, GA. 1846 - William T. and Lauretta are in the October 29, 1846 poor school funding list of the 463rd District of Newton County, Georgia. 1847 - William T., aged 14, and Lauretta, aged 11, are in the September 28, 1847 poor school funding list of the 463rd District. 1848 - William T., aged 15; Lauretta, aged 12, and Hardy, aged 9, are in the 463rd District poor school funding list dated, October 2, 1848. 149 iii. Lauretta POOLE was born about 1836 in Newton County, GA. 1842 - Lauretta is in the January 3, 1842 poor school funding list of the 463rd District of Newton County, Georgia 1846 - Lorena [sic] and William T. are in the October 1846 poor school funding list of the 463rd District. 1847 - Lauretta, aged 11 and William T., aged 14 are in the September 28, 1847 poor school funding list of the 463rd District. 1848 - Lauretta, aged 12; William T., aged 15 and Hardy, aged 9 are the 463rd District October 2, 1848 poor school funding list. 1850 - Lauretta, aged 15, is enumerated in the household of Priscilla Pool, aged 40 in the Newton County census. 1854 - In the September 1854 term, Prissilla [sic] Pool is listed as having two children eligible for poor school funding in the Wyatt District (463rd.) The two children are probably Lauretta and Hardy. However, the 1851 poor school list also shows a James Pool. James not been linked to any family in the Newton County area. James O. Pool also appears later in the November 3, 1858 poor school funding list of the 463rd District. In has 1857 - Miss Priscilla Pool is shown in the poor school funding list of Wyatt District as having 2 eligible children. Again, these are most likely Lauretta Hardy.

150 iv. Hardy K. POOLE was born about 1838 in Newton County, GA. 1847 - Hardy, aged 8; William T., aged 14 and Lauretta, aged 11 are in the 463rd District, September 28, 1847 poor school funding list of Newton County, Georgia. 1848 - Hardy, aged 9; William T., aged 15 and Lauretta, aged 12 are in the poor school funding list of the 463rd District dated, October 2, 1848. 1849 - Hardy, aged 9, is in September 11, 1849 poor school funding list of the 463rd District. 1850 - Hardy, aged 10, is enumerated with Isaac Frazier in the 1850 census. 1851 - Hardy is in the September 22, 1851 poor school funding list of the 463rd District. 1852 - The September 1852 poor school funding list of the 463rd District shows Priscilla Pool's child, Hardy K. Pool. 1854 - In the September 1854 term, Prissilla [sic] Pool is listed as having two children eligible for poor school funding in the Wyatt District (463rd.) The two children are probably Hardy and Lauretta. However, the 1851 poor school list also shows a James Pool. James has not been linked to any family in the Newton County area. James O. Pool also appears later in the November 3, 1858 poor school funding list of the 463rd District. 1857 - Miss Priscilla Pool is shown in the poor school funding list of Wyatt District as having 2 eligible children. Again, these are most likely Hardy and Lauretta.

45. Morning POOLE was born about 1804 in Fairfield County, SC. She was married to William VAUGHN on 4 Mar 1825 in Newton County, GA.
