BAILEY, JAMES A.M. Inventory filed Aug., 1822 by John H. Bailey, admr.

BAILEY, VALENTINE Account of sale given Jan. 31, 1867 and Apr. 30, 1870 by Luvenia G. Robertson, admrx. Said Luvenia was the wife of Thomas B. Robertson and formerly Luvenia Bailey.

BAKER, CLAIBORNE The heirs having renounced their right to administer, J.G. Newsom was apptd. admr. Jan. 6, 1888. Inventory taken Jan. 28, 1888; accounts current Jan. 6, 1888 and Jan. 6, 1889. Heirs were Mary and Eliza Baker, daus. of the dec'd. Mention is made of Rebecca Baker, dec'd. mother of Mary and Eliza Baker.

BALLARD, JOSEPH John Ballard was admr. of the estate, Dec. 27, 1777, replacing William Rhoads, the dec'd. exr.

BARCLIFF, SARAH B. Jesse F. Newsom having renounced his right to administer, W.A. Johnston was apptd. admr. Sept. 1, 1879. Heirs were Jesse F. Newsom, J.V. Newsom, Rebecca Motling, Joseph Kirkland (nephew of the dec'd.), William Kirkland, Lun(?) Vaughan, Eliza Devid(?) (of Warren Co.) and Nancy Powell (Warren Co.)

BARHAM, J.H. Year's support to the widow Laura R. Barham, Jan. 7, 1888.

BARNES, GEORGE W. (not an estate) George W. Barnes, Sr. was apptd. gdn. of his son George W. Barnes, Jr., Nov. 20, 1860.

BARNES, JEPTHA A. Account current from Feb. 1819 - May, 1821 with Joseph J. Williams, admr. Joseph J. Williams was apptd. gdm. of Charity D. Barnes, orphan of the dec'd., May 18, 1825.

BARNES, JOHN Inventory taken Feb. 27, 1822; account of sale Mar. 18, 1822.

BARNES, PETER Rhodham Barnes, gdn. of Sarah Barnes (orphan of the dec'd.), filed gdn. accounts from Nov., 1804 - Feb., 1822.

BARTLEY, FRANK William T. Shaw was apptd. admr. Feb. 14, 1883; account current from Mar., 1882 - Feb. 14, 1883. Heirs were the widow Sarah Bartley and Mack, Hilliard, Henry (minor), Millard (minor), Robert (minor), Junius (minor), Bettie (minor), Louisa (minor) and Matilda Bartley (minor).

BASS, B.W. The widow Fannie Bass qualified as exrx. May 9, 1877. Heirs were the widow, O.S.(?) Bass (age 40) and Polly Florence Bass (age 8).

BASS, J.L. Account of sales given Feb. 19 and Mar. 15, 1898; inventory taken Apr., 1899; final account given Apr. 14, 1899 by M.L. Mountcastle, admr. Heirs were Mrs. M.A. Barkley, S.W. Mountcastle and Claudia Taylor.

BRINKLEY, W.H. R.M. Johnson was apptd. admr. Dec. 10, 1888. Heirs were the widow Lucy Brinkley (age about 40 in 1888), William Brinkley (age about 8), Walter Brinkley (age about 15).(all of Halifax Co.), Thomas (age about 11) and Spencer Brinkley (age about 9, both of Oxford, NC). The deceased died in 1885 and was the son of Spencer P. Brinkley.

BRINKLEY, WILLIAM Benjamin Hunter, gdn. of the orphan Richard Brinkley, filed his gdn. account for 1868. The ward was age 21 in Nov., 1869.

BRITT, FRANKLIN Account final Dec. 16, 1871 with Braswell Britt, admr.

BROOM, FRANCIS (not an estate) The said Francis Broom was apptd. gdn. to his own son Jesse Haley Broom, Nov. 17, 1823.

BROWN, JOHN Theophilus Brown qualified as exr. Jan. 9, 1878. Inventory taken Mar. 29, 1878; account of sale given Feb. 6 & 7, 1883. Heirs were the widow Jinett Brown and the children of the dec'd.: Theophilus Brown, Virginia W. Brown, Samuel Brown, John Brown, Caroline Herbert, Margaret C. Bradley, Frances M. Browning and Amanda Walker.

BROWN, SUSAN E. Richard W. Brown was apptd. admr. Sept. 23, 1885, and was apptd. gdn. of the orphans Richard Moseley Brown and Laura Elizabeth Brown. Only other heir was Richard W. Brown, husband of the dec'd. The estate contained property in Bedford Co., VA.

BROWN, WILLIAM E. Account current for 1868 to 1872 with G.H. Macon, admr.

BROWN, W.W. William P. Robertson was apptd. gdn. of the orphans William West Brown and Sallie J. Brown, Sept. 17, 1878. Gdn. accounts were filed for 1878 to 1885.

BROWNING, BENJAMIN Year's support given to the widow Sophia V. Browning, June 21, 1886.

BROWNING, E.D. W.H. Day qualified as exr. Jan. 27, 1888. Heirs were Virginia Gee, M.G. Day, Florence Faucett, W.D. Faucett (a minor), L.D. Browning, T.B. Browning, W.D. Browning, Annie Kidder, W.M. Parson, F.? Browning and William Parson?. (difficult to read)

BROWNING, FERIBEE Hezekiah Evans qualified as exr. Oct. 14, 1876. Heirs were Mrs. Jennie Potter, Miss Elizabeth Evans, Miss Gussana Evans, Mrs. Adeline Heath, Miss Margaret L.C. Powell, Mrs. Florence M. Powell and Hezekiah Evans. All are residents of Halifax Co. except Adeline Heath who lives in Franklin Co.

BROWNING, TIPPO M. H.J. Hervey & W.W. Perkins qualified as exrs. June 25, 1870.

BRYAN, JAMES Account of sale given Oct. 3, 1868 by John C. Randolph, admr.

BRYAN, JAMES S. R. Wilkins qualified as exr. Dec. 18, 1894. Heirs were Martha Susan Bryan, Angelina Bryan, Winifred N. Bryan, Sarah Eliza Wynn, Laura A. Braswell and Elizabeth P. Wynn.

BRYAN, MRS. MARY L. C.P. Simmons qualified as exr. Apr. 17, 1889 and took inventory Mar. 9, 1889. Heirs were Herbert G. Bryan, Maud Simmons (wife of Charles Simmons), Hettie Pope (wife of J.J. Pope), Mollie Powell (dec'd.), Emma Cotten (wife of W.L. Cotten), Ella Simmons (wife of C.P. Simmons) and Ellen M. Williams. The infant heirs of Mollie Powell, dec'd. were Ethel and Mary Powell.

BRYANT, JOHN Year's support given to the widow Della Bryant, Dec. 23, 1884.

BULLOCK, MOLLIE C. E.C. Bullock qualified as exr. May 9, 1883 and was the only heir.

BURGESS, CHARITY A. Margaret J. Merritt qualified as exrx. July 31, 1883 and took inventory Oct. 16, 1883. Heirs were Charity Ann Benton, Ann Olivia Merritt, Jerry D. Askew (minor), Charity Askew and Margaret J. Merritt (minor).

BURGESS, F.A. Year's support to the widow Lousinda Burgess and the only heir (an unnamed posthumous child), 1884. A.A. Burgess was exr.

BURGESS, JOHN E.B. Perry was apptd. admr. Oct. 15, 1891. Heirs were Mrs. M.M. Solomon (of Ohio), Mrs. Lucy E. Moore (of Colorado), Mrs. Sally B. Perry, the heirs of T.L. Burgess (in Halifax and Nash Co's.), C.H. Pearson? (Granville Co.) and Mrs. Emily Gay (Wilson Co.).

BURGESS, THOMAS A. Inventory taken Apr. 14, 1884 by Alfred A. Burgess, exr. The dec'd. had a share in the estates of Robert Burt and J.A. Burt after the death of Emily M. Burt.

BURGESS, THOMAS L. The widow Lucy R. Burgess having relinquished her right to administer Apr. 25, 1892, David Bell was apptd. admr. Apr. 28, 1892. Heirs were the widow, J.L. Burgess (age 38, Wake Co.), Robert Burgess (age 30, Wake Co.), C.T. Burgess (age 6, Wake Co.), T.F. Burgess (age 20), W.L. Burgess (age 18), Mary M. Burgess (age 15), _.A. Burgess (age 13), L.C. Burgess (age 11) and C.A. Burgess (age 9).

BURK. SARAH Inventory taken Mar., 1809 by William Hillen?.

BURNETT, MRS. E.L. Account current for 1864 to 1879 with William H. Jones, admr. de bonis nom (former admr. had been J.B. Bowers). The dec'd. had a share of the estate of Wiley Powell, of which one share went to Martha E. Alsop, wife of S.S. Alsop, Jr.

BURNETT, JAMES Account current for 1863 to 1879 with William H. Jones, admr. A one-half share went to the widow Isabella F. Burnett, a one-eighth share each to William and Ammariah Burnett (heirs of Benjamin Burnett) and a one-eighth share to the heirs of Joseph Burnett.

BURNETT, MARTHA E. (not an estate) W.E. Bowers, gdn. of the ward, took inventory Jan. 1, 1871 and gave gdn. accounts for 1871 to 1873.

DUNN, MARGARET A. (filed as Mary A. Dunn) Martha F. Powell and Martha E. Burnett having renounced their right to administer their aunt's estate in 1873, W. Ezra Bowers was apptd. admr. July 25, 1873. John Watson also refused to qualify as exr. July 23, 1873. Inventory taken Sept. 26, 1873. Heirs were Mary E. Powell (minor), Wiley Powell (minor), Eugene Allen (minor), Ivy Allen (minor), Martha E. Burnett, Thad R. Bowers, W.E. Bowers, Martha S. Dunn (minor, of Nash Co.), William O. Dunn (Nash Co.), Frank W. Dunn (minor, of Nash Co.) and Martha Powell. Mary E. and Wiley Powell were orphans with John Watson of Warren Co., their gdn.

EASLY, LUCY Benjamin F. Gary qualified as exr. July 29, 1875. Inventory taken Feb. 5, 1876 and account of sale Oct. 13, 1875. Final account filed for 1875-1882. Only heir was James C. Anderson (minor). If he should die without heirs and before reaching 21 years of age, his legacy would go to Benjamin F. Gary.

EATON, VIRGINIA P. Mrs. Seigniora M. Lockhart was apptd. admrx. Nov. 11, 1876 and was the only heir. Inventory taken Mar. 13, 1877. Mention is made of land in Northampton County.

EATON, WILLIAM A. Inventory taken May 18, 1818 by H.G. Williams, Sam. Williams and Benjamin C. Eaton, exrs.

EDMONDS, ELIZA N. M.G. Day having renounced her right to administer the estate Nov. 11, 1890, E.T. Clark was apptd. admr. Nov. 13, 1890. Heirs were Mary G. Day (wife of W.H. Day) and Augusta T. Powell (wife of W.C. Powell), sisters of the dec'd. Account current for 1891-92.

EDMONDSON, D. R.C. Josey, Mary P. Edmondson and Thomas E. Powell qualified as exrs. Sept. 13, 1894. Heirs were Mary Edmondson, Etta Josey, Minnie Taylor and the children of Minnie Taylor.

EDMONDSON, MARY P. Inventory taken May 8, 1902 by R.C. Josey and W.A. Dunn.

EDMONDSON, POLLARD Ed. Pennington and James R. Council qualified as exrs. Nov. 29, 1892; inventory taken Jan. 9, 1894. Account final May 9, 1894. Heirs were Wm. M. Edmondson, trustee, John Evans, Dora Jones, Gatsy Council, William Edmondson and Hattie Edmondson, all of Edgecombe County. John Evans and Hattie Edmondson were minors.

EDMONDSTON, MRS. CATHERINE A. John Devereux qualified as exr. Mar. 31, 1875; inventory taken Jan. 10, 1875. Heirs were John Devereux, John Devereux, Jr., T.P. Devereux, F.J. Miller, Mrs. H. Cannon of Wake County, Mrs. Elizabeth Jones and Miss Rachel Jones of Baltimore, MD, and Owen and Dolly Richardson.

EDMONDSTON, PATRICK M. The widow Catherine A. Edmondston having relinquished her right to adminster, John Devereux was apptd. edmr. Dec. 1, 1871. Account of sale Oct. 22, 1873. Only heir was the widow.

EDMUNDS, ELIZABETH Allottment of Negroes Jan. 9, 1822 among Charles Edmunds, Benjamin Edmunds and Elizabeth Johnson, children of the dec'd. The estate included the undivided Negroes from the estate of their dec'd. sister Sally Powell.

EDWARDS, MISS CARRIE Account current for 1896 filed Jan. 15, 1900 by J.T. Gooch, admr.

HADNOT, SARAH Account of sales given Jan. 1, 1808. (No exr. or admr. named)

HAGANS, HARRIETT M. E.T. Branch qualified as exr., May 2, 1888. Only heir was James W. Branch.

HAIL, BENJAMIN Account current for 1819 with George Powell, admr. Money had come to the estate of the dec'd. from the estate of his dec'd. father (unnamed), Feb., 1822.

HAILE, SARAH James H. Haile was apptd. gdn. of Andrew Haile, minor heir of the dec'd., Feb. 16, 1824.

HALE, BENJAMIN H. C.H. Hale was apptd. admr. July 30, 1891. Heirs were the widow Mary F. Hale, Kate S. Mabry, Sallie M. Hale, S.H. Hale, B.H. Hale, A.M. Hale (not a resident of NC), C.H. Hale and R.S. Hale (not a resident of NC).

HALE, EATON F.W. Gregory was apptd. admr. Sept. 21, 1887. Their were no heirs. Inventory taken by the admr., May 4, 1888.

HALE, JACK R.J. Lewis was apptd. admr. Apr. 9, 1879. Heirs were Miles Hale, Laura Demry and Kate H. Eaton Lewis?.

HALE, LEWIS The dec'd. died June 18, 1865 leaving a will in which his wife Sarah E. Hale was exrx. She died Nov. 5, 1867 and William E. Aaron was apptd. admr. In his will the dec'd. had made bequests to go to the following heirs after the death of his wife: to Sallie M. Hale (dau. of Benjamin and Mary Hale), to Catharine S. Hale (dau. of Benjamin and Mary Hale) and to Elizabeth Tucker (who became Elizabeth Brigendine but died in 1873 in King and Queen County, VA, leaving Mrs. Elizabeth Carter her heir).

HALE, MARY Richard B. Parker was first apptd. admr. but died in Jan., 1869. W.H. Day was then apptd. admr. Apr. 28, 1869. Heirs were Benjamin Hale, Rebecca Kitchin (wife of L.L. Kitchin) and Lucy Pearson (wife of John Pearson). The dec'd. died in 1863.

HALE, SAM Inventory taken Nov. 19, 1903 by S.G. Daniel, admr.

HALE, SARAH William E. Aaron qualified as exr. (no date) A legacy was paid to Miles Hale Mar. 6, 1875 and to William H. Peebles of Alabama, who sold his share-to J.M. Grizzard, Feb. 2, 1872.

IRBY, T. Edward T. Clark was apptd. admr. July 1, 1891 and gave an account current from Oct. 30, 1891 to Apr. 26, 1895. Heirs were unknown.

IRBY, THOMAS Johnes (sic) Lee was apptd. admr. Aug. 18, 1862 and gave an account current from Sept. 23, 1862 to Oct. 21, 1870. Heirs were Martha Lee (sister of the dec'd. and wife of Jones Lee), Wealthy Hall/Holt (sister of the dec'd.), Harriett Mabry (sister of the dec'd, and wife of Washington Mabry), Betsy Tucker (sister of the dec'd.), the heirs of a dec'd. brother Edmund/Edward Irby and the heirs of a dec'd. brother Harrison Irby. The dec'd. had received money from the settlements of the estates of Calvin Irby and William Irby, Dec. 30, 1859.

IVES, SAMUEL Samuel T. Ives was apptd. admr. June 5, 1879 and took inventory Aug. 12, 1879. Account final with the admr. from Oct. 21, 1878 to Nov. 9, 1881. Account of sales Sept. 3, 1879. Heirs were T.H. Ives, S.T. Ives and Sarah A. Dickens (wife of J.A. Dickens).

IVES, SAMUEL T. Year's support allotted to the widow Eliza A. Ives, Mar. 10, 1886.

IVES, THEOPHILUS Personal property allotted to the widow Rosa L. Ives, Mar. 22, 1886.

IVEY, BENJAMIN W. Margaret B. Ivey qualified as exrx. Nov. 25, 1876 and took inventory Apr. 17, 1877. She was the only heir.

IVEY, JOHN Inventory taken Aug. Court, 1862 by Richard B. Parker, exr.

IVEY, MARGARET B. Dr. A.B. Pierce qualified as exr. July 6, 1891. Heirs were Amanda Sykes (of Georgia), Jonas Pierce, William A. Pierce, William E. Ivey, Mary Ivey, Emma Ivey, Pattie Ivey, Mollie Ivey, Oscar Pierce, Light(?) Pierce, Susan Ivey (wife of Robert Ivey) and Dr. A.B. Pierce.

IVEY, RICHARD N. William E. Ivey and Robert W. Ivey, Jr. qualified as exrs. Feb. 6, 1882. Heirs were William E. Ivey, Richard B. Ivey, Susan F. Ivey, Mary E. Ivey, Robert W. Ivey, Sallie J. Powell, Willie O Smith (age 19) and John R. Ivey (Johnston, SC).

IVEY, R.W., JR. Mary E. Ivey qualified as exr. June 9, 1893 and was the only heir.

IVEY, ROBERT Account of sale Dec. 6, 1814 with John Ivey, exr., who also filed an inventory Oct. 14, 1814. James Bishop, gdn. of the orphans, filed gdn. accounts for Robert, Richard and Elizabeth Ivey, Aug. Court, 1817.

IVEY, SUSAN Inventory taken Aug. 30, 1815 by John Ivey, admr. Account of sales Jan. 1, 1816 and account current Aug. Court, 1816 with the admr.

to administer the estate, Edward T. Clark was apptd. admr. Feb. 7, 1883 and filed an inventory Feb. 9, 1883. Heirs were David Jones, Sarah Hutchins, Mary Merritt, Mariah Bartley, Catherine Walden and R. Grant Jones (a minor).

JONES, WILLIAM H. Pattie V. Jones was apptd. gdn. of her own children (orphans of the dec'd.), Mar. 14, 1893. This record reveals the names and birthdates of the orphans as follows: Sallie D. Jones, born Apr. 26, 1872; Frank A. Jones, born Jan. 24, 1874; Pattie V. Jones, born Feb. 27, 1879; and James P. Jones, born Dec. 2, 1880.

JONES, WILLIE W. The original administrators Joseph B. Littlejohn, Sarah Burton and Willie Epps having died, L.M. Long was apptd. admr. Jan. 22, 1883. Heirs were Sallie E.
