52,53- Aug. 25, 1797- proved May Court 1800- DAVID BRADFORD, SR. wills to wife ELIZABETH 4 negroes, plantation whereon I now live and son JAMES BRADFORD to live on plantation and work hands on said land, household furniture, stock, to stay with my wife for use of family and maintaining them; to two children when of age or married, that which she thinks right; at death of wife, all furniture and stock to be divided to two children JAMES and ANN BRADFORD; to my wife, 4 horses and all working tools for her lifetime; to son JAMES, the land whereon I live and also 640 acres on Reedy Branch, 6 negroes, and after death of his mother, 2 other negroes, wagon, horse, bed and furniture, a desk, gun and working tools; to daughter ANNE, 618 acres on Reedy Branch, 5 negroes and, after death of her mother, 2 other negroes, a feather bed and furniture; if either of children die, the whole to the survivor.
