She was preceded in death by her husband and an infant; her parents; brothers, Dale Shell and an infant brother; an infant sister; and an infant grandson.



# German Speaking People West of the Catawba River in North Carolina 1750 - 1800 and Some Émigrés' Participation in the Early Settlement of Southeast Missouri

### Introduction

This is a migrational history of more than six hundred immigrants (heads of household) who pioneered the settlement of the present-day North Carolina counties of Burke, Catawba, Cleveland, Gaston, Lincoln, and Rutherford.

Emphasis is upon time of arrival, spouses, children, children's marriages, and where families moved. Other information, where available, includes ships the settlers arrived on and points of departure from Virginia, Maryland, and Pennsylvania as they moved south.

Documentary evidence of origin in Alsace, Switzerland, the Netherlands and Germanic provinces of Europe, some as many as five generations prior to emigration, has been located on a surprising number of families. Sources are listed throughout the volume.

Many of these émigrés participated in the early settlement of southeast Missouri. By 1810 they were moving into northeast Arkansas, then westward. Many families are followed as many as four generations after arrival, tracing pioneer progeny south and westward, and as far north as southwest Virginia, Kentucky, southern Indiana, and Illinois to continue the repetition of names on land records and tombstones.

This is a culmination of forty-six years of research by the author; the generous contributions of many longtime associates, and the expertise in European research generously contributed by Miles Philbeck and other individuals. It is a one-of-a-kind guide to an important group of immigrants as they pioneered in the settlement of America.

These become a major problem, but anyone doing genealogy will soon learn to identify them on records. However, occasionally we happen upon a new one..

*Marillis* was one which plagued me for years. It was not until working with these records that I discovered it was short for Maria Elizabeth.

Note: Magdalena may have been a second wife. The fact that dau Magdale ma had m. by 1755 to Jacob Setzer and son Mathias Boovey was b. ca 1761 indicates a good possibility of a second wife.

ANC, NC, DB B:375-6 - 6 & 7 Dec. 1754 - Jonathan Howman and wife Rebecca sold 320 A on middle fork of Killians Creek, the place formerly surveyed for Conrad Pove, which was granted to Howman 17 May 1754.

Note: Conrad is missing from records until 1764.

MC, NC, DB 4:397-8 - 18 Dec. 1766 - Conrad Povey and wife Magdalena deed 196-1/2 A to Jacob Setzer which was granted to him 21 Apr. 1764 on Elk Creek.

MC, NC, wills: 1/8 Dec. 1766, probated Jan. 1767: Conrad wills to wife Magdalena; dau Magdalena (wife of Jacob Setzer) and her children Jacob, John and Adam Setzer and to Mathias Poovey.

Emanuel's Lutheran Church, Lincolnton, NC: Heinrich Probst b. 18 Nov. 1798, bp. 13 Jan. 1799, son of John Probst.

Sarah Probst, b. 24 Jan. 1810, dau of Nikolas Probst and wife Elizabeth.

Heinrich Probst, b. 5 Aug. 181\_, son of John Nikolas Probst and wife Elizabeth.

John Probst d. before 27 Nov. 1811, is reputed to have m. Catherine Cotner, dau of Jacob Cotner, d. 1805 CGC, MO. She is said to have m. (2) \_\_\_\_\_\_ Byrd. I have not proved this. Please read further.

CGC, MO, Probate Record Box 15, Bundle 295: Letters of Administration granted to Conrad Statler 27 Nov. 1811 on the estate of John Propst.

19 Feb. 1823: Letters of Administration granted to Henry Propst (on the estate of John Propst) on the unadministered portion during the administration of Conrad Statler; on this document Henry acknowledges there were three sons and four daughters. However, only two sons and two daughters have receipts in files: Daniel and Henry Propst, Elizabeth Crites and Barbara Robinson.

**Note:** There are no division or guardian's records in the court minutes, just minute records of continuing administration through 1824. I do know there is a book that may contain the necessary records, but I do not know the name. I have excerpts on other families that have been sent to me from it.

This writer believes this to be John Probst, Jr., due to the fact that he was not the one who obtained the 640 arpents of land and ages of these children indicate they were born ca 1800 - 1810.

CGC, MO, DB F:169 - 2 Nov. 1821 - John Propst and Barbara his wife deed 140 A to Hiram Estes and Polly his wife (late Polly Propst), dau of said John and Barbara, for love and affection.

1830 CGC, MO, Census: Hiram Estes 2 m. -5, 1 m. 5-10, 1 m. 10-15, 1 m. 30-40; 1 f. -5, 1 f. 30-40.

CGC, MO, DB F:341 - 23 Apr. 1823 - John Propst and wife Barbara sold 1 A - a part of the 640 Arpents from the Spanish government.

CGC, MO, DB F:493 - 26 Jul. 1824 Hiram Estes and Polly his wife deed 140 A to John Propst, Jr.

Note: I believe this to be actually John III and the one who m. Canzada Cheek.

CGC, MO, DB I:336 - 1838 - John Propst and wife Canzada sold 140 A to George Hartle, part of a tract ceded to John Propst, Sr., under the Spanish government.

JACOB PROPST, b. ca 1781 LC, NC, d. after 1850 CGC, MO; m. probably LC, NC Sarah \_\_\_\_\_, d. before 1840 CGC, MO.

Note: This writer believes he was either son or grandson of Frederick. Frederick's widow, Sophia Aschenbrenner Propst has 1 m. 16-26 in her household 1800 LC, NC, Census.

Neither John nor Jacob appears on 1800 LC, NC, Census. Sophia sold her lands in NC by 1804.

1790 LC, NC, Census: S. Propst 1 m. -16, 3 m. 16+; 1 f. This is apparently Sophia, but I have no idea what happened to these children.

19 Jan. 1803 Claimants to Public Lands CGC, MO: Jacob Propst 250 Arpents' (a French unit of measure equal to .85 of an acre).

Board of Land Commissioners for Missouri - Minute Books: 1:258 - 1 May 1 806; 3:479 - 20 Feb. 1809; 4:238 - 23 Dec. 1809; 5:167 - 1 Jun. 1811, Jacob Probst, Claimant.

1806 List of Inhabitants: Jacob Probst.

CGC, MO, DB F:376-7 - 5 Sep. 1823 - Jacob Propst and Sally his wife to Martin Thomas 100 A bounded on two sides by land belonging to Jacob and part of the tract where he now lives.

CGC, MO, DB H:123-4 - 16 Apr. 1833 - Jacob and Sary Propst sold 2 O A on S. west side of W. fork of Whitewater. Confirmed to the said Jacob Propst.

CGC, MO, DB K:80-1 - 21 Sep. 1841 - Jacob Probst to John Welty, part of land confirmed to said Propst under Spanish government; DB K:346 this 500 A was returned to Jacob Probst on 25 Oct. 1842; DB M:213-4 - 11 Feb. 1847 - Jacob makes a maintenance bond with Henry Miller and Elizabeth his wife to provide for Jacob during his lifetime which again involves this land. However, 1850 Census Jacob was living in home of Andrew Miller and Sophia his wife.

LODWICK/LEWIS PROBST received a MC, NC, warrant for 600 A on Andrews Branch of Howards Creek 18 Apr. 1767, which was granted to him by Crown Patent 9 Dec. 1768.

LC, NC, DB 16:269 - 17 May 1792 - Lodwick made a deed to his sister-in-law Sophia Aschenbrenner Propst, widow of Frederick, for 100 A; 17:198 - 18 Nov. 1794 - he deeds 300 A to nephew John; 17:208 - 18 Nov. 1794 - 200 A to Wm. Tron baugh, Jr.

Note: These deeds prove Lodwick and Frederick were brothers. Their relationship to Henryand Mathias is not known.

LC, NC, DB 19:45 - 1 Jan. 1799 - Sophia Propst purchases Lot #13 in Lincolnton, NC. She sold this and the 100 A she received from Lewis.

LC, NC, Wills: 22 Jan. 1799, probated Apr. 1799 - Lewis Propst wills to sister-in-law Sophia Propst and she was Executrix of the estate. He signed the will as Ludwig Props.

MATHIAS PROBST of Lyon Twp, Northampton Co., PA, purchased 325 A on E. branch of Clarks Creek about a mile N. of Paul Anthony. MC, NC, DB 3:59-62 - 9 and 10 Nov. 1765.

**Note:** I could find no other mention of Mathias in any record in the Catawba area. However, I found the following which just might pertain to him. His relationship to the others is not known.

Allemaengel Lutheran Church, Berks Co., PA: Mathias Probst and wife Maria Magdalena Stambach, had a dau Catharine Barbara b. 16 Dec. 1767 Lyon Twp., bp. 24 Jan. 1768 with George Probst as sponsor.

MICHAEL QUICKEL, b. 1747 Lancaster Co., PA, d. 8 Oct. 1818 LC, NC; m. ca 1770 LC, NC, Anna Maria Friday, b. 4 Dec. 1747, York Co., PA, d. 7 Oct. 1826 LC, NC; believed to be dau of Nicholas and Anna Elizabeth Friday, Sr.

The parentage of Michael would appear to be Johann Michael Quickel; m. (1) 26 Ju. 1741 Barbara Muller, Trinity Lutheran Church, Lancaster, PA. This Michael was b. 25 Jul. 1721, d. 18 Dec. 1787 Dover Twp, York Co., PA, and buried in Quickle's Church Cemetery. It is expected Barbara is buried in Conestoga Twp. Lancaster Co., PA, where Michael appears on 1751 and 1757 tax lists and land records through 1763.

Michael made his will 10 Jul. 1785 which was probated 29 Jul. 1788 and names his children: Son Michael to get £30 as he had heretofore received near to his divided share:York Co., PA WB - G:300.

Johann Michael Quickle m. (2) 2 Jun. 1761 First Reformed Church of Lancaster (both widowed) Barbara Snavely (Schnabele) Bohner, a widow with two Bohner children: Henry and Barbara (see Bonner records).

He bought over 400 A in Dover and Manchester Twps, York Co., PA, DB B:41 3 - 14 Jul. 1764, and 2F:12 - 17 Apr. 1769; he conveyed 2 A and 47 perches to the Lutheran and Calvinist Congregation (Quickel's Church) D:241.

Johann Michael Quickel, b. Sunday, 20 Jul. 1721 (tombstone 25 Jul.), bp. 21 Jul. 1721 in Brandau, Hessen; sp. John Michael Roth; and confirmed 1734, Neunkirchen KB; son of Christophel (who was son of Jost, son of Leonhard) and Anna Barbara Ross.

Note: Sources are Robert C. Carpenter and *RCC:CAP*; Peter J. Rzemnski; and Janet Quiggle Harmon, Convent Station, NJ; Agnes Yount.

1A. ANNA MARIA QUICKEL, b. ca 1772, LC, NC, d. LC, NC; m. 12 Jun. 1790 LC, NC Philip Cansler, Jr., b. ca 1765 PA, d. before Apr. Ct. 1854 LC, NC, son of Philip and Juliana Defenbaugh Cansler.
