- 2. Jemima Hill, born 1807-08? no other information.

5. THOMAS RODEN, a return made by Moses Bond in Charleston for Thomas Roden on 3 December 1766 for 50 acres on Sandy Creek, a branch of Broad River in Craven County, it being a part of the 250 acres granted to Zachariah Isebell on 8 March 1763 and sold 16 July 1766 to THOMAS RODEN (NOTE DIFFERENT SPELLING) by deed from Zachariah Isbell with dower (release?) by his wife Elizabeth Isbell...and also for 250 acres of land on Sandy Creek, granted 20 June 1764 and to Jemima Potts (NOTE Potts Buton data # 28) and conveyed by deed dated 16 November 1764 to Thomas Roden by Jeremiah Potts with dower by his wife Mary Potts. Bounded by lands of Zachariah Isbell and vacant lands.

Note these returns on land grants are for lands bought by Thomas Rhoden and not for his original grants as noted in # 2 and # 3.

- 6. WILLIAM RHODEN a memorial tax return for 200 acres of land in Craven County on forks of Wateree Creek and River certified for him on 5 March 1765 and surveyed for him by Isaac Perry and (on) all sides vacant at the time of the grant on 12 March 1765 (see #2) Return made in Charleston on 3 May 1765 by William Aldridge for William Rhoden.
- 7. I happen to know that William & Isaac Aldridge with Moses Bond and John Pearson with some of the Gibsons, Turnipseeds and others came down from Pennsylvania about 1750.
- 8. JOHN NICHOLAS RODEN a memorial tax return made by him in Charleston for 100 acres of land on north side of Indian Fields Swamp in Berkeley County (now Orangeburg or Dorchester) with all sides vacant and granted to me by King George II, dated 22 January 1759. Return made 17 Jan 1760.

JOHN RHODERIN, a return made by Michael Muckenfuss in Charleston dated 27 September 1765 for John Rhoderin for 100 acres in Berkeley County on the Edisto River (now Barnwell Co.) by vacant land on two sides and on two sides by lands of Tobias Hartzog, certified for me 21 March 1765 and granted 30 August 1765 (see # 2, 3 & 4).

9. BENJAMIN LOVE, 14 October 1768, made memorial tax returns for 100 acres of land on Turkey Creek in Craven County for MARGARET BOWDEN (RODEN?), surveyed for her by William Gist on 12 August 1768...also JAMES BODEN (RODEN?) for 100 acres on Broad River of same date as that of Margaret Boden (Roden?)....I copied these thinking they might be Roden, BUT later checking immigrants I found that John, James and Margaret Boden came in as immigrants with the spelling of BODEN.

I checked no further memorial land returns for Roden.

- 10. WILLIAM RODEN, husband of Jane, of Fairfield County had a survey for 200 acres certified for him on 6 December 1765 between the forks of Bever Dam and Wateree Creeks of the Wateree River...William Roden gave the land in 1770 for the Baptist Church there now called "Beulah Baptist Church." It was then the Wateree Branch of the Congaree Baptist Church and was later moved to Dutchman's Creek, located about 5 and 1/2 miles south of Winnsboro...from Townsend's S.C. Baptist (Church?).
- 11. WILLIAM RODEN, husband of Jane, in 1787 was a member of the Skull Shoals Baptist Church on the Pacolet River, or at least he had some part in the organization of that church for his name appears in 1787...Townsend.
- 12. JOHN RODEN, son of William & Jane Roden, in 1799 was a delegate to the Bethel Association of Baptist from the Sandy River Church in Chester with James Fowler, Pastor.

- 18. GEORGE ROWDON, FILE # S-15 623, a Pension for Revolution in National Archives in Washington, D.C. for George Rowdon of S.C.
- 18a. Whether this pension is same as George Roden (#17) I am unable to say. Write for a pension summary sheet in Washington and see...The summary sheet may state where he was born and name some of his relatives.
- 19. JEREMIAH RODEN, Revolutionary Soldier, wife Susannah, FILE # R 8-926, a Revolutionary Pension claim from S.C. in files of National Archives in Washington. HE WAS SON OF THOMAS RODEN AND MARY POTTS.
- 19A. JEREMIAH RODEN does not have a file in S.C. and evidently served from some other state or never bothered to make a claim for an indent. Many did not place claims for their indent pay) or else his file was lost.

HE DID SERVE IN S.C BUT WHAT HAPPENED IS HE AND FAMILY MOVED TO ALABAMA...HE DIED AND HIS WIFE FILED CLAIM FROM ALABAMA.

20. JOHN ROTTAN, a memorial tax return made by James Patton in Charleston on 16 March 1764 for John Rottan for 200 acres on Turkey Creek in Craven County, all sides vacant & surveyed for him on 16 June 1763 by Jn. Wade and granted him on 2 March 1764. I had forgotten to add this.

RODEN REVOLUTIONARY CLAIMS.

21. JOHN RODEN, FILE # 6542, and for THREE distinct John Rodens in service and perhaps a 4th, who furnished supplies...I separated the three John Rodens by a comparison of signatures which showed them separate men.

21a. JAMES RODEN, for 40 days service in Militia in 1778 and for an account audited...Little River, S.C., dated 14th May 1785, Please pay my indent to Mr. David Hopkins and oblige and witnessed by Allen Long and Nathaniel Abney....Then D. Hopkins at Broad River, S.C. dated 28 May 1785, Pay the interest to Thomas Lehre and witnessed by William Stukes & Jeremiah Kingsley.

21a. The above was originally typed for a John Roden but it was for James Roden.

21b. JOHN RODEN (no. 1) For Militia Duty from 1 May to 1 December 1781 and for 214 days total (He resided in Orangeburg District)...This service was certified by Captain Frederick Wommork (Perhaps Wannamaker for there was a Captain Frederick Wannamaker) & by Captain Joseph Johnson and Lt. John N. Frey and witnessed by William Buyck.

John Roden used the first interest and made it payable to John Kirkland for collection/ Wit. Right Rice.

John Roden used another interest payment for the purchase of 20 acres, land originally granted to John Kirkland/ Wit. J. Clark/

23rd January 1787, John Roden used the indent for the purchase of 642 acres of land and made it payable to Micajah Rice/ Wit. Thomas Hingham.

21c. JOHN RODEN, a claim for a sorrel horse impressed from me by Col. Middleton and appraised in May 1781...claim was allowed and made payable to D. HOPKINS on 11 September 1784...the signature from this claim was missing and hence I was unable to determine which of the John Rodens made this claim, but he was likely from the area of Sandy River since he made it payable to David Hopkins, who lived up that way.

21d. JOHN RODEN (no. 2) for service of 35 days in 1778 under Captain John Mayfield and Captain Robert Frost, who certified same...sworn to 24th February 1784 before John Hitchcock, J.P......13th May 1785 John Roden made this indent payable to David Hopkins/ Wit. Nathaniel Abney & Abraham Whitlock. Broad River P.O., 28th May 1785, David Hopkins assigns the indent to Thomas Lehre for collection/ Wit. Jeremiah Kingsley & William Stukes. This John Roden is likely the same as # 21c.

- 21e. JOHN RODEN (no. 3) for 90 days service in militia in 1781-82...The main papers are missing but 11 October 1790, John Roden made claim payable to William Embry for collection in Columbia...His signature is completely different from signature of # 21d and # 21b, which always signed by name with a (X).
- 22. JAMES RODEN, for service and see # 21a for his data, which I mistakenly typed in for John Roden.
- 23. WILLIAM RODEN, husband of Mary Mayfield, but always signed as William Roden, FILE # 6542, a claim for 2 horses lost while in the militia service in 1781-82....Chester Co., 7 October 1787, please pay my claim to (not legible) and sworn to before John Pratt, J.P.....Abraham Mayfield collects same & perhaps was for the not legible name.
- 6th March 1787, WILLIAM ROADEN, signs the three years of interest on his indent to Jonathan Mayfield and Peter Sealy "To buy Land."/Wit. Thomas Nicholls. This William Roden was son-in-law of Jonathan Mayfield.
- 24. LEWIS BOATNER in his file for supplies, sworn to before Thomas Taylor, J.P., 15 January 1788 and certified by Richard Winn...Pay my claim to either Benjamin Hart or to JOHN ROTTAN/Wit. by Ludwig (not legible German script...seemingly it was Ludwig Schweisseger).
- 25. WILLIAM RODEN (WHO WAS HE?) a claim for 291 days of service from 3 July 1781 to 1st May 1782 on an Indian Expedition under Captain Parsons...also for 10 days service under Captain Barron of Col. Roebuck's Regiment, dated 15 November 1781....Also for 253 days dated 7 June 1780 under Captain Parson in the Regiment of Colonel John Thomas Jr.....without a date, this claim was made payable to Richard Winn of Fairfield District.
- 26. WILLIAM ROTTENBERRY, a claim for 193 days in 1781-82 and for a horse & saddle & bridle, lost in action....This was sworn to before Thomas Baker J.P. and made payable to Richard Winn of Winnsborough....(I took this since he seemed to reside in Fairfield and noted the Thomas Baker J.P. and Richard Winn's names).

- 34. WILLIAM RODEN of Barnwell (District) Will signed 26 October 1811, probated 10 April 1813. Wife Mary Roden...styles himself as planter. All my seven children to share equally and all EXS. My land to my three sons & named as John Roden, William Roden and Simon (Simeon) Roden. /Wit. Isaac Richardson Sr., Isaac V. Richardson Jr. & Samuel Richardson.
- 35. In Charleston i found a deed made by a William Rottan and witnessed by MOSES HILL dated 1777......I wonder if this was this William Roden..the land was not located as to county.

It would appear that the land was in Craven County (Camden District) in either in todays Fairfield-Chester County S.C. To date this is the earliest date we know of Moses Hill, who later married Savilla Roden, daughter of Thomas Roden.

36. JOSEPH RODDEN OF Charleston District (see #32), Will

signed 12 March 1803, probated 15 April 1803....wife Mary Rodden & Ex. No children. nephew, William White./Wit. William Holsall, Isaac Nelson & Christian Belser.

39. WILLIAM RODEN of Sandy River, Will signed 20 February 1795, probated September Court 1800...wife Mary Roden (Mary Mayfield) and she to have 1/2 my land and to her heirs at her death. The other half to my son Jonathan Roden. No Ex. is named. /Wit. Allen Mayfield, Greenberry Roden & James Atterbury.

5 December 1800 Mrs. Mary Roden (was a daughter of Jonathan Mayfield) named as Executor and her bond was signed by Jonathan Mayfield & Abraham Mayfield and witnessed by Edward McDaniel....18 November (year not legible) Abraham & Elisha Mayfield were named as Executors.

{NOTE: This is the same Mary Roden and wife of William Roden}.

- 40. OLD Thomas Roden Estate, Administered by Richard Wilkes (was a son in law). I did not open this file to see what data was in it...Chester Co.
- 41. OLD John Roden, of Chester County, a will signed 1 May 1820, probated 10 October 1821..and called John Roden Sr.....No wife is named...Lands at Rocky River. December Court 1824, this will was in litigation...Children named...

John Roden Jr. & Ex. Greenberry Roden, if not dead

Frances Wilkes Sally, wife of Abraham Bannister.

Miss Susannah Roden states she has cried and cried because she did not tear up the will which left her brother Joshua Roden out...an older will was brought up in which Richard Wilkes was called son in law.

Appraisers named were Gustavus Watson, Jesse Simpson, Hazel Hardwick & Richard Wilkes.....Joshua Roden and James Roden sign for shares....Ann Brown signs for a share (Perhaps a daughter & then Anna married?)...Mrs Bannister and Mrs. Wilkes sign for a share...John Roden signs for share...James Gilchrist for a share...Richard Wilkes signs for his wife....Mrs. Betsy Roden signs again and seemingly (was) a widow of a deceased son of John Roden Sr. (Maybe Jason Roden) I did not have the time in Chester to fully abstract this will.

42. In Kershaw County S.C. the Estate of Samuel Albert and later Estate of his widow, Mrs. Nancy Albert...Samuel Albert Estate Administered 22 October 1828 by his widow Mrs. Nancy Albert and her Estate. Citation read 27 June 1844 (She died 27 June 1844)...Assessment by Daniel Motley in right of his wife, Harriet Albert Motley...Heirs were:

51. Estate of Charles Humphries Administered 2 April 1802 by his widow, Mrs. Sarah Humphries and her bond was signed by George Brown & Kisman Bannister. /Wit. JOHN RHODEN.

#### CHARLESTON DATA

I was unable to find any will or administration for Rhoden or Roden or any of the variations of the spellings, in the Charleston records. I examined more than 100 books of Probate records and not a single entry. I will admit that with the system used in Charleston, that it will be very easy to miss an administration. The wills are much easier and are simple to find.

The deed books are from 1680 up to now. After 1800 there is a master Index...before 1800 there is a master index for some of the sets of books. There are over 400 books and they are piled to the ceiling (14 foot high) and step ladders have to be used to secure the books towards the top. It is a task that is hard. I did find your SAVILLA RODEN as a witness, but I was unable to find the name of her father...THREE RODEN Deeds follow and they were all the Roden data I was able to find.

- 57. Amos Tims with dower by his wife, Frances Tims, 13 November 1778, a deed to James Timms. /Wit. Robert Sanders, Joseph Tims & Austin Montray.

- 67. U-13 (BOOK U, PAGE 13?) Thomas Hill and dower by Jemima (Woodward) Hill....deed in 1821 to William Halsell, 189 acres for \$ 1200.00 being land surveyed for Thomas Roden in 1779 (might be 1789?) Since said "Surveyed for" rather than granted to...it is likely this survey was not claimed by Roden and Hill took it over...Often that is the case as I study grants. Andrea.

# 68. 1810 CENSUS FOR CHESTER COUNTY S.C. James Rodin aged 26-45 wife aged 26-45 (16-26?) girl under age 10. This James was nearer 26 than 45 and wife near 26 than 16.

69. THOMAS RODEN was one of the earliest Rodens in Chester County and may have died there in 1809. (HE DID). He probably came with his brothers, Zodak, John Sr., William Roden.....These comments were made by Nicholson.

# 70. 1800 CENSUS FOR CHESTER CO. S.C. John Roden over age 45....wife seems not to show in this census

1 male aged 16-26 & likely a married son or son in law.
2 males & 1 female under age 10. (5 slaves)
2 males aged 10-16.
2 females aged 16-26 & one likely wife of male 16-26
This John could also have a second wife of one of the females 16-26.
