the said *Cudgick Ruff* his Executors, Administrators, or Assigns, will be entitled to receive from this Office the Sum of *Five Shillings and three pence*

on the demand for one Year's Interest on the principal Sum of *Three pounds fifteen Shillings Sterling* and the like Interest annually

The said *Cudgick Ruff* his Executors, Administrators, or Assigns, will be entitled also to receive, and shall be paid, if demanded, the principal Sum of *Three pounds fifteen Shillings*

on the *3^d May 1788* And the said *Cudgick Ruff* his Executors, Administrators, or Assigns, may make any Purchases at any Public Sales of Confiscated Property, (except such as shall be ordered by the Legislature for Special Purposes;) and this INDENT shall be received in Payment.

For the true Performance of the several Payments in Manner above-mentioned, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the aforesaid ACT.
