

STEWART--FAMILY ORIGIN

This illustrious name, which has long been identified with the country of Scotland, has a very interesting beginning. When William the Conqueror invaded England in the 11th. century he was accompanied by a Norman knight by the name of Fitz-Alan. As a reward for his military prowess he was given large tracts of land in Shropshire. His second son, Walter, went to Scotland. He came into favor with King David I, and became prominent in the King's service. The King bestowed upon him large land possessions, among them being the Barony of Renfrew. The King Appointed him as Lord High Steward of Scotland. It was decreed by the King that the office should be hereditary.

Walter's great-grandson, Alexander, was the one who created the name "Stewart", and adopted it as his surname. He was at that time Alexander the Steward. He dropped the letter "d" at the end of the word, and inserted in its place the letter "t", and he became Alexander Stewart. As such he became the ancestor of the royal line of Stewarts of Scotland and England.

The spelling of the name as "Stuart" originated in France. Mary, daughter of King James V, who later became Mary, Queen of Scots, was educated in France, and she produced the change. She wrote her name in the French language. Because there is no "w" in the French alphabet, she put the letter "u" in the place of "w", and so spelled her name, Steuart. Later she dropped she dropped the letter "e", to spell it, Stuart. Completing her education in France and returning to Scotland in 1560, she held to this spelling. But her father, James V, wrote his name, Stewart, and likewise did his son, James VI.

The crown of Scotland was brought into the Stewart line in a very interesting manner by Walter Stewart, the sixth Lord High Steward of Scotland. The Battle of Bannockburn was fought during the reign of King Robert Bruce. Walter Stewart displayed great valor and rendered outstanding service during the battle. He later married the daughter of the great Robert Bruce. Her name was, Marjorie. Thus royal standing was attained, and their son was crowned as King Robert II of Scotland in 1371. Thus the Stewart dynasty was originated in Scotland.

A large Scottish Clan was formed by the descendants of Walter Fitz-Alan (Stewart), and became numerous by reason of the younger members. This distinguished Clan remained strong in Scotland even though there was much migration. Some went to northern Ireland, and some from there to America; and others came directly from Scotland to America.

Our own ancestor, James Stewart, of the Irish branch, born in County Antrim, came over to South Carolina in 1837.

Members bearing this distinguished family name migrated to America in great numbers. Stewart descendants are now living in just about every section of the U.S. A. And those bearing the name, or those of other names who are descendants of those who bore the name, are to be found throughout our country in the business world, and in the fields of arts and sciences.

5 INTRODUCTION

This is a genealogical and historical record of a branch of the Stewart Family; the descendants of John Stewart of Rhsherry, Ireland (Northern Ireland), through his son, James Stewart. I limit it by saying: "through his son, James", because he no doubt has many other descendants through his other children.

I have been interested in genealogy for many years. In previous years I have compiled and published my Beckman genealogy, and the Thompson (my wife's family) genealogy. My wife is a great-granddaughter of John Stewart of Rosherry. At her insistence, as well as others, I undertook their Stewart genealogy, and this book is the result.

You will find some mistakes because I am human, and have not as yet, as the Shorter Catechism says, "been made perfect and passed into glory." As I heard Mr. Paul Harvey, the Newscaster, quote sometime ago: "Vy is it ve get so soon old

and so late smart?" Vy? Because we are human.

On my part this has indeed been a "labor of love" for all the family. I've enjoyed it, and been richly rewarded in all the wonderful correspondence with the various members of the family, and others. And right here, in this manner, let me express and record my heart-felt thanks to each and every one who has so kindly helped me in this project. You have been wonderful.

I have tried to make it as complete as possible. But sometimes I could not get all the information I desired. There are some instances where the date is not in full, or parts of names or initials or places are omitted. But I tried, and on

the whole I think we have a marvellous genealogy.

Pictures, which are always interesting, are put in the book. I exercised the editor's right of selection, since we could not put in everyone. Forgive me is your picture is missing. And at the end of the genealogy will be found a number of appendices which should be of interest and informational to various members of the family.

As is customary in such a compilation as this I have used several abbreviations which are time and space conserving. They are: b., for born; d., for died; mrd., for married; dau., for daughter. And months also are abbreviated.

By means of the printed record, which will be in homes of the widely scattered family, and in various libraries, much information, which otherwise might be lost, will be pre-served for future generations. I hope it will be interesting, in some instances inspiring, and helpful to the present generation, but also to many in years to come. Louisville, Miss.

JOHN STEWART

John Stewart lived in Rosherry, County Antrim, Ireland. He died in 1822, age 44 years. His wife, Mary ---, died in 1855, age 79 years. They had five children of whom we know. Three girls: one mrd. a Mr. Lilley; one mrd. a Mr. Smiley; one never mrd., and died in Philadelphia. Pa. Two sons came to South Carolina in 1837. They were Robert and James. It took nearly eight weeks for the ship. on which they came, to cross the Atlantic Ocean and land in Charleston, S. C. They reported that a storm damaged the sails of the ship, and blew them off their course. The usual trip then was six weeks.

We can find no information about Robert Stewart, after the mention of him in a letter which James wrote to his mother in 1853. a copy of which I have. (Annie Mae Stewart has the original letter. See the Appendix, page 82).

JAMES STEWART

James Stewart was b. in 1811 in County Antrim, Ireland. He became a tailor by trade. (In 1913 Howard Thompson visited in Ireland while he was studying in Scotland. Called on Mrs. Jane Cameron near Ballymena. He called her

"Cousin Jane". See the Appendix, page 100).

When James landed in South Carolina he settled on a farm near Blackstock, Chester District. He mrd. (Ist.) Miss Jane Lee. They were members of Concord Presbyterian Church, Woodward, S. C. Jane Lee Stewart d. June 1, 1847, age 33 years. She was buried at Old Stone Presbyterian Church (formerly, Jackson Creek Presbyterian Church) Fairfield County. Nearby her grave is the grave of a Mr. John Lee, but no way of telling what, if any, relation existed. Their Children: - I. - Ellen, b. Oct 1, 1840; II. - John

Alexander, b. Feb 15, 1844; III .- Elizabeth Jane Lee, b.

June 1, 1847.

James Stewart mrd. (2nd.) Miss Elizabeth Hutchinson. She was b. in 1826, in County Antrim, Ireland, dau. of Sarah (Sally) Johnston and James Hutchinson. (See the Appendix, pages 84 & 86 for the Johnston and Hutchinson connection). They moved to Winston County, Miss., in 1855. He served for one or two years as the Overseer of the slaves on the Plantation of Mr. Daniel Coleman(grandfather of a present Mississippi Federal Judge, J. Plemon Coleman), near Fentress, Miss., west of Ackerman. Then he bought a place, built a house, and settled down to farm near Bethsalem Presbyterian Church. He was forced to give up the tailor trade because of the weakening of his eyes. He was elected a Deacon in Bethsalem Church in

1872. He was elected a Ruling Elder in the Church in 1884, and served faithfully until his death in 1895. Elizabeth was a wonderful christian, wife and mother. (See what her husband said about her in the old letter, Appendix, page 1). She was affectionately called "Big Grandma" by the W. Y. Thompson children to distinguish her from their other grandmother, whom they affectionately called "Little Grandma". He d. May 14, 1895. She d. Jan 20, 1904. Both are buried at Bethsalem Church.

ELLEN STEWART

I.- Ellen Stewart and her sister, Jane, remained in South Carolina when their father and stepmother moved to Mississippi. They lived with their Aunt Betsy Lee,

sister of their mother, Jane Lee Stewart.

Ellen never mrd. In later adult life her home was between the homes of her brother, John Alexander Stewart, and her sister, Jane Stewart Dunbar. It was situated nearer Woodward than Blackstock. In a manner of speaking, it was just headquarters for her, because she was out so much of the time being busy in helping other people. She might well be called "an angel of mercy" in

the community. (See picture, page 44)

Her talents were sewing and serving or ministering. In Acts 9:36, we read: "Dorcas was full of good works and alms deeds which she did". Ellen Stewart followed in the footsteps of Dorcas. She was a good seamstress, sewing for people, and would stay as long as a month if necessary in a home sewing for the family. She would also spend like time in homes where there was need of ministering on account of sickness or other special need, staying as long as her service was necessary. I am sure that there were many in the community who could, to change the words of Acts 9:39 without doing violence to them, "show the garments which Ellen Stewart made for them"; and many who would rise up and call her blessed" for the loving services rendered.

She was transferred to her heavenly home on Jan 24, 1924, and her body was laid to rest in the Cemetery at Concord Presbyterian Church, Woodward, S. C., where it

rests in the shadow of the church building in which she devotedly worshipped during her lifetime. Her grave is adjacent to that of her Aunt Betsy Lee. On Aunt Betsy Lee's tombstone are the following words: "Daughter of J. and J. Lee".

JOHN ALEXANDER STEWART

II.- John Alexander Stewart (familiarly known as "Jack", especially by his buddies in the army) came to Mississippi with his parents. When seventeen years of age he enlisted in the Confederate States Army. (See the Appendix, page 97 for his experiences in the war; and page 99 for certification). After the war he returned to Mississippi. He mrd (1st.) Jane C. Cook. I cannot find date of marriage. But the Winston County records in the Court House in Louisville, Miss., show that the marriage license was issued to them on Dec 21, 1866. She was b. in Winston County, in Feb 1838. They lived on a farm. They had three children, two of them twins, but all d. in infancy. Jane Cook Stewart d. Aug 24, 1869. She and the children are buried in the Cemetery at Bethsalem Presbyterian Church.

John Alexander Stewart, shortly after his wife passed away, returned to Woodward, S. C., his early boyhood home. He mrd. (2nd.) Mrs. Nancy Cathrine McBride Boney, Feb 6, 1872, in Woodward. The ceremony was performed by the Rev. Thomas W. Erwin, and witnessed by, R. C. Clowney and T. P. Mitchell. She was b. Mar 31, 1851. at Woodward. dau. of Elizabeth H. ---- and Rob-

ert McBride.

They lived at Woodward, where he was a merchant and farmer. He served as a Supervisor in Fairfield County for several years. He was a Past Master of the Winnsboro Masonic Lodge. He was ordained and installed a Deacon in the Concord Presbyterian Church, Woodward, S. C., in 1877, and served faithfully in this office. His wife d. Nov 1, 1921, and buried in Concord Cemetery. He retired and spent most of his time making short

He retired and spent most of his time making short visits with the children and others. He was at the home of his daughter Bessie (Mrs. T. E. Kell) in Tryon, N.C., and on Aug 9, 1926 he went to the Doctor for a checkup. While in the Doctor's office he d. of a heart attack. He was buried at Concord, beside his wife.

On his tombstone is this record: "Co. A., 13th. Miss. Regt., Barksdale Brigade. Wounded at Sharpsburg

and Gettysburg."

This item of interest should be recorded here. - A short time before Janie Lee was born Mr. Stewart employed Miss Elizabeth (Lizzie) Street, a maiden lady, to help Mrs. Stewart. She rendered such wonderful assistance that they kept her on in the home, and she helped with all the other babies. In fact, she lived out her life in the Stewart home. The children grew up calling her "Aunt Lizzie". One of them, Mary Sue (Sunie) was heard to say many times: "I have two mothers, my real mother, and "Aunt Lizzie", and I love them equally". After a rich and full life of helpfulness to others, "Aunt Lizzie" departed this life on Sept 23, 1914, being 78 years of age. She was buried in Concofd Cemetery. Her grave is close by those of Mr. and Mrs. Stewart, who loved her, and whom she loved and helped in life.







Fairfield District, May 16, 1853.

Dear Mother:

I take this present opportunity of writing you these few lines to let you know that we are all tolerable well at present, thanks be to the giver of all good for his mercies to us, hoping these few lines find you enjoying the same blessing. I wish to let you know that I have Ellen and John Alexander at school this year as it is the first chance I have had of a school close to me. I moved about twelve miles this year on account of getting them sent to school. With the help of God I will endeavor to bring them up in his fear as I think it is the duty of a parent to do so. It is my kendid opinion that any parent that neglects the training of their children it shall stand against them when we shall be called forth to give an account for the deeds done in the body. There is no one thing parents ought to be more diligent in than the training of their children for I think the precepts and the morals which are imbibed in the minds of children shall never depart from them as long as they live. They may go on in sin and folly for a long time but it will be a check to their conscience by times which is very often the means of calling them back from their evil ways and placing them in the paths of their duty. I have been blessed with a good fortune of my second partner as it is much harder getting a woman suitable to perform the duties of a stepmother and a mother of her own children. Elizabeth performs her duties as a woman of good understanding ought to do. It is with pleasure I look upon my little family as there is never a word of discord to be heard. When she speaks to any of them they never wait for a second bidding. She conducts her house with a grace which is an ornament to her sex. I wish to let you know that the reason I quit my trade was on account of my eyesight which has been greatly impaired for sometime back. I have nothing to blame for it but my own folly, my reading after hours which I used to do to a great extent, reading that which profited and satisfieth not. Not any of you need blame me for not writing to you. I have not received a letter

from any of you in a good many years. I have always been very attentive in writing to you as long as you answered my letters, and shall be glad to hear from you all as often as you write to me. I have nothing very particular to write you on account I am sending one to Brother Lilley at the same time. You will see the rates of our markets in his as I think it is not worth mentioning anything that is in his as you will see it all anyhow. I have to let you know that Brother Robert starts for Ireland on the 18th. instant. He will give you more news than I can put in this letter. Cousin James Hutchinson and family are well. James Giffin and family are well. They are living about three miles from where I am living. James McCarley and family are well. Alexander Stewart and family are well. I saw him about three weeks ago and he told me he would be up at my house last Sabbath but he did not come up. He is living about twelve miles from where I am living. The McCormicks are all well in general. Widow Dickey and family are well. I have very little more to write to you at this time. Give my love to Brother McBride and family and to Brother Lilley and family. Also to Brother Smiley and family, and to Aunt Hood, to cousins Hoods and families. Give our best respects to all our old friends and inquiring Neighbors. Elizabeth and the children join in sending their love to you. Write as soon as this comes to hand and let me know all particulars, and all the news you can gather up as I would like to see a good full letter from Ireland. I add no more but remain your son and daughter.

PS. I have to let you know that Brother Robert is not going out to Ireland at this time. I had not this letter more than fifteen minutes written when I heard the news. I thought I would let you know it on account that you would be uneasy when you would get the letter and he not come. I don't know when he will be for starting now. No more. Good bye.

Those who came to America landed in Charleston, S.C., and settled in Fairfield District for a while. Later they moved to Mississippi and settled in the Counties of Winston and Choctaw.

He put some seed from the Jimson Weed in the coffee he made. Mr. Hutshinson said he did not like the taste of the first cup, and drank the second cup thinking it would be better. Mr. Hudson did not drink his on account of the taste. Mr. Hutchinson became ill, and he walked home, almost blind. He lived only a week after he was poisoned. The Negro slave later confessed that he was trying to poison his master.)

James Lammey (1798-1854) mrd. Elizabeth Bradshaw (1784-1870). They were b., and reared, and mrd. in Ballymena, County Antrim, Ireland. Their children were b. in Ireland. They came to America and landed in Charleston, S. C. in 1842. They settled in Fairfield District. They later moved to Mississippi, and settled in Winston County, near Bethsalem Presbyterian Church. Mr. Lammey's trade was: Rope Maker. They are buried at Bethsalem.

Their Children: - Robert; Margaret; William Thomas, (1820-1902), mrd. Mrs. Margaret Herron Hanna (1823-1902), the widow of Samuel Hanna who d. in Ala.; John (1833-1866), never mrd.; Elizabeth, mrd. Patrick Mann John-ston(see the Johnston line); Mary Ann, mrd. Robert McElroy, in S. C.; James, never mrd., was in the Confederate States Army, and was killed in the Battle of Franklin, Tenn., Nov 27, 1864; Alexander(1834-1891), mrd. Anna Williams, lived in Weir, Miss., and is buried at Bethsalem-

The Children of William Thomas Lammey and Margaret Herron Hanna were: Margaret Bradshaw, b. Aug 13, 1859; and Dorothy (Dollie), b. Mar 9, 1862.

Alexander Kerr, b. in Ireland, came to S. C., in Fairfield District, and later moved to Mississippi, settling in Winston County. He mrd. Rebecca Gladney, who was b. in S. C. He died in 1891.

Dorothy (Dollie) Lammey, named for her Aunt Dorothy Herron, mrd. William Baxter Kerr, Dec. 1885. Lived in Winston County, near Bethsalem Church.

Their Children: - William Lammey, b. Sept 19, 1886; Alexander, b. oct 27, 1888; Uva Herron, b. Mar 13, 1894; Blanche Bradshaw, b. Sept 23, 1895.

Susan Herron, sister of Margaret, mrd. Archie Hanna, and they moved to Texas.

THE DUNBAR (MISSISSIPPI) CONNECTION

William John Dumbar (1828-1908) mrd. Dec. 15, 1852, Nancy Agnes Johnston (1834-1888). Both b. in County Antrim, Ire. Came to America and lived in Fairfield District, S. C. for several years. Came to Mississippi about 1855, and lived on a farm just north of, and within sight of, Bethsalem Presbyterian Church, in Choctaw County. (Mary Elizabeth Thompson now own the Dumbar Place). Mr. Dumbar's trade was: Shoe Maker, and it is said that he made only good ones. It is reported that in his younger years Mr. Dumbar was quite an expert at boxing, quite a man of the ring. He was naturally left-handed. It is said that his powerful and dangerous left hook sent many opponents to the floor or the ground, depending on where the match was being held. His boxing prowess was well-known throughout the surrounding community. The Children:- Margaret Ann Dumbar, b. 1853, mrd. Joel Frazier; Sarah Jane, b. 1855; James Robert Beard, b. 1858, went to Texas; William John, Jr., b. June 28, d. Aug 8, 1861; Mary Johnston, b. 1862, mrd. J.M.C. Johnston(see the Johnston connection); Mancy Marshall, b. 1865, mrd. Robert Stevenson; Susan Henry, b. 1868, mrd. William Stevenson; John Adam, b. 1871, never mrd., d. 1933; Cynthia Caroline, b. 1873, mrd. Mecklin Fairchild Stewart(see the Stewart line).

Mr. W. J. Dunbar had a brother, Henry A. Dunbar (1844-1868) who came to Miss. with him. Henry is buried at Bethsalem. He also had a sister, Mary Ann Dunbar, who came to Miss. with him. She later returned to S. C. She mrd. Stephen Fee in S. C. They came to Miss. shortly before 1900, for in that year they were received into Bethsalem Presbyterian Church on Certificate from the Cool Branch Baptist Church in S. C. (I think, maybe I shouldn't, but I think that William John Dunbar was a brother to Robert Dunbar, who mrd. Jane Stewart, but I have not yet found the official records to substantiate this as a fact. But, a grandson of William John told me that he remembers hearing his grandfather speak of having a brother named Robert in S. C. Robert's father was named Adam Dunbar. William John named one of his sons, John Adam Dunbar. It is possible that they were cousins and not brothers, so for the present do not quote me as saying that William John Dunbar and Robert Dunbar were brothers.— L.A.B.Jr.)

Mamie Beatrice Gordon; (brothers mrd. sisters); James Alexander, (1908-1926). The Stevensons were and are members of the Mt. Zion Presbyterian Church. Alvy and Russell are Ruling Elders.

WILLIAM JOHN DUNBAR LAND DEEDS

I think it historically interesting to record some of the land purchased by William John Dunbar when he came to Miss. as some names in the transactions are family connected. Russell Stevenson, his grandson, has the old deeds. I.- NE Qtr of SE Qtr of Section 32, and Wz of SW Qtr of Section 33 (except 10 acres out of the SW corner), T 16, R 11 E. Conveyed, Feb. 7, 1859, to William John Dunbar, by William A. Harvey, J. C. Harvey, and Jesse B. McGee. Witnessed by Thomas A. Reid, Justice of Peace of Winston County, Aug. 27, 1868. Recorded in Winston Co., Miss., Sept 8, 1868, John M. Turnipseed, Clerk of Probate Court. (The 10 acres excepted in the above had previously been conveyed to Bethsalem Presbyterian Church, Sept 21, 1840, by Samuel I. Harvey, for \$ 20.00).

II.- Robert D. Brown to William John Dunbar.

Et of NE Qtr, and SW Qtr of NE Qtr, and SE Qtr of Sec. 29, and Et of NE Qtr of Sec. 32, all in T 16 N, R 11 E. April 11, 1869. Recorded in Winston Co., Miss., May 24, 1869, James

R. Ellis, Clerk of Probate Court.

The previous history of that Ez of NE Qtr of Sec. 32, is in-

teresting, and it called for 80.65 acres.
On June 15, 1850 it was conveyed by deed to Robert D. Brown from William Brown. Witnessed by Thomas Gladney. Relinquishment signed by Elizabeth Brown, wife of William Brown. / Thomas Watt, Magistrate in Oktibbeha County. / Recorded Aug 2, 1850. How did William Brown get it? On Feb 27, 1841, it was conveyed to William Brown, of Pickens County, Ala., by the Columbus, Miss. Land Office, and the conveyance was signed by Martin Van Buren, President of the U.S.

The Browns were members of Bethsalem Presbyterian Church. They owned New Prospect Plantation, north east of Bethsalem, where they built the beautiful two and one half story house, which still stands, with some changes, by late owners. New Prospect was the Post Office location for the community for many years. The mail was carried by buggy from Louisville, via New Prospect, to Ackerman. Also, a company of soldiers from the community, in the Confederate States Army, was known by the name: The New Prospect Greys. John Weir was their Captain.

THE MCGEE CONNECTION

I secured a part of this information from Mrs. Josie Worthy Holman, widow of Dr. William Bruce Holman, who lives here in Louisville, Miss., and quite interested in genealogy.

John McGee mrd. Edna Fields. Both were b., and reared, and mrd. in Ireland, his ancestors having come from Scotland. He d. in the 1860's during the war. She d. about 1870. Both are buried in Louisville, in the old cemetery. No markers. Their Children were: Jesse Brown; James; Ann Eliza; Frances Rose; Mary; Caroline; Elizabeth Jane; Catherine; William M.; John; Sofie; and Margaret.

Jesse Brown McGee (1821-1885) mrd. (1st), Margaret Harvey. They lived in Starkville, Oktibbeha County, Miss., where he was a merchant. She d. there. Their Children:

His parents moved to Ackerman when he was three years of age, so Clyde grew up in the Choctaw Capital and has ever since made it his home. After attending the Ackerman Schools, he was married to Miss

Lucille Smith, daughter of the late Mr. and Mrs. Sam Smith. A fine son and daughter, Clyde Thomas McGee and Miss Mary Lou McGee, are the children of this marriage.

From 1916 to 1932, Mr. McGee was employed by The Gibson Grocery Company, with time out for 12 months overseas service in World War I. He was stationed near I-sur-Tille, France. From 1932 to 1936 he was deputy sheriff under Sheriffs Williams and Bradberry. On December 5, 1936, he opened The Volunteer State in Acceptage, which he is now operating.

You have created a more harmonious relationship within this office and with other organizations than had before been attained. We attribute this to your unusual responsiveness to human needs, tolerance, and considerateness.

Your many contributions to and active participation in community affairs has added so much to community relations and won you the respect of all who knew you. Particularly noteworthy is the esteem in which you are held by the youth of Herlong. We are very impressed by the example set by your personal conduct, honesty, integrity, sense of responsibility - and most of all, by your thoughtfulness and devoted Christian service.

Working for you and with you has been a distinct pleasure. extend our best wishes for continued success in your military career and throughout life.

FINANCE AND ACCOUNTING STAFF

(Uncle John Stewart, sometime after the war, took time to write down his experiences in the war. I felt that it would be interesting as part of the Stewart History. But due to the length of the paper, I took the liberty to condense it without doing violence to the continuity of his recollections.)

RECOLLECTIONS

On the 13th. of May, 1861, one hundred and one of Mississippi's boys and young men met at Louisville, Miss., to form a company to go and fight for their dear Southland. Mothers, fathers, friends and sweethearts were there to bid us good-bye, and send us away with our hearts full of courage and hope. Miss Lou Covington presented the Company with a beautiful flag to which Lieut. Edmunds replied.

Our Officers were: Capt. J. M. Bradley; First Lieut. Neville Edmunds; Second Lieut. James Hathorne; and Third Lieut. Joe Bradley. All were killed later in the war. There was only one married man in the Company, so we voted to send him home

to his wife.

After a two days march we arrived at Macon, Miss., where we became a part of the Winston Guards. We took the train there for Corinth, Miss., and became part of the 13th. Miss. Regiment, with William Barksdale, Colonel. After three weeks we went to Union City, Tenn., where we stayed two months. The health of the Company was so bad that we had to go to Jackson, Tenn. This was such a lovely place that the boys were filled with joy; but we were called out for dress parade and given orders to cook three days rations to go to Virginia. We arrived at Manassas in time for the battles.

The Yankees were so badly defeated that the roads would not hold them in retreat. Many Northern women had come out in their carriages to go with their men on what they thought would be a victorious march to Richmond; but they hastened back to Washington. We then went to Centerville where many of our boys died with the measles. The 13th., 17th., and 18th. Miss. Regiments, and the 8th. Virginia Regiment were united into a Brigade commanded by General Evans of South Carolina, and we went on a two days march to Leesburg, Va. We were the only soldiers at Leesburg, and were treated royally.

In our next battle at Ball's Bluff Gen. Evans gained a great victory by killing, drowning, and capturing many Yankees. At Leesburg the 8th. Virginia Regiment was transferred, and we were given the 21st. Miss. Regiment. After Ball's Bluff we were sent to join the regular army under Longstreet. We took part in the fight at Seven Pines, Seven Days Battle, Sharpsburg, and we were on the Maryland side when Jackson captured Harper's Ferry. Our business was to keep the Yankees

from getting away. We were in numerous skirmishes.

We went with Lee to Gettysburg and our corps was engaged in battle on the second day, my Brigade fighting in the peach orchard. After passing through the orchard I was wounded and left to be taken prisoner. But on the night of the retreat Ferguson's Cavalry came along and I got on a horse and rode out with them to the Potomac River. It was so high we would

have to wait there a week. However, my Lieut. was sick, so he and I "appropriated" a horse a piece and swam the river (another man rode with me) to the Virginia side where we were safe.

From Gettysburg Longstreets corps was sent to Chickamauga where we took part in the battle. It was here that a comrade, Davis, and I captured eleven privates and two commissioned officers. I feel sure these yankees were running out of the battle and were glad to be captured.

After Chickamauga LongStreets corps was sent to Knoxville. Here we surrounded Burnside's army. But he received strong

reenforcements and we were compelled to withdraw.

On the night of the 29th. of Nov., 1863, we were aroused about midnight and told to prepare to attack Fort Sanders just before daylight. My Regiment, the 13th. Miss., led the charge, supported by the 17th. Miss. They had stretched wire around the fort about knee high to trip us up. There was also a ditch between the wire and the fort. Many of our men fell and lost their lives, among them being Col. McElroy. Six of us were captured, and my Lieut. Col. O'Bryan. He was a brother-in-law to Brownlow.

That was my last battle. We were kept in jail in Knoxville for nine days. Then we left for Rock Island prison where I spent sixteen months. It was the 9th. or 10th. of Dec., 1863 when we left Knoxville. We had three days march over and around mountains to a station in Kentucky where we were put on a train. I have forgotten its name. On this march from Knoxville all we had to eat was corn on the cob. You could hear the boys snicker like a horse, and tell the guards to bring in the fodder.

One day we met a man in a wagon pulled by a very large yoke of oxen. His wagon was full of corn. He had to stop on the side so we could pass. We did not leave him an ear in

his wagon. The guards seemed to enjoy it.

Col. Casey had charge of us on our way to prison. He certainly was a fine man, and was kind to us. Getting on the train at the Kentucky station, we continued our journey on to Rock Island. The weather was very cold, and the nearer we got to our journey's end the colder the weather was.

Col. Johnson who commanded the Rock Island prison was very unkind and tyrannical. In the prison we were guarded by negroes, and many prisoners were shot down by negroes for no reason that was justifiable. I was told that when a negro shot a prisoner, he was promoted to a non-commissioned officer. In the prison we had barely enough food to keep alive. signed: John A. Stewart.

HOWARD THOMPSON'S VISIT IN IRELAND.

In 1913 Howard Thompson, while studying in Scotland, visited in Northern Ireland with some kinfolks. He took a picture of the tombstone marking the graves of the parents of James Stewart. On the tombstone is this inscription: "Erected to the Memory of John Stewart of Rosherry, and his wife, Mary Stewart". Dates of death and ages are given following each name. The Cemetery is a short distance, according to Howard, out of Ballymena, but he does not remember a place named Rosherry. His letter to me, LAB.Jr., has information which I think is of interest to the family, and so I will let him tell of his visit. He says:

I visited in the home of Mrs. Jane Cameron. She lived a short distance out from Ballymena on a farm with her son, Simon, if I remember correctly. Another son had migrated to America, and was living in Ohio. A third son, John, had become a rather well-known Doctor, (M.D.), in London. Later, before I returned to America, I had lunch with him one day in a down-town London Club of which he was a member. May I add that he wore his Prince Albert coat and silk hat. While at the table he remarked: "One year ago today William T. Stead (a rather famous churchman) was my guest in this Club. He went down on the Titanic, you will recall".

Simon, the farmer son with whom Cousin Jane Cameron lived, owned a thirty acre farm of which he was very proud. I told him my father was a farmer. When he asked about the size of our farm, and I told him several hundred acres, he seemingly could not quite grasp

it when his nice farm had only thirty acres.

Cousin Jane's family cooked on the open fire-place. While visiting in her home, it was my first and last opportunity to eat anything cooked on the old "pot-rack".

There were two of our cousins in charge of a school, apparently what we would term a Preparatory School, there

in Ballymena. Their names were Fullerton.

As soon as I made myself known to Cousin Jane Cameron, her first question was: "Are your grandparents both living?" I had to tell her that both of them had died. She said to me: "Your Grandma Stewart and I were

playmates when we were children".

Then Cousin Jane Cameron told me that Grandpa Stewart learned the Tailor Trade under the teaching of her father. Among several incidents she related was this one: "Your grandfather would sometimes say to me: 'Jane, I have a penny that is burning my pocket. Come and thread my needle for me'". She remembered threading his needle for him many times.

THE LIGHTER SIDE

(In this section I give some of the incidents in the lives of several members of the family. They were told to me by Alex (William Alexander Thompson). I have recorded them in a note book, under the title: "Alex Says", and I believe a sufficient number to weave into a good novel. May be, some day.-LAB, Jr.)

One year when the seasons were just right, with enough rain to keep the corn growing, it seemed that there would be a very large harvest. One day Mr. Byars met Uncle Scott(Robert Scott Stewart). The conversation got around to the crops, and Mr. Byars asked Uncle Scott: "Mr. Stewart, how is your corn prospect this year?" Uncle Scott replied: "I believe we will have a bumper crop- an overflowing corn crib". And then My. Byars said: "There is nothing like being bothered with a plenty".

I remember Papa(W. Y. Thompson) told me about an occurence in school one day when he was a boy. He said: We were having our spelling lesson. We always had to spell a word and then pronounce it. If it had more than one syllable, we would have to spell and pronounce by syllables, and then pronounce the whole word at the end. That day we had one-syllable words. One boy, when it came his turn, stood up and Teacher gave him the word: bed. He spelled: "b - e - d". Then he was supposed to pronounce it, but he just stood silent. Teacher said: pronounce it. But he was silent. Teacher told him again to pronounce it, but he was still silent. Teacher, thinking to help him by giving him a clue, said: "What did you sleep on last night?" The boy said: "a sheepskin".

One time Uncle John (John Alexander Stewart) had come out from South Carolina on whe of the several visits he made to Mississippi. He was staying in our home. We children always enjoyed his visits for he was a good teller of tales. He and Mr. Jim Mills were great friends having been together in the Confederate States Army. Mr. Mills heard that Uncle John was visiting in our home, and he asked Jess Ballard, about my age, to bring him to see Uncle John. They had a big time together. I remember that Uncle John told the following tale. He said:

One time two neighbor farmers decided to have a race to the corn mill. One of them would go straight through the woods, carrying his sack of corn on his shoulder. The other would go around the road on horse-back which was considerably farther. So they started. After some time the man on horse-back rode up to the mill. When he got down from his horse, took off his sack of corn and walked up to the millhouse goor, he saw that the man who went through the woods had already arrived. He had poured his corn in the half-bushel measure, and was lifting it up to pour it in the uh- uh- (Uncle John was hesitating as if he could not think of the word he wanted). Quick as a flash Mr. Jim Mills said: "hopper", thinking to help him. But quick as another flash Uncle John said: "All right, Jim, if you know the story better than I do, you go ahead and finish it". It tickled Jess Ballard so much he nearly fell out of his chair from laughing.

Each spring Mama(Elizabeth Peggy Brice Stewart Thompson) would make Howard and me some new pants before Easter. They were made out of heavy white duck cloth. She would send Papa to the woods to get the inner bark from certain oaks. She would boil the bark and make a brown dye to dye the pants. Aunt Genie did the same for Charlton and John. One March morning Papa was in the yard talking with Zuber(Negro who worked on the farm) and telling him of work which needed to be done. After a while Zuber said: "Mr. Thompson, Easter will soon be here, and that mean's spring". Papa asked: "Why are you so sure about it?" Zuber said: "Look down the road. Yonder comes James Charlton, wearing his new Easter pants, and that is a sure sign."

When I was a boy the men would gather at the church with their tools to clean off the cemetery. We boys always went along but we did more playing than working. I remember that at one of the workings Uncle Hut (Hutchinson McBride Stewart) and Cousin Charlie Youngblood (he married Cousin Dutch Moore's sister) got into an argument. Uncle Hut argued that the sun moved. Cousin Charlie argued that it did not. After a little while Uncle Hut said: "Charlie, don't you remember the record back in the Old Testament where God told the sun to stand still so that the Israelites could win the battle?" Cousin Charlie replied: "Oh yes Hut, I remember it, but there is not any record there of God telling the sun to start moving again".

Papa had the good habit of having family prayer every night after supper. In winter time we would gather in a semi-circle around the fire in the living room. Papa would read a chapter in the Bible, then all would kneel on the floor, each by his chair. Papa's prayers were not always short ones. One time when prayer was ended, Lyl, then about two years old, was standing by her chair instead of kneeling. Velma asked her why she got up before the prayer was ended. Lyl answered saying: "Because my knees was a huttin".

One Sunday at church some men were standing around talking. I remember Cousin Jack admired Mr. Lammey's shoes, and asked: "Mr. Lammey, did Uncle Dunbar(William John Dunbar) make those shoes for you?" (Mr Dunbar was the shoemaker in the community and he was a good one) "Yes, he did", replied Mr. Lammey. And Cousin Jack asked: "How long have you been wearing that pair?" "Jack, you make a guess", said Mr. Lammey. "Well, I would say about ten years", Cousin Jack guessed. Mr. Lammey said: "Jack, you missed it. I have been wearing these shoes twenty one years". You would have to know Mr. Lammey to understand this. He wore that particular pair of shoes only to church. Even on Sunday morning when he went out to hitch the horses to the carriage he wore his work shoes. When he drove home from church he pulled off his Sunday shoes before unhitching the horses from the carriage and putting them in the stables.

Grandpa(James Stewart) had a favorite expression. If he intended to address some one, he would begin it with, "See here;" One summer George McGee, a brother of Uncle Tom McGee, was working with Grandpa on his farm. There were lots of wild turkeys in the woods then. One day after eating dinner George asked Grandpa if he and the fellow working with him could go out and see if they could get a wild turkey. He gave them permission. They went, but evidently did not figure how fast the time could fly by. They went farther into the woods than they should have gone. Instead of being at the house to go back to work at one o'clock, they came in about an hour late. Grandpa met them and said: "See here, George, did you find any turkeys?" George replied: "No sir, we did not get a turkey, but we saw lots of turkey tracks." Grandpa said: "See here, George, no more turkey tracks during the lunch hour."

Uncle William (William Alexander Johnston) did not like for any one to get the better of him, and always had a good come-back. One summer Uncle Hut(Hutchinson McBride Stewart) had a fine flock of chickens. He was almost getting an egg a day from all the hens. Uncle Hut said to himself: "I am going to get William this time". Not long after he went to Uncle William's on some business. They were standing in the yard talking. He finally got around to it and said: "William, I have a fine flock of hens this year. I'm getting an egg a day from almost every one of them". Uncle William had a rail fence around his yard. At one point along the fence he had dug out some dirt so the hens could go under and out into the field. Going under they would have to bend their knees, partly squatting. Uncle William pointed to the hole under the fence and said: "Hut, what your hens are doing does not come close to mine. My hens go under that fence several times a day, and every time a hen squats to go under the fence she lays an egg." Uncle Hut said to himself: "Pshaw! William has done it again."

We were living at the old place (Later known as the Uncle Scott place). One Sunday morning Mama, with one or two of the older girls helping her, was preparing breakfast. The rest of us with Papa were sitting in the living room waiting for the call to breakfast. Several families in the community had been talking about moving to Texas. After a while, somewhat suddenly, as some would say, "out of a clear blue sky", Papa said: "Lets move to Texas". Just as suddenly Nellie, with a rather distressed look on her face, spoke up and said: Papa, are we going to move before we have breakfast?" Papa was so dumfounded by Nellie's question, combined with the woe-be-gone expression on her face, that, so far as I remember, he never again spoke of moving to Texas.
