THOMAS GENEALOGY

John Thomas, a native of England, moved his family to Ebenezer, Georgia in the 1750's. Ebenezer is "located some twenty-five miles up the Savannah River from Savannah Town, in St. Matthews Parish, and four miles below the present town of Springfield, Georgia. It had been settled by the Saltzburgers, German Lutherans who had fled from religious persecution in Europe. Their settlement contained a church and several schools, and many English settlers who were granted land in the Parish availed themselves of the schools and the ministers' services when the need arose." (Lower Richland Planters, p. 1, by Laura Jervey Hopkins)

According to the above book, in August 1755, he applied for a grant of 300 acres in Georgia at Buck Head Creek in St. George's Parish at a place called the "Horse Pond Springs." In his petition he stated that he had been "in the province seven months, not had land granted him and desirous to obtain land for cultivation, having a wife and five children."

According to the Georgia State Archives Colonial Records, Vol. VII, p. 463, in February 1757, he petitioned for 200 acres of land three miles above Mt. Pleasant. It stated that John Thomas Sr. had a wife and ten children, plus seven negroes. The Surveyor General's office has no record of the grant being issued, but this is not unusual for this time. It is also not listed in a plat book; however, a case of 1765 mentions the land of John Thomas as a boundary for another sale. Also in 1759 this land is mentioned in two other grants.

Since John Thomas Sr. mentions five children in 1755 and 10 children in 1757, Laura Jervey Hopkins speculates: "So it would seem that John Thomas, Sr., had left five of his children in England, and sent for them after he settled."

In March 1757, he was appointed Justice of the Peace and made an Esquire for the District of Ebenezer.

In September 1757, he applied for another grant of 100 acres of land adjoining Athanasius Thomas and John McCollum at Rooty Branch, about six miles below Mt. Pleasant.

I believe John Thomas Sr. could have had three brothers named Athanasius, David, and James who also applied for land at this same time. Athanasius applied for land near Mount Pleasant in 1757. (Anderson Thomas had a son also named Athanasius, indicating a close family connection.) Other Thomas grants were for James, St. Matthews Parish, in 1760, and David who applied for at least one grant with John Hopkins applying at the same time in 1759. David applied for a grant in May of 1759 (one slave) on the Savannah

River opposite Matthew's Bluff on the Carolina side. There was another John Thomas Jr. and Sr. operating further north on Briars Creek in St. George Parish, so it's a bit hard to tell if a Joanna Thomas and a Gilshot Thomas who also applied for grants in the Briars Creek district in 1759 were related to our John or the other John. Athanasius' child, a girl named Sarah, was baptized on the same day, 21 Mar. 1759, that Sarah Thomas (John Thomas, Sr.'s daughter) married John Hopkins at the Ebenezer Church. The child Sarah was born in SC in 1758; Sarah (John's daughter) was only about 14 at the time.

Around 1760 John Thomas Sr. and his children moved to St. Mark's Parish, SC.

Viz: Dennis, Doll, Jenny, Phyllis, Nanny, Daphne, and Peter. He also bought 3 feather beds and furniture, 1 bay horse with a sprig tail on 29 Nov. 1766 from John Thomas, Sr. Witness: Philipe Pearson and George Strother Proved by Geo. Strother before John Pearson, JP of Berkley and Craven Cos.

In Vol. NN, p. 187, there is a Deed of Gift. John Thomas, Jr. of St. Marks Parish, Craven Co., SC, deeded to:

Brother Matthew Anderson--a negro Dennis, girl Phillis.

Brother Matthew Anderson--a negro Dennis, girl Phillis, feather bed and furniture.

Brother James--negro girls Nanney, Daphney, and Doll, a feather bed and furniture.

Sister Cecelia--a negro woman and child (Jenne and Pear), a feather bed and furniture, and a bay horse branded 26 Mar. 1767

John Thomas' will abstracted in on next page. Note: In this will, John Thomas Jr. names John Thomas Sr. as one of his executors; however, John Thomas, Sr., did not qualify as an executor. So it would seem that he died before June, 1768.

SARAH THOMAS

2. Sarah married John Hopkins (1739-1775), on 21 Mar 1759 in Ebenezer, GA. According to Lower Richland Planters, p. 3, "Again in 1760, John applied for 200 acres of land settled and improved by his father-in-law, John Thomas, Sr., who had left the Province of Georgia and had given his son-in-law permission by letter to apply for grant of this land. The petition was granted. In May 1762, John Hopkins obtained another grant of 200 acres in St. George's Parish, which appears to be his last grant of land in Georgia."

I, Cecilia Thomas, of Craven County in the Province of South Carolina, being very Sick and weak of Body, but of perfect mind and memory Thanks be given unto Almighty God for the same and calling to mind the Uncertainty of this Transitory Life knowing that it is Appointed unto all Men once to die do make cons titute Ordain this my Last Will and Testament, and desire that it be received by all as such, Principally and first of all I give and recommend my Soul into the hands of God who gave it and as for my Body I recommend it to the Earth to be buried in a Christian like decent manner at the discretion of my Executors hereinafter named and as touching my worldly Estate wherewith it has pleased God to bless me with, I give desire and dispose of the same in manner and form following, that is to say, in the first, I give and bequeath unto my well beloved crother Mathew Anderson Thomas One Feather 3ed and Furniture and One Mare by the Name of Chickasaw To have and to hold for ever, and I Lend to my well beloved Mother, One Negroe Wench Named Ginne, and One Negroe Boy Named Peter and all my Stock of Cattle Hogs and Sheep during her Natural Life and after my Mothers decease the said Negroes and Stock with their increase to be equally divided between my two well beloved Brothers Mathew Anderson Thomas and James Thomas at the discretion of my executors hereinafter named, and I do Appoint Nominate Constitute my well beloved Brothers John Thomas Jun'r and John Hopkins my Lawful executors to cause all the above Testament punctually to be fulfilled above mentioned, and I do hereby Utterly disallow revoke and disannull all and every other former Wills Legacies dequeaths and Executors by me in any wise before this time. Named Willed and Bequeathed Ratifying and confirming this and no other to be my Last Will and Testament.

4. Mary married George? Strother, widowed early.

MATTHEW ANDERSON THOMAS

5. Matthew Anderson married Susannah Crosby, daughter of William Crosby and Mary Davis. There is some question if Susannah was a Crosby or not. In the book <u>Colvins and Allied Families</u>, it shows that Susannah Crosby (daughter of William Crosby and Mary Davis) married Capt. Anderson Thomas. Some think this was Anderson Thomas, Jr. William Crosby was born in 1755 in Berkeley County, and died in 1797 in Chester Co., SC. There is no date for birth of Susannah (Crosby) Thomas, but she and her brothers and sisters were born approximately 1781-1797.

Matthew Anderson Thomas was a Revolutionary War soldier. He served 481 days as a captain in the militia during 1778, 1779, and 1780 (Matthew, Philip, R7031); A.A. 1933; A.A. 7713A; N297 according to South Carolina Patriots in the American Revolution.

Hopkins in turn assigned it to Thos. Lehre with Jeremiah
Kingsley and Wm. Stakes at Wits. "Broad River, 28 May 1785"

"The State of SC to Philip Matthews to service done part under Capt. Anderson Thomas, Capt. Parrih, Comp. Col. Winn's Regiment at Congarees. etc. 25 days."

In 1785, Anderson Thomas was appointed Justice of the Peace of Chester County. (Book W, 24 March 278 Miscellaneous Records)

According to Anderson Thomas division deed after his death, he had land granted to him on 21 Jan. 1785. However, the

earliest record I found at the Chester County courthouse of a land grant to Anderson was Nov. 1787 for 200 acres on the Sandy River, originally granted to Edmond Franklin. There is another grant in Nov. 1790 for 490 acres, which he sold to Martin Elam in 1808. This land on Welches Fork of Sandy River bordered James Sharp's and John Daughtery's land, being a king's grant of 29 April 1768, recorded Book H, No.8, p.457, dated 4 July 1768, Sentry's office Book CCC.

At the SC Archives there were listed nine land grants to Anderson Thomas, the earliest in 1785, and the last in 1788. Index to SC Land Grants 1784-1800

In Dec. 1790, Anderson "of Fairfield County" bought from Martin Elam a negro woman named Sarah; two boys named Simon and Samuel; and two girls named Grace and Hannah.

In the 1790 Chester County Census, Anderson Thomas listed 2 adult white males, 5 males under 16 years, 6 white females, and 2 slaves.

In the 1800 Chester County Census, Anderson Thomas had 2 males under 10 years, 1 male between 26-45 years, and 1 male over 45. He had 4 females under 10 years, 2 females between 10-16 years, 2 females between 16-26 years, and 1 female over 45.

In 1815, there are three records of release in a Conveyor to Conveyee Book, 1785-1842 from Matthew Anderson Thomas to David Sims, Book X, pp. 5-7.

In Anderson's administration file is found a letter from his son John Thomas, dated 7 June 1815 from the Congarees, addressed to "Capt. Anderson Thomas, Sandy River, Chester District per my servant Peter on horseback."

"Dear Father, I send a letter enclosed which I wish you to take charge or and convey it to whom it directed with all the speed you can. Carry it yourself. The boy I send with those letters is to stay with you until further ordered. And I wish you to put him to work with your negroes, and for you to send Carrolina or some other negroe to work as you will see direction in the inclosed letter. You will please not neglect

this as it will be of much advantage to me. Should my father not be at home, Anderson or my sister Mary will convey the letter or carry it and deliver it through Silver. I should have come that way myself but being in so bad a state of health I was not able to ride that far. But you may expect me there in some twenty or thirty days. Hope these may find you and family in health. Mine is well. Please present my compliments to all my relations. I am with respect your son, John Thomas. P.S. Please seal the enclosed letter.

When Anderson died in 1816, (File 1032, Chester Co., SC), his estate was administered by Mary (Polly) Crosby, the widow of William Crosby (died 1807, intestate and young). She also had administered her husband's estate, and was the mother of Athanasius' wife. She was possibly Anderson's mother-in-law.

Through 1816 and 1817, the children of Anderson Thomas had to declare in court what they had that belonged to Anderson Thomas' estate. Then they had an estate sale.

At Anderson's estate sale, the following were heavy buyers: Mary Thomas, Ann Ryan, William Thomas. Other buyers: Burr Harrison, A. Cord, Robert Parks, Ferdinand Hopkins, Isham Goore, Col. Stokes, Thomas Shelton, Athanasius Thomas, William Lewis, Thomas Stokes, Thomas Beaver, Daniel Ryan, and John Fewell.

This is not a complete list. Some items were repeated and some items were illegible.

It also appears Anderson Thomas was a slave holder, and a cotton planter. At his death he had 300 lbs. of cotton seed. At his estate sale of 1817, the only slaves sold was a man Carolina and a woman Betty to Robert Parks.

In 1823, John Thomas paid the heirs of Capt. Anderson Thomas, listed below, 300 dollars for 100 acres on the Sandy River. Including himself, there were only 9 heirs listed. However, John Thomas' will and Martha Thomas' will both mention two other siblings: Mary Wilkes who died between 1836 and 1841, and Cecily Halsey, wife of John Halsey. The nine heirs were as follows:

John Thomas son of Matthew Anderson Thomas

John was a Captain. In the division deed signed 1 June 1823, Deed Book W, page 346 in Chester County, SC, John bought 100 acres of land on the Sandy River by the land of Sarah deGraffenreid and Henry Middleton and by the land belonging to Hall and Thomas Co., it being a part of a grant made 1 Jan. 1785 to Capt. Anderson Thomas, deceased.

John Thomas' will is in Mongomery Co., Ala., Will Book 2, Page 144. It was dated 11 April 1835, and probated 19 Oct. 1836. He left to his brother, Dr. Anderson Thomas, one fourth of his He left to his three nieces: Eleanor Maria Ann estate. Todd, Dorothy Martha Thomas Todd, and Nancy Anderson Byars Todd, one fourth of his estate, to be placed in the hands of their mother, Mrs. Eleanor Todd, to raise and educate them. The balance he left to his other beloved brothers and sisters: Athanatius Thomas; heirs of William Thomas, deceased with the exception of his nephew John Thomas; William Lewis; Mrs. Sarah Shelton; Mrs. Mary Wilks; Miss Martha Thomas; Mrs. Cecily Halsey; Ann Ryan. Witnesses: Stephen S. Garrett, John T. Pratt, and William Morris (Morris was William Lewis' son-in-Executors: Dr. Anderson Thomas, William Montgomery, Nathaniel Barnett.

Other information obtained at the Ala. State Archives: his estate records (Orphan Ct., Book B, p. 89, 22 Aug. 1838); \$25000 was spent for his tomb--there were no decimal points, so I couldn't ascertain the exact amount; According to records, he had 221 negroes, all listed by their first names only except two--Judy and Charlotte Lewis. As late as 1850, this administration was still in the courts.

Athanasius Thomas son of Matthew Anderson Thomas

Athanasius married _____ Crosby. It appears that on 6 Oct. 1814, Anderson Thomas paid substitute wages for Antha. Thomas his son in the service of the United States. I found in Fairfield County, Conveyor to Conveyee Book 1785-1842 this record: Antha. Thomas to George Perry (Release) Book HH, p. 169, 1827.

William Thomas son of Matthew Anderson Thomas

Prior to my research at Montgomery Co., Ala., Archives concerning the estates of John and Martha Thomas, I knew nothing about William. At the Archives, I learned that he died before 1835, and his heirs were as follows:

Ann Thomas daughter of Matthew Anderson Thomas

Ann married Dr. Daniel Ryan. After her husband's death in 1832, Ann moved her family to Calhoun Co., Ala. She died in 1865. There is an interesting discrepancy here. In my search for Thomas records in Montgomery county, I discovered Ann Ryan of Benton Co., Ala. appointed Daniel Ryan as her attorney in fact in regards to her inheritance from her uncle John Thomas. William Lewis, husband of Nancy Thomas, also made Daniel Ryan his attorney in 1843. Athanasius Thomas of Benton Co., Ala. also made Daniel Ryan is attorney. Possible this Daniel could be Ann Ryan's son.

Martha (Patsy) Thomas daughter of Matthew Anderson Thomas

5. Martha (Patsy) (20 Mar. 1811-15 Sept. 1853) married William Crosby (10 Mar. 1806-27 Aug. 1868) on 8 Oct. 1829. However, there is some doubt whether this is our relative. In John Thomas' will of Montgomery Co., Ala., in 1836, he lists an unmarried sister named Martha Thomas. Several years later Martha Thomas, unmarried, left her own will in Montgomery Co., Ala., on 29 Dec. 1841. After a list of Martha and William Crosby's children, I will continue with information about the Martha Thomas of Montgomery Co., Ala.

He remained on the farm with his youngest children Milton, Charlie, and Alma. After Mary's death, Ainsley married her sister Pauline Price. After her death, he lived around with his children-he had 4 daughters and ten sons.
- 5. Amanda Catherine Crosby, born 26 Apr. 1837, married Dr. James M. McCollum on 13 Dec. 1859. He died 22 Jan. 1923. Their children: Charles B. and James.
- 6. Charity Coleman Crosby (7 Mar. 1840-5 Mar. 1919) married Joel F. Rabb (1836-1863) on 14 Jan. 1858. Their children: Ida Cassandra (30 Oct. 1858-6 Oct. 1944), William Baxter (12 June 1860-18 Nov. 1940), and Joel Franklin (25 Oct. 1862-12 Mar. 1922). After her husband's death, Charity married John Abner Tetts. Children: John Arthur (1872-1936).

Martha Thomas of Montgomery Co., Ala., died on 29 Dec. 1841. (Orphan Ct. Book C, p. 460, 29 Dec. 1841)

Nancy Thomas daughter of Matthew Anderson Thomas

Nancy married William Lewis of Chester Co., SC on 15 July 1816. They were married by Francis Wilkes, Justice of the Peace near the double bridge on the Sandy River. According to her family Bible, she was born in June 1796 and she died after 1880 at Warren, Bradley County, Arkansas. They had two children: Anderson Thomas Lewis and Eleanor Lewis Morris, born on 13 Nov. 1818.

When Nancy's husband died in 1846, he left his wife the home, household furniture, land, "as much provisions and stock as she may need to keep up the plantation," slaves Silva, Pomp, Sam, and Lige, and "all the properties and money that may be coming to me as legatee from the estates of John and Martha Thomas."

Anderson Thomas, Jr. son of Matthew Anderson Thomas

Anderson Jr. (1779-_____) left a widow Mary (Polly) who later married Francis Wilks, his second wife. Anderson Jr. died sometime before his father died in 1816.

Apparently there is a discrepancy here. In John Thomas' will of 1835, he left his brother one fourth of his estate. Dr. Anderson Thomas was also his executor, along with William Montgomery and Nathaniel Barnett. Mary Wilks is listed as a sister.

Eleanor Thomas daughter of Matthew Anderson Thomas

Eleanor married Robert Todd. According to their uncle John Thomas' will, probated 19 Oct. 1836 in Montgomery Co., Ala., Eleanor, of Coosa Co., Ala., was widowed. John Thomas left her three daughters a fourth part of his estate to be placed in Eleanor's hands to raise and educate them. Her daughters:

Eleanor Maria Ann Todd, married 1. John R. Pratt (died July 1844) 2. John L. Flowers on May 1846 (Flowers died Dec. 1846) John $\underline{\mathbf{T}}$. Pratt was a witness to John Thomas' will, and John $\underline{\mathbf{F}}$. Pratt was the administrator of Martha Thomas' will in 1841.

- 6. James married Susannah Mabry, daughter of Ephraim and Mary Mabry of Fairfield County. He lived for a few years in Georgia near Ebenezer before moving with his father to the Congarees and establishing his family in Fairfield Co. SC in the corner near both Union and Chester counties. He served as Sgt. and Capt. in the Revolution both before and after the siege of Charlestown. (See a record of his claim in his brother Matthew Anderson Thomas' section.) In the Census of 1790, 6 slaves were listed. James died on 13 May 1790, and his father-in-law was the administrator of his estate along with Anderson Thomas, his brother. (File 7-214 in Fairfield Co.) His estate was administered in Fairfield County, but he had moved into Union County shortly before his death. Their children:
 - 1. Mabry Thomas (22 Sept. 1770-18 Jun. 1841) married Ursula Crosby. Her parents were Richard and Rhoda (Bond) Crosby. They moved to Conecuh Co., Ala. in 1816 with several others from Chester County, SC., including her brother Chesley. Both he and Ursula are buried in the Thomas Cemetery in that county. Their children:
 - 1. Susan Hobson Thomas (1810-1881) married Calloway Stallworth. She is buried in the Evergreen City Cemetery.
 - 2. Frances Elizabeth Thomas married Joshua King Hawthorne. She is buried in the Belleville Baptist Church Cemetery in Alabama.
 - 3. Mary Ann Amanda Thomas married William Adam Ashley
 - 4. John Anderson Thomas married Rebecca Elizabeth Kennedy
 - 2. Sarah Thomas (1777-___) married Allen deGraffenreid (18 Sept. 1764-7 Jan. 1821). According to A Goodly Heritage-History of Chester County, SC compiled by Anne "The 70: DeGraffenreid P. Collins, on p. family...intermarried with the Thomas and Blewett families of Chester, both of whom owned over a hundred The DeGraffenreid property in West slaves in 1830. Chester was referred to as the Baron's Estate... The house site and family burial ground, with elaborate marble memorials, is now only a pile of rubble on Fish Dam Road."

His wife was not listed in this division. Their children:

 - 2. Mabry Thomas (1817-12 May 1881) married Louisa Elizabeth Humphries. His estate was administered by James Munro on 16 Nov. 1881 in Union County. His heirs were listed as Elizabeth Thomas, Susanna Thomas, Cecilia Thomas, Marion Thomas, and Milton Thomas.
 - 3. John Pulaski Thomas (Dr.) (6 Feb. 1818-1900) married Emmaline Frances Kelley.
 - 4. Capt. James Thomas (3 Mar. 1819-14 Dec. 1879) married Frances Gilliam.
 - 5. Susannah Thomas (1820-after 1881) married James J. Thomas. (See John P. Thomas children)
