

ARTICLE III.

SECTION 1. Those women entitled to membership are the widows, wives, mothers, sisters, nieces, and lineal descendants of such men as served honorably in the Confederate Army, Navy and Civil Service, or of those persons who loyally gave material aid to the cause. Also women and their lineal descendants, wherever living, who can give proof of personal service and loyal aid to the Southern cause during the war.
