 to be my last will and Testament revoking
 all others.

 and bequeath the following property viz -
 the sum of six hundred and twenty
 five dollars instead of any interest in
 my tract of land. Also a negro man
 named Survey which William Porter now
 has in his possession. a negro man

named Reubin and another named Abraham also a negro woman named Patsy and her two children Charles and Mary together with her increase if any. all to her and her heirs forever.

To my daughter Mildred Tidwell, I give and bequeath the following property vis my tract of land on which I now live containing one hundred and twenty five acres more or less also a negro man named Evans now in the possession of Richard Tidwell. also my old man Robert and my yellow woman Temperance and her three children a girl named Katherine also one named Angeline and a boy named David together with their increase in any at all. To her and her heirs forever.

All my other property of every description vis my stock of horses, cattle hogs, sheep household and kitchen furniture all my farming utensils and together with what money may be on hand after all my debts and specified bequests are paid off together with all the debts that may be owing to me whether in notes or accounts my will is shall be divided into two equal lots by my three friends and neighbours Joseph Bellapont Elisha Uzell and merit H Booker for the benefit of my two daughters and their heirs. which two lots shall be drawn for by them so as to make each child as equal as can be should either of the above named persons die before the division of my property. my will is that my Executors appoint another or others

in their place.
