The following is a list of family members mentioned in the will of John Wilson, Jr.:

Rebechah, his wife. First person mentioned in the will, he made sure that she would be taken care of properly.

James Wilson, son. 237 acres of farmland (formerly belonging to Richard Taylor).

Theophilus Wilson, son. 100 acres of land lying on Rice Creek, a grist mill, 50 acres of "Sawyer's Tract" on the North side of Bear Creek adjoining the testator's "Old Tract", 200 acres of land originally granted to James Freeman, 100 acres of land formerly granted to **Lewis Perry**, etc.

Jesse Wilson, son. Five shillings sterling.

Nancy Mitchel, daughter. 60 pounds sterling, to be invested.

Susannah Rush, daughter. miscellaneous movable property.

Martha Norris, daughter.

[John] "Jack" Wilson, son. Five shillings sterling.

William Wilson, grandson all of Sawyer's Tract, excluding the 50 acres granted to uncle Theophilus.

James Wilson, grandson (a minor). The plantation house and surrounding property, after his grandmother's decease, 221 acres of land originally granted to the testator lying on Roundtop Branch, and a horse. If he dies without heir, his portion to be divided equally between the following four heirs:

John Norris, **grandson**. 100 acres of land lying on Roundtop Branch that was formerly the property of Samuel [D]ipper.

Mary Laughon [aka Lauhon or Lawhorn], daughter. One slave.

William Wilson, son. Five shillings sterling.

Nancy Mitchel, daughter. In addition to the 60 pounds already mentioned she is to receive the sum total resulting from the sale of all of his remaining goods, movables, and livestock -- to be divided equally with the following four additional heirs:

- . James Wilson [son, probably]
- · Theophilus Wilson, son
- · Samuel Lawhon [aka Lawhorn or Lauhon], son-in-law
- John Rush, son-in-law

Executors were James Wilson (son), Theophilus Wilson, and Samuel Langhon [Lauhon, Lawhorn].
