i William Winn's second wife was Rosa Hampton of Fairfax County, Va., daughter of John Hampton and Margaret Wade

La. has joined the D.A.R. on William Winn's service to the

(26) I have observed no official reference which would certainly identify his military record. (27)

RICHARD WINN, youngest son of Minor Winn and Margaret O'Connor, moved to the Camden District of South Carolina from Fauquier County. Va. about 1765, while still a minor, accompanying his older brother, John. He was born in 1750 (officiel records show him to have been 25 years of age when first commissioned in 1775) probably in Fauquier County. He was commissioned First Lieut., 3rd S. C. Rangers June 17, 1775; subsequently served as Major and Colonel, S. C. Militia, and finally reaching the rank of Brig. General of Militia, succeeding General Sumtor. He was wounded in the battle of Hanging Rock Aug. 6, 1780 (Historical Register of Officers' of the Continental Army, 1775-83, by Heitman). He is said to have been exceptionally well educated and before entering. the army was employed in surveying in the Province. He led a very active military life, taking part in expeditions in Florida and in Georgia and in fights against the British at Hanging Rock, Fishor's Ford, Blackshoar, and other points in South Carolina. For interesting details of his valuable services see History of Orangoburg County, S.C., by Salley; Colonial and Revolutionary History of Upper South Carolina, by Landrum; Southern History Association Magazine, June 1898; Mill's History of S.C; the S.C. Historical and Genealogica Mag. Oct. 1904, p. 261-2 and Jan. 1905, p. 42. Ho owned large tracts of land in the Camdon District, chiefly in what is now Fairfield

cated land of Tories. He joined his brother, John, in donating land for the establishment of the town of Winnsboro and was active in the Mount Zion Society and other public services. He represented South Carolina in Congress from 1793 to 1802 and again a few years later, for he is said to have voted with Calhoun, his colleague, for the War of 1812. He is said to have been appointed U. S. Superintendent Indian Affairs (Creek Nation) in 1788. The following quotation is from Dr. J.L.M. Curry's account (Draper MSS 13VV133):

"Richard Winn was the brother of John, and the youngest of five sons. He was not quite twenty years old when he emigrated from Va. to So.Ca. In Johnson's Traditions of the Southern For, you will find a partial account of his sufferings and services.....

"Richard had a good English education, superior to what young men, at that day, as a general rule possessed. He was fond of scientific pursuits and kept himself familiar with improvements and discoveries. He knew nothing of Latin & Greek but was fond of mathematics and was an excellent surveyor. His first employment in So. Ca. was by a company of wealthy Englishmen who engaged him to survey and locate lands for them, giving him every eighth tract for his services. Thus, before the Revolution, he became a large land-owner. He was a Justice of the Peace and held the office until he joined the Continental Army.

"Many of his noighbors took British protection, but he was too good a patriot to accept such a course. He and his brother, John, were special objects of Tory malignity and suffered much loss of property. The Tories plundered and burnt Richard's home, which, by the way, was occupied by Cornwallis as his Headquarters, carried off his stock and his negroes, which were never returned. His wife, whose maiden name was Prescilla Mc Kinney (her brother who married Anna Winn, the sister (?) of John and Richard, was a Lieut. in Morgan's Rifle Brigade), and three little children were driven away and might have starved but for the kindness of a neighbor who had them cared for until Richard, the husband and father, then confined in consequence of a pevero wound.

he had received at Hanging Rock, could make provision for them. During the War he went up from Lieutenant to Colonel. Afterwards, by the South Carolina legislature, when war was over, he was elected as Brigadier General and then Major General.

"He accumulated a large property, much of which was sold to pay the debts of his neighbors for whom, in his

credulity and kindness, he had become security.

"He was of calm temper, attached to his friends, accurate in business, wrote with ease and strength, but was not a public speaker. He was neat in dress, interesting in conversation, moral in character, and despised what was mean and vulgar. Profane language never escaped his lips. He was modest and respectful and kind and very popular. He served several sessions in the Legislature and afterwards represented his district in the Congress of the United States. He became a member during General Washington's administration and served until after the War of 1812 was declared. In the War session he was a colleague of Mr. Calhoun and gave the war his ardent support. During his last term of service he removed to Tennessee and served a portion of his term after the removal of his family. He regretted he could not continue in Congress to aid in providing ways & means for the successful prosecution of the war.

"I am sorry my facts are so meagre but they are reliable and were gathered with considerable labor...."

The old Richard Winn place in Winnsbero consisted of 50 acres, a part of an original 300 acre tract granted to John Winn. The original house was one and a half stories. The second house was built near the site of the old one - probably by General Winn - and had all the rooms on one side (left) of a great twelve foot hall, rooms 22 feet square, and it appears to have been the plan to duplicate these rooms of the right side of the hall. The third house, the present one, is evened and occupied by Mrs. Thomas Ketchen. It is situated on rising ground about three city blocks from the center of town on the west side of the highway running north. There is a large sloping lawn in front and to the

south side, containing many fine old cedars and a few remaining large pines, many of the latter having died in recent years. Beyond the highway and railroad tracks one can see, behind a grove of trees, Mount Lion School, the site for which was donated by General Winn.

Richard was a member of the Jockey Club of South Carolina, said to be the oldest club in America, and owned many fine race horses. The following is quoted from Pearson's manuscript:

"Gen: Winn had the usual weakness of putting his hand to paper as security, and as is usual, generally had the money to pay. Between 1795 and 1810, he paid security debts to the amount of \$50,000. In his long absences from home his overseers did what was good in their own eyes - that is, never to consult the good of their employer. His plantation was unproductive of profits and his circumstances were not prosperous. He sold his lands to good advantage, removed with an aching heart from his ancient seat and a country he loved to a body of land he owned on Duck River, Tenn. (Maury County). Hero, after some years, in the depths of solitude and among strangers, he breathed his last at a good old age. He was upwards of six feet in height and indifferently well-formed. His countenance was noble and majestic, and beamed with the warmth of benevolonce and kindness. His port was noble and his mannors dignified and elegant."

General Winn moved to Tennessee in 1814 and died Dec. 19, 1818 in Maury County, possessed 2500 acres and 40 slaves.

One report states that his grave lies in a thicket of briars in Williamsport, Tenn; another that he was buried in Columbia, Tenn. A recent researcher reports that the Maury County records show that he was buried in Columbia; that the Government sent an inscribed tembstone to mark his grave, but that the stone was deposited in the Court House cellar to await a

convenient time for setting it up; that when the citizens felt that the time had arrived for erecting the marker with appropriate ceremonies, the stone could not be found. The county records contain his will but I have not seen a copy of it.

The U. S. Census of 1790 lists him as having in his family two free whites above the age of 16 years, five below the age of 16 years, three white females including heads of families, and 30 slaves.

I read in an article published in the Winnsboro "News and Herald" the statement that "General Winn's family was not considered smart. Mrs. Winn's maiden name was Blocker, an Edgefield family. One of the daughters caused some merriment among her young lady acquaintances who asked her where she got her fine shell comb she was wearing, by replying that 'her father bought it in Congress.'" (Ederington's History). The author must have been confused in his families as I have seen no other mention of Richard Winn having married a Blocker.

All of Richard Winn's children, except Samuel and Thomas, are said to have died prior to 1858. Richard married Precilla McKinney. Their children were:

I know that my redeemer liveth and that he shall stand at the latter day upon the earth and that after my skin worms destroy this body, yet in my flesh shall I see God. Job XIX, 25, 26. This marble is erected by David Read Evans in mournful testimony of his affection and respect to the memory of his amiable and beloved wife, Margaret Evans.

I saw him afterwards and asked him whether he received my relinquishment as a payment. He said Yes and repeated he never meant to charge me for any service he had done, nor for any I might require of him as a physician. I don't know how to reconcile this declaration with his conduct; that land, and indeed any land so near the town, is worth \$10 per acre, and he sold to Cathcart at that. Now at the assessment that you say is the nub in this business it would amount to about \$100 with about 30 dollars for schooling, which makes I think a protty good nothing..... the Dr. will give his services but never part with money if he can help it. I would not for the world offend the old man for in sickness we would sadly miss his services."

No effort has been mede to solve the connection between the various lines of kinns in Virginia with the Fauquier County family. They doubtless originated from the same Welsh stem.
