

N. J., and then lived in Hardiston Twp., Sussex Co., N. J. He enlisted in Sussex Co., N. J., May, 1777, orderly Sgt. was John Hazen; served 1 mo. under Gen. Wynes.

Sept., 1777, he served 1 mo. under Capt. James Edsall; served 2 tours of 1 mo. each under Capt. Thomas Hill. *Gasper Rarick* served with him under Capt. Hill. Served several short tours under Capts. Hill and Wm. Johnston. He was at the Delaware when *Joseph Jobs* & others were killed by Indians. Noah d. Aug. 10, 1837.

Elizabeth Talmadge, widow of Noah (W. 207; Cert. 10,903, issued May 3, 1850, at \$20.00 per an. from Mch. 4, 1836; N. J. service, Pvt.) Elizabeth applies Sept. 28, 1848, 76 yrs. old on June 18, 1848 (1772) & then lived at Sparta, Sussex Co., N. J. She m. Noah Feb. 11, 1790, by Thos. Van Kirk, J. P. Bible record says: "Feb. 11, 1790, Noah Talmadge and Elizabeth Chamberlain (the 18th June following she was 18 yrs. of age.)"

Affidavit from David S. Talmadge Sept. 20, 1849, of Sparta, N. J., giving above parents & his birth as in 1790. (No further family data on file).

West, Hezekiah (S 34,519; Cert. 13,411, issued July 18, 1833, at \$24.17 per an. from Mch. 4, 1831; Ill. Agcy.; S. C. service, Inf. & Cav., Pvt.) applied for pension Dec. 3, 1832, from Johnson Co., Ill. He was the only son of John West and was b. in Frederick Co., Md., in 1763; age 7 the family moved to Sandy River, Camden Dist., S. C., later called Chester; there attended school under Joseph Coyle and *Daniel Stringer*. In 1777 he was taken from school as said Stringer was "listed" into the service of the U. S. in a Co. of Grenadiers & his father, *John West*, was also listed in the U. S. service in a Co. of Mounted Rangers under *Capt. Richard Winn*, Col. Thompson's Regt. These Rangers mounted, armed & equipped themselves. His father served 14 mos. & was killed in engagement at St. Tibbes.

Hezekiah West volunteered in 1780 & served 1 mo. as priv. in Capt. Frost's Co. of Mounted Rangers, Col. Winn's Regt.; in 1781 he served 3 mos. in Capt. Robert Frosts' Co. of Foot; in 1782 he served 3 mos. in Capt. John McCool's Co. of Mounted Rangers, Col. David Hopkin's Regt.

Since the Rev. War he has lived in Camden Dist., S. C.: in 1804 he moved to Ky. & remained there 2 yrs., since resided in Johnson Co., Ill. Died in latter July 29, 1845.

Jan. 2, 1837, *William Garrard* declares he and Hezekiah West served part of a tour together in the Rev. War under Capt. McCord on Santee River, S. C.; at that time the military drafts were considered to be 3 mos. (No further family data on file). (To be continued).
