Spouse: Elizabeth Minor (b: ca. 1653, Stonington, New London, Connecticut), daughter of Thomas Miner and Grace Viola Palmer Married: About 1668
- 2 – Minor Winn, I (b: ca. 1665, Westmoreland Co, VA d: ca. 1730, Eden Plantation)
Spouse: Martha Anne Byrd (b: ca. 1663, Middlesex Co, VA d: ca. 1748, Prince William Co, VA)
Daughter of: William Byrd (b: ca. 1652, London, England) & Mary Horsmanden (b: ca. 1652, Lenham Parish, Kent, England). Established Eden Plantation, Prince William Co.
Married Minor Winn, II: 12 May 1678 in Prince William County, Virginia
- 3 – Minor Winn, II (b: ca. 1704 d: 23 Mar 1778, Old House, Rock Hill, Warrenton, Fauquier, VA)
Spouse: Elizabeth Margaret O'Connor (b: 1705, Essex Co, VA d: 1787, Fauquier Co, VA)
Daughter of: James Conner and Margaret Butler
Married: 1723, Fauquier County, VA (**See Appendix I, Minor Winn II**)
- 4 – **Colonel John Winn, Sr.** (b: ca. 1727/1732, Fauquier Co, VA d: 16 Jul 1814, Rutherford Co, TN)
Buried in: Rutherford County, Tennessee, Some sources say he died in Jefferson Co, MS
1st Spouse: Dorothea Wright (b: 1743, Alexandria, Prince William Co, VA d: 10 Dec 1780) Winnsboro, Fairfield County, South Carolina) [said to be cousin of George Washington]
Married: 17 Aug 1758, Alexandria, VA. (**See Appendix II, Colonel John Winn**)
Daughter of: Francis Wright and Ann Massey
2nd Spouse: Penelope Kirkland (b: 1761, Camden, SC) Married: 12 Aug 1782, Winnsboro, SC
Revolutionary War: John Winn, Sr. was a Colonel in Fairfield County, South Carolina. John Winn, Sr., along with nephew Minor Winn, attempted to shoot Lord Cornwallis. They were arrested, tried, and sentenced to death. They were pardoned.

Revolutionary War: As a very young man, was in Regiment, Fairfield County, South Carolina
Spouse: Elizabeth Evans (b: ca. 1770), daughter of David and Mary Evans
Married: August 23, 1790 in Winnsboro, Fairfield County, South Carolina
Other: Sheriff of Fairfield County, South Carolina, during the years 1792 to 1795

Married: 20 August 1809, Fairfield County, South Carolina
- 7 – Thomas Micajah PICKETT, SR. (b: ca. 1830 LA or MS d: 22 Jul 1864, Atlanta, GA)
Spouse: Martha Harriet Mobley Bennett (b: 6 Aug 1842, Franklin Co, MS d: 19 Jun 1917, Franklin Co, MS)
Married: 31 Jan 1861, Meadville, Mississippi

12 – Larry Arnold HOWARD (b: 4 Apr 1948, Port Arthur, Jefferson Co, TX)

Spouse: Jean Ann BEACH (b: 19 Oct 1948, Port Arthur, Jefferson Co, TX)

Larry Arnold Howard's 6th great-grandfather was Colonel John Winn, Sr. (b: ca. 1727, Fauquier Co, VA d: 16 Jul 1814, Jefferson Co, MS). Colonel John Winn, Sr. and his son, Minor Winn, attempted to ambush and kill General Cornwallis, the British Commander of the Southern British Command. General Cornwallis was camped in Winnsboro, Fairfield County, South Carolina, at the time. Colonel John Winn and his son, Minor Winn, were tried, convicted and sentenced to hang. General Richard Winn (Colonel John Winn's brother) sent a messenger to Cornwallis informing him that if he carried out the sentence to hang his brother and nephew, he (General Winn) would hang the first 100 British officers that he captured. Fortunately for Larry Arnold Howard, they were pardoned by General Cornwallis.
