Dear Tommie, Shiela, Stewart, Jodi, et alia:

Stewart, Jodi and I descend from Thomas Woodward (Regulator) and his first wife Jemima Collins and I attach here a chart that I perhaps got from Jodi showing our lineage. I come from his son John and his marriage to Esther McDonald (their daughter Mary Ann Collins Woodward married Maj. Thomas Lyles, etc.). Stewart's line is from his son Rev. William Woodward and Nancy (Nanya?) Barrette (see attached). Of course you know that TW's second wife was Elizabeth Stokes (later married Benj. May), who was of mixed Native American blood, and this was the lineage for Thos. Simpson Woodward.

Theresa Hicks (<u>SC Indian Traders, Indians, and other Ethnic Connections</u>) says that Elizabeth Stokes's grandfather was a Silvester (Silves) whose eldest daughter married Thomas Stokes, an Indian Trader. Val Green tells me that the Stokes were a known early family in the coastal settlement area of Georgetown (Winyah) and that Thomas Stokes was from there. The Silves name suggests that the Native American family may have had a progenitor who came in with DeSoto, possibly a Sephardic Jew.

I am attaching Gary Woodward's work which he sent me some time ago. I hope he will read and add to this correspondence loop.

The genealogy volunteers here often get requests for information on the African American Woodwards whose descendants are also here in Fairfield County. A study of colonial period Woodwards in this area suggest that not only Thomas Woodward's direct line was here, but also perhaps cousins who came in at various times from Virginia. It is difficult to find where the black and white lines may have connected, be it by blood or association. I have not tried to unravel the Woodwards here but am attaching various files which show some lines.

I recently helped the University of SC digitize an unpublished manuscript about families settling "north of the Broad River" in Fairfield and Richland County. It is searchable and there is a good deal on our Woodwards at http://library.sc.edu/digital/collections/northbroad.html.

I assume your Mary slave ancestress was African American and not Creek. Your DNA finding is not unusual these days, as more and more people are making such discoveries. Our Lyles family

has connected through DNA and family records to the descendants of a slave and my great great uncle in the mid 1800s.

I will copy your letters below with information to insert into our Woodward family files. I would appreciate your including me in further information sharing!

Hello, Stewart:

How nice to hear from a descendent of my gggggrandfather, "Thomas the Regulator" Woodward. His grandson (and my gggrandfather General Thomas Simpson Woodward), left behind letters that were compiled and published as "Woodward's Reminiscences." This book is a treasure trove of information on TSW and the Creek Indians with whom he associated for many years. Today, TSW's descendants all stem from his liaison with his slave mistress, Mary. They had three children together, two sons and one daughter, and

we descend from one of the sons, Alfred. Our DNA test confirmed what we always knew, but couldn't otherwise prove.

We have connected with a number of descendents from the other son and daughter and are sharing information, pictures, etc. We have also received assistance from an historian in Louisiana and a researcher/author, Don Marler, who republished the "Reminiscences" and added more up-to-date information on the General. Some of the daughter's descendants have a problem with how their ancestress came into the world, so their denial keeps them apart from the rest of us. Southern practices have done that to untold numbers of families, unfortunately.

What, exactly, do you want to know about our distant relationship? I note that through female ancestors you have had to make quite a leap to reach the Woodward line. Have you taken the "Family Finder" DNA test? We've done so, but the "fourth cousins" listed cannot find a paper trail to a relationship. The test did confirm that my two first cousins, who also took the test, are, in fact, my first cousins. Not much help, but a confirmation of sorts as to their accuracy.
