All the Woodwards in America were originally from England. William Woodward of London sent three sons to Maryland. They were Abraham, William, and Henry. Abraham, gentleman of Annapolis, Maryland, was born in 1686 in England and died there before the last of March 1744. He came to America and settled in Annapolis in 1738. He married July 11, 1707, Elizabeth Finloe, daughter of James Finloe; he married the second time on August 25, 1717, Priscilla (Ruley) Orrick, daughter of Anthony Ruley, gentleman, and Rebecca, his wife of Anne Arundel County, Maryland, a widow of James Orrick. Abraham Woodward's children by his second wife Priscilla Orrick Woodward were:

1. William b. Dec. 6, 1716; d. 1790
2. Rebecca b. Jan. 15, 1722
3. Martha b. Dec. 8, 1726
4. Abraham b. Jan 5, 1729
5. Thomas married Mrs. Margaret Watters Izams, who died leaving no children. Thomas then went to Fairfax County, Virginia, and married Elizabeth Simpson, the mother of Thomas. This Thomas came to South Carolina after the French-Indian Wars, probably 1760 or 1758.
6. Priscilla married William Farris
7. Mary married ---Ridgely
8. Henry
9. Elizabeth d. 1758 unmarried
10. Eleanor

NOTE: Please note that the information from Prince William Co., Va. shows that the mother of Thomas (Regulator) Woodward was named Mary Simpson NOT Elizabeth Simpson. Also Margaret Izams did have a son... (Nicholas)..Note Thomas Woodward & Margaret Izams m. 1778 & comparing this with death date of Regulator makes this Thomas impossible to be the father of the Regulator.....

MARY SIMPSON, mother of the Regulator, is believed to have been married to a John Woodward, 2nd m. John Robertson.
