**Subject:** Yongue Genealogy

Attention: Eddie

I am John Daniel Yongue. My Father was Henry Lee Yongue. My grandfather was Neil Malone Yongue. They are buried in Fort Lawn, SC

We never knew much more than my great-great grandfather was John Lee Yongue and his wife was Annie Elizabeth Goza Yongue. Recently, through [ancestry.com](http://ancestry.com), we have discovered that John Lee Yongue is buried in Evergreen Cemetery in Chester. (I have not seen the tombstones, but have seen pictures)

Having said all that, my problem is trying to "see" the tombstones of prior descendants.

The genealogy I have seen and assume is correct is as follows:

Hugh Yongue I was born in Belfast Ireland and married Agnes Sittlington. At some time they were in Larne, Antrim County, Ireland. Eventually, they died and were buried in Augusta County, Virginia.

They had Hugh Yongue II in Larne, Ireland on 1 March 1732. Hugh Yongue II married Margaret Campbell in Ireland and moved circa 1770 to Fairfield or Chester County.

They are buried in the "Yongue Graveyard" that is supposed to be near Woodward in Fairfield County, SC.

They had James Yongue in Larne, Ireland in 1757. After they moved to Fairfield County, he married Agnes Mae Lee of Granville NC (?) in 1780.

James died 7 Dec 1796 Agnes remarried and moved to Tennessee. (No burial site for James.)

They had at least 4 children, one of whom was James Yongue Jr born 1793 in Blackstock, SC. James Yongue Jr and his consort Elsie Ford had 10 children. One of whom was John N Yongue. (N may be for Neil.) James Jr and Elsie are supposed to be buried in the Yongue Graveyard, Woodward, Fairfield County, SC.

John N Yongue was born in 1812 and married Savilla Price. John N died in 1860. No burial site noted. They had 8 Children, one of whom was John Lee Yongue who married Annie Elizabeth Goza.

I would love to know where my ancestors are buried. I am hoping you know much more about the "Yongue Graveyard".

I found a reference to a Yongue Grave yard just off Wagers Road in Chester County near Blackstock. It was a very small grave yard with only 5 - 10 graves and only 3 -4 grave stones. All seem to be some of the children of James Yongue Jr. I saw the graves of Sarah Yongue and Dr William B (P?) Yongue.

Any info you have about these and other grave sites would be greatly appreciated. I plan to visit and see who of mine is buried in Evergreen in Chester and may go back to rub the stones I saw off Wagers Road.
