Abstracts of Early Camden District Wills

EARLY WILLS OF CAMDEN DISTRICT

The following abstracts are from the book in the Kershaw County Judge of Probate's Office innocuously entitled "Kershaw County Will Book A 1." Actually, the contents of the greater portion of this book antedate Kershaw County (formed in 1791) by nearly a decade, and represent a far greater area. These early probate records recall a brief period, from 1782 until 1787 when one Court of Ordinary served all of Camden District. Camden District, created in 1769, was a long swath of territory cutting through the center of the Up-country, from the Santee River to Kings Mountain, including the ante-bellum districts of Clarendon, Sumter, Kershaw, and Lancaster; Richland, Fairfield, Chester, and York.

The book contains 499 pages, of which the first 384 belong to the period before 1787, when the Camden District Court of Ordinary gave way to the newly erected County Courts in probate jurisdiction. There are notations that some if not all of these early records were recopied from an original book. The date of probate for each will is not usually given.

All the rest of my estate both real and personal to

my beloved wife Mary, my three children Mary, Ann, and Morris, to be equally divided... the estate not to be separated till the debts are paid or then till Ann Miller comes to age. Unless the Executors places(?) the Different Grants I have and such lands as may be run in Georgia to be jointly the Right of my wife and children, my executors may at any time sell the following and such part of the land as they think best... the Negroes to be sold in Virginia herementioned, Phoebe, Goordon, Nanny, Ben, John, Tomboy, and Doll and Sip. Executors, my beloved wife Mary, Lyman Hall, Josiah Powel, Samuel Busby, & Thomas Morris. In case of the Death of Josiah Powel and Doct'r Hall or either of them, their Son (sic) James Powel and John to be as fully impowered as their fathers to act as Executers. It is my desire Peter Manly Three Sons be school'd out of the whole. If Capt. Morris should... (illegible) put in one hundred pounds sterling with my children and him to conduct it in order to get them their pin money. 26 Nov. 1781.

To William Crossley of Bishopgate Street, Linen Draper in London, I give 2000 pounds. To Capt William Coombes Senr, of Rotherith on London, I give 1500 pounds. To Capt William Coombes Junr in London, I give 2500 pounds. To Mr. Francis Farneson(?) in London, I give 1800 pounds. To the Widow Poupard of Smock Alley, Bishopgate Street, London, I give 600 pounds. To Robert Horrer of Clerkenwell in London, watchmaker, I give 500 pounds. To Philip Moore, merchant in Savanna Georgia, I give 50 pounds. To William Clay of Piccadilly in London, pencil maker, I give 30 pounds. To William Haslewood of Philadelphia, coombmaker, I give 10 pounds. All which sums I mean South Carolina currency, it being somewhat more than the partnership of Harris and Company owed them before the partnership was dissolved.

To my brother in law Thomas Bowe, my silver table & tea spoons & tongs... and all

my other books. To my friend Doctr George Carter, 50 pounds currency. To my friend Mr. Henry Bembridge, 50 pounds currency. To my friend Mr. John David Miller, 50 pounds currency. All three residing in Charlestown. I further give to my brother in law Thomas Bowe of Islington in London 1000 pounds. I give to my brother John George Harris, Receiver in the Isle of Guernsey, 700 pounds, all which sums I mean South Carolina currency. All my Debts, Bonds, and Notes of Hand due me, with what sum or sums I may have by me at my Decease, I give unto my good friend and brother in law of Islington. Pages 6-7. Will of James Frierson of St. Marks Parish, Camden District, planter, being sick in body. To my son () Frierson, 250 acres of land near my dwelling house, bought of William Moultrie of Charlestown, being half of a tract of 500 acres between me and James Davis, also 250 acres lying on Little river and great Lake or in Lake (sic), being half of a tract which I had formerly run out for me. To my son William Frierson, 50 acres of land where I now live, also 100 acres adjoining bought of Jared Nielson, likewise 138 acres in the Swamp bought of Jared Neilson, and 250 acres lying on Little river and great Lake or in Lake, being part of a tract as above mentioned. To prevent any Misunderstanding, it is my desire that this last tract, as it is in law, if got or lost, that the same may be equally shared between my Sons John Frierson and William Frierson. In case of the death of either of my sons, John Frierson or William Frierson, and not married, the survivor may enjoy all the lands. To my Grandson William Carson (?), 2000 pounds currency, to be paid at the age of 21 years. All my moveables and personal estate to be equally divided between my sons John Frierson and William Frierson and my Daughters Susannah Davis, Mary Frierson, & Agnes Frierson, on condition that as my Daughter Susannah Davis, having received more than her equal part, that the sum of 500 pounds currency must be stopt from paying her out of my estate, to make everything equal. To his sons Mark and Richard, one Hundred pounds each. To his Daughter Elizabeth, 100 pounds. To his Grandson William Fortune, son to William, one cow and calf. To his granddaughter Elizabeth, daughter to Mary, ten pounds. To his wife Ann Fortune, all household furniture, also 100 pounds. He further directed that his lands on the Head of Jacksons Creek should be sold to pay the aforesaid legacies, and the Surpluss money, if any, should be equally divided amongst his Wife, Ann Fortune, his two sons Mark and Richard, and his two Daughters Jenny and Elizabeth. To my well beloved wife Rachel Furman, during her natural life, 250 acres on both sides of Beach Creek, granted unto me, with all my household furniture ... my Negro man Sirrah, and my Negro man Glasgow & Negro woman Jenny and her issue, during the time she shall continue my widow. In case of her remarriage, then she shall keep the said slaves, but the issue of Jenny shall be equally divided among my children.

To my son Josiah Furman, a tract of land in St. Marks Parish which I purchased of Barnard Bookman, containing 550 acres, bounding South West on Wateree River, North West when granted on vacant land, now belonging to the estate of James Postell Decd, to the South East on Land which I purchased from Tennis Tiebent, to the North East on land which I purchased from Samuel Bacot...

EDITOR'S NOTE: The Jury List of 1778 includes the name of John Sadler in New Acquisition District and also in the District Between the Borad and Catawba. The above Will belongs to John Sadler of the Fishing Creek Settlement in New Acquisition. Within that Calvinist enclave, he was surely one of very few whose Estate included a "Common Prayer Book." Although his Will mentions no land, both his sons were owners of respectable tracts.

Richard Sadler entered his Memorial on 14 Oct. 1772,

Of a plantation or tract of Land Containing 300 Acres Situate in Craven County on the waters of fishing Creek, on the waggon road that Leads from Peter Kuykendalls to Charlestown, lying Northwards from Charles Beatey's Land ... Originally Granted the 9th day of Novr 1764 to Edward Crofts by his Excellency Arthur Dobbs Esqr, then Gov'r of N Carolina & Conveyed by the said Edw'd Crofts the 11th day of April 1765 to John Fondren who with Elenor his Wife Conveyed the same to the Mem'st ... which tract by a late resurvey of the boundary line between N & S Carolina falls within the province of S Carolina in Craven County ... (S.C. Archives, Memorials, vol. 11, p. 458).

However, the name Richard Sadler occurs twice in the New Acquisition Jury List of 1778 and again twice in the York County Census of 1790. Also, in the Revolution a Capt. Richard Sadler did 57 days duty in 1778 and furnished flour for the Expedition to Georgia that year, mentioned on p. 208 of this issue. And in 1782, a Richard Sadler did duty in Orangeburgh as a private with Capt. Jas. Wallace, also of the Fishing Creek settlement (Account Audited 6714).

George Sadler entered his Memorial on 29 Mar. 1776,

Of a plantation or tract of Land Containing 100 Acres Situate as Supposed when run out to be in Tryon County in North Carolina and upon the Waters of Fishing Creek, and is part of a Larger tract Originally Granted the 22d day of Decr 1768 by Gov'r Tryon to William Hannah ... and Conveyed by said William Hannah by Deed of Release bearing date the 24th day of Octr 1769 to the Mem'st, but by the Con-

tinuation of the boundary line between N & S Carolina, it now falls Within this Province,

Of a plantation or tract of Land Containing 200 Acres Situate as Supposed above when run out, upon the South branch of Fishing Creek, adjoining John Dennises Land ... Joining Davidson's Land ... Originally Granted the 11th day of Decr 1770 to Robert Harper by Govr Tryon ... and Conveyed by him the 6th day of Aug'st 1770(?) to the Mem'st ...

Of a plantation or tract of Land Containing 260 Acres Situate as Supposed above when run out to be in Tryon County, N Carolina, but by the Continuation of the boundary line between N & S Carolina it falls within this Province in Craven County, on the waters of Turkey Creek, Joining Edward Lacey's Land ... Originally Granted the 18th day of April 1771 by Govr Tryon to the Memst ... (Memorials, vol. 2, p. 479).

George Sadler was listed in the 1778 Jury List as a resident of New Acquisition, and in 1790 a George Sadler was recorded in the census of both Chester and Pendleton Counties. In the Revolution George Sadler furnished "200 Weight of Flour and one mare in the year 1779, received by Jas Mitchell." For this he was paid in 1786 £.20.14.3½, received for him by John Gordon (Account Audited 6712).
