Mr. Dukes and family moved from Liberty County to Thomas County about 1835, and settled in the Grooverville district which section of Thomas was made into Brooks County in 1858. He later sold out his plantation near Dry Lake and moved over into the then county of Lowndes and located in Tallokas community of which is now Brooks County. He died there July 17. 1855. Mrs. Hodges on Jan. 3, 1866, married Wm. N. Redding; she died 1872.

Mr. Dukes was Justice of Peace of the 754th district of Thomas County, 1841-45; Captain of the Militia in the 752nd district, Thomas County, 1836-37; and Justice of Peace of the 790th district of Lowndes County, 1849-1853.

He became a Mason in 1849, receiving his degrees in St. Thomas Lodge, No. 49, at Thomasville. In 1852 he became a charter member of the new Okapilco Lodge, No. 172, near his home, and served as its secretary until his death.

John Delk, who married Mrs. Dukes' sister, was administrator of the estate of E. C. Dukes and was granted letters of dismission in 1862. In 1866, John W. Dukes, the oldest son, was David Mathis, oldest son of John Mathis (see Vol. I), was born in North Carolina in 1802, and was brought as an infant by his parents to Bulloch County, Ga. David Mathis brought his family to what was then Lowndes County in the winter of 1825-26, and settled on lot 102, 9th district. This is one mile east of the present village of ecil, Cook County. In January, 1826, he built his log-home, a sturdy and comfortable home that he occupied until his death about fifty years later. This home was on the Coffee Road, main thoroughfare of travel in those days from middle Georgia into southwest Georgia and Florida. It was a stage-coach stop where the horses were rested. Many people in those pioneer days, enjoyed the hospitality of the Mathis home.

Mr. Mathis was ensign of the militia in the 658th district, 1828-40, and Justice of Peace, same district, 1829-1834; and Justice of Berrien Inferior Court, 1861-62. Mr. Mathis was a member of Pleasant Primitive Baptist Church into which he was baptized about 1840, but later transferred his membership to Salem Chruch which is now in the City of Adel. His wife was a member also. He died about 1875 and his wife died soon after. They were buried at Pleasant Church.

He came with his parents to Burke County, Ga., in 1800, then about 1805 to Montgomery County, then to Telfair County. He was married twice. His first marriage was in Telfair County, May 17, 1810, to Miss Susannah Byrd, born 1793 in McIntosh County. By her six children were born. In 1849, he was married in Lowndes (now Brooks) County, to Martha Ann Dukes, born 1820 in Tattnall County, daughter of Elijah Dukes, and grand-daughter of John Dukes, R.S., who emigrated from Barnwell District, S. C., to Tattnall County about 1802-03. By the second wife, six children were born. The twelve children in their order, were:

Mr. Wooten lived several years on the north side of the Ocmulgee River, but after the creation of Appling County south of the river and the detachment of the 1st land district from Appling and being added to Telfair, he granted lands in that district and moved there. But in 1827, he sold out his possessions there (land lot 314, 1st district) to William Ashley, having shortly before moved to Thomas County. In Thomas he settled in the 13th land district where he acquired three or four lots of land and established his home. But after his first wife's death he divided his lands between his children who were all

DRAWDY, LEVI (p. 73): (1st) Mr. Drawdy's last wife, Delilah Ann, was not a daughter of King Hinson, but rather was his sister. Her first husband was Noah Green by whom she had nine children who lived in Berrien, Clinch and nearby counties. (2nd) There was no daughter named Ann. (3rd) There were only two children by the second wife, viz., Sylvester M. Drawdy and Perry Drawdy. (4th) The second husband of the daughter, Keziah, was Horace Cox of Clinch County, a son of Samuel D. Cox of Berrien County.

DRIGGERS. WILLIAM (p. 74): He was born Nov. 30, 1776. His wife, Millie, was born June 25, 1778.

DUKES, JOHN (p. 75): Elijah Dukes, shown as a son, was not a son of this John Dukes. Elijah's father was John Dukes, R. S., who moved from Barnwell District, S. C., to Tattnall County, as early as 1803. This is clearly shown by instruments of record in Barnwell County, S. C. So far as known, no relationship existed between the two John Dukes'. The other children's names listed on p. 76, are correct.

FENDER, DAVID (p. 77): (1st) His daughter, Nellie, properly "Penelope", married Mark Davis, son of Stafford Davis of Coffee County. (2nd) Mr. Fender's home-place was on lot of land 396, 10th district formerly Lowndes County (placed in Clinch in 1850, and in Lanier in 1920). He boughtthis property March 22, 1838, from Joseph J. Walton of Lincoln County, as shown by deed recorded in Clinch County. Mr. Fender gave portions of this land to some of his sons during his lifetime.

FLETCHER, JOHN (p. 80): (1st) He was commissioned Captain in the Screven County militia, Nov. 21, 1795. (2nd) The son Griffin Mizell Fletcher, married his first-cousin. Jane Mizell, daughter of Griffin and Susannah Mizell who lived many years in Telfair but later moved to present Brooks County. (3rd) Mr. Fletcher was cut out of Effingham into Screven County in the latter's formation in 1793, and then in 1796, he was annexed to Bulloch when it was formed partly out of Screven. He served as Representative from Bulloch County in After removing from Bulloch, he lived a short time in Tattnall County before moving to Telfair. He was Justice of Peace in the 43rd district, Tattnall County, commissioned May 17, 1808. (4th) His son, John Fletcher, Jr., was married in Bulloch County to Sarah Dell, Sept. 18, 1828. (5th) The clause on p. 81, reading "who were by that time all of age", is incorrect.

FOLSOM, LAWRENCE (p. 82): He was named by the legislature in a resolution approved Dec. 27, 1827, as a trustee

DAUGHARTY, DEMPSEY (p. 89): Harvey M. Burnett was the first descendant of John Daugharty, R. S., to be admitted on his service, into the Sons of the American Revolution. He was admitted June 9, 1953, and his National Number is 76565. He is a member of the Wiregrass Chapter, S.A.R. He is a grandson of James Burnett (q.v.).

DICKERSON, R. G. (p. 93): The daughter, Rachel, married Ben M. James of Pierce County, instead of Ben W. James of Ware and Clinch Counties. The two James' were first cousins.

DUKE, EDWARD C. (p. 99): The son, Elias C. Dukes, married Mrs. Sinadolia (Stephens) Cone, Nov. 9, 1865, in Thomas County. She was the widow of James F. Cone.

EASTERS, GILES (p. 101): (1) His wife's name as shown by Jefferson County, Florida, records, was Arcady and not Fairiby. That she was a McCutchen before marriage was vouched for by her last surviving grand-daughter some years ago. The Compiler in more recent years found the marriage of Giles Easters of record in Tattnall County as stated; but the present record is a transcribed typewritten record, and the WPA transcriber evidently misread the name "Arcady" as "Fairiby." The original record cannot be found by the present Ordinary at Reidsville. (2) There was another daughter, Sarah, who married Edmund Gray in Jefferson County, Fla., August 5, 1831.

ELLIS, WILLIAM (p. 102): (1) His parents moved to Montgomery County the same year he was born, and were cut into Tattnall in its creation. (2) He was 1st Lieut., Telfair County militia, 437th district, 1835-1838.

FOLSOM, MASTON (p. 107): He served on the first Grand Jury in Brooks County, May term, 1859.

FUTCH, THOMAS (p. 111): His father, Solomon Futch, made him a deed of gift for fifty acres of his home-place lands in Bulloch County, July 11, 1818 (deed book A, page 417).

GIBSON, DANIEL (p. 116): The name of the husband of the daughter, Sarah, should have read "James T. Robeson". He later changed the spelling of his name to "Robinson"; and after marriage, moved to Lowndes, now Brooks County, where descendants now live.

HARRIS, MOSES S. (p. 135): He was Clerk of the Piedmont Baptist Association in 1825 (and not 1823, as stated).

HOLLOWAY, GRIFFIN (p. 153): (1) Since this sketch was printed, Mr. Griffin W. Holloway, only surviving child of the subject, has departed this life at his home in Barwick, Ga., in his 93rd year. (2) Griffin Holloway, the subject, served on the
