- Two Documents We Are Proud To Publish -

l - "Hopewell Baptist Church Minutes" - This church near Bascomville in Chester County was organized sometime prior to 1793. Records show that "Pacolet Church, a member of the Bethel Baptist Association dismissed 19 members to form a new church on Fishing Creek to be called Hopewell".

Its first minister was Samuel Eccles who served until about 1803 after which Samuel McCreary, a licensed minister and a grandson of Justice John Gaston, preached for them and later served as their second pastr until his death on March 2, 1834 in his 71st year. He is buried in Burnt Meeting House cemetery in Chester County.

Sometime after Hopewell Baptist came into being, three branch churches were sponsored by Hopewell - Providence Baptist, Harmony Baptist in 1839, and Fort Lawn Baptist in 1888. The last two named are still active today.

There have been no known records of Providence or Hopewell Baptist churches until Miss Margaret Jordan of Richburg permitted us to publish "The Minutes of Providence and Hopewell Baptist Churches" covering the period from 1826 to 1876 which she has in her possession.

This publication of 131 pages contains the names of more than 700 individuals with the following surnames most prominent; Adams, Bell, Bradley, Collins, Culp, Edwards, Ferguson, Howard, Hyatt, Jackson, Johnston, Jordan, Kea, Kee, Montgomery, McCreary, McFadden, Perry, Pittman, Potts, and White.

This is by no means the complete minutes of Hopewell which was organized about 1793 and existed as an active church until destroyed by fire in 1926 but the book does cover the period from 1826 to 1876 which is an important period of time for those of us seeking records of our ancestrs.

Furthermore, most other early churches in his area of the Piedmont Carolinas were Presbyterian so this is one of the few existing publications that contains records of many of our ancestrs who came to America or de-

cended from those who came as Baptist.

It is believed the first 23 pages are the minutes of Providence Baptist since it is known bat John K. Johnston was Clerk of Providence Church. Page 23 tells of the dissolution of this church. We now have the minutes of Providence and Hopewell for the period 1812 thru 1815 which we hope to publish in 1982 along with the cemetery inscriptions at Hopewell and the index to the above book.

This here-to-fore unpublished document we believe will aid many who have sought but not found ancestors whom hey believe had roots in the

Chester County area.

2 - "History of Hopewell A.R.P. Church", Chester County, South Caro-

lina by Dr. Robert Lathan.

In 1879 the Yorkville Enquirer of Yorkville S. C. published the above history of one of Chester County's oldest churches. The reproduced book we are publishing for the first time is in three sections all written by Dr. Lathan.

The first section deals with the history of the church and community together with biographical sketches of its first four pastors plus a list of elders from the church's beginning thru Dr. Brice's ministry. The middle section is a reproduction of Rev. R. W. Brice's (it's fourth pastor) list of pastoral visitations to members, infant baptisms (white and colored), removals from the church's roll (primarily emigrations to the west and southwest) and marriages he performed.

In Rev. Brice's report there are many names, dates and places during the period he served from 1852 to 1874 that should be of inestimate value to those with roots in this area during the period of Rev. Brice's service.

The third and final section of Dr. Lathan's well written book is entitled "An Excursion" in which he in almost diary form tells of his many

visits to the eastern section of Chester County where Union A.R.P., Hopewell A.R.P., and Old Catholic Churches are located and into Fairfield County where he was reared. He tells of the families and churches he visited, their problems and trials and the reasons for many of these stalwart citizens emigrating to the west and southwest with their roots left behind in Fairfield, Chester, Lancaster and York Counties.
No treatise we have seen has more genealogical information on the

early families of this area than Dr. Lathan's History of Hopewell Associate

Reformed Presbyterian Church.

TINKLING SPRING CHURCH

There was no Solid South in the pre-revolutionary period, but rather three Southern societies: the Chesapeake Society, the Carolina Society, and the Back Country. The Back Country was settled mostly by pioneers from Pennsylvania moving up the Valley of Virginia and on into the Carolinas and Georgia. The Scotch-Irish were the dominant group in the Upper Valley and on into the Piedmont.

The earliest churches with a settled pastor in the Upper Valley - indeed in the entire Back Country - were the Old Stone and Tinkling Spring Presbyterian churches, organized by the Scotch-Irish in Augusta Co. The history of Tinkling Spring Church has been closely related with the Valley. From the Valley and from this church, have gone out a multitude of sons and daughters to enrich the nation through their own services and that of their descendants.

The first white explorer to claim a view of the Valley was John Lederer, but the Irish family of John Lewis, Tinkling Spring's advance pioneer and leader of the settlement which developed Augusta Co., Va., about 1732, is the first settler.

Margaret Lynn, wife of John Lewis, was the daughter of William and Margaret Patton Lynn. Another child of William and Margaret P. Lynn was Dr. William Lynn, who immigrated to the Virginia Colony and in 1727, petitioned the Council of Virginia for a land grant west of the Blue Ridge for 50,000 acres.

Other settlers associated with Lewis seem to have been fellow dissenters in the faith: Kerrs, Christians, Campbells, and Cathys. The Kerrs were part of the Donegal Presbyterian Society under the ministry of Rev. James Anderson in 1730. The family of Gilbert Christian, his wife and four children. John, Robert, William and Mary - immigrated to Pennsylvania in 1726. Two became elders at the Tinkling Spring Meeting House. John Campbell, his wife, Grace Hay, and seven of his nine children came about the same time. The father died sometime before 1741. Patrick, the oldest son had a land grant of 1,546 acres. The well-known Col. Arthur Campbell and Gen. William Campbell of King's Mountain fame were both baptised at Tinkling Spring.

On Aug. 26, 1738, Capt. James Patton and his brother-in-law, John Preston, arrived with their families. James Patton, born 1692, was the fourth son of Henry and Sarah Lynn Patton.

These land owners were not the only settlers, but it is clear from the Tinkling Spring membership list of 1744 that there were 77 heads of families in that church alone. They were divided into three districts: John Finley's list included the families of Turks, Gays, Gillespies, McClures, Pattersons, Teas, and Edmistons. William Wright's list included the Hutchisons, Johnsons, Frazers, Thompsons, Kerrs, Hendersons, McCunes, Skillerns, Palmers, and Moodys. John Christians's list included the families of Bells, Alexanders, Caldwells, Davisons, Prestons, Lewises, Scotts, McClanahans, Breckenridges, Blacks, Cunninghams, Ramseys, Wilsons, and McCullocks.

The manuscript of the Record of Baptisms, 1740-1749, is in chronological order. The congregation referred to was the old Craig parish in which was included both Stone and Tinkling Spring Meeting Houses.

THE REVOLUTIONARY SERVICES OF DAVID WEIR, HIS SON, WILLIAM WEIR, JOHN MILLER, AND MOSES MCCOWN OF FISHING CREEK, SOUTH CAROLINA

David Weir was descended from James Weir, of Scotland, who was descended from Baltredus de Vere; the first of the Weir Scottish line, coming to Scotland from England in 1153, a younger son of an ancient and noble English family. Blackwood, Lesmahagow Parrish, Lanarkshire, was the Scottish ancestral home of the Weir family. The above James Weir was proclaimed by King Charles II, October 8, 1681, in the following language: "Charles, by the grace of God, king of Great Britain, France, and Ireland, defender of the faith, to our lovits greetings, --For as much as the persons underwritten, are by decreet of the lords Commissioners of judiciary, forfeited in their lives, lands and goods for their treasonable rising in arms in the late rebellion at Bothwell bridge, viz., James Weir, of Lesmahagow, Lanarkshire" (and Others). "We hereby give and grant full power, authority and commission to pursue, take, apprehend, imprison, the fore said rebels and traitors wherever they can be found, and in case of resistance to pursue them to death by force of arms or drive them forth, etc." (A Covenanter.)

"Given under our signet at Holyrood, the 8th day of Oct. 1681, and of our reign the 33rd year, signed The King."

In 1684, a milder proclamation was issued against the Weirs of Lesmahagow, Lanarkshire. James Weir, the younger, Thomas Weir, brother of James the younger, Gavin Weir, Adam Weir and others. They were charged with being active offensive Covenanters. "Soldiers of the King were stationed in Blackwood Manor in 1684, the home of the Weir family." The Weirs fled from the persecutions of Claverhouse to the north of Ireland. Their property having been confiscated and they hunted out of Scotland, they took refuge in Ireland." "County Antrim was known as the shelter of the hunted Covenanters."

Historian Hanna says, "Many of the Antrim, Ireland, Leases having fallen due in 1772, the tenants, all Protestants, were at once a whole country side, driven from their habitations, and saw their farms, which these sturdy Scots had in five generations reclaimed from the wilderness of Antrim, let by auction to the highest bidder, 100,000 pounds was asked in addition to the rents from the Protestants, they offered rent and interest on the 100,000 pounds, which was refused. The most substantial of the expelled, gathered their effects and sailed to join their countrymen in the New World. Where the Scoth-Irish became known as the most bitter secessionists from England."

Smith's History of Pickens County, Alabama, speaks of "The Weirs of South Carolina, who were born in the north of Ireland, their ancestry were Protestant Irish. Which is as valuable an inheritance as an American need wish, they were Scotch-Irish Presbyterians of the highest standing. Their standing is too well known to need eulogy."

These Scotch-Irish Presbyterian Covenanters, settled at Fishing Creek, in 1772. Headed by Rev. William Martin, they came from Ballymoney, County Antrim, Ireland, and had intended to land at Cape Cod, but were driven out of their course by a severe storm and landed on the coast of South Carolina. In this company, headed by Rev. William Martin, were the Weirs, the Millers, the Boydes, the McCowns, the Piggins, etc.

George Howe, in his history of the Presbyterian Church in South Carolina, says, "Wm. Martin and his Covenanters had ill getting their land, they expected to settle down all close together but they had to scatter and select land a considerable distance from each other, they were entitled to bounty land, one hundred acres for each head of family and fifty to each member, those who had means bought from the older settlers. The place selected for a Church was near the house now occupied by Mrs. James Barber Ferguson. It was a log building, burned by the British in 1780. The second Church was the Beaver Dam Church, on land now occupied by Stephen Ferguson."

Fishing Creek is a settlement about fifteen miles long and four miles wide, lying along Fishing Creek, in Chester County, South Carolina, all historic ground. Hardly an acre but had been the scene of some interesting Revolutionary event: Rock Creek, Catawba River, and Fishing Creek are there. The country is rolling, beautiful to the eye, with a general atmosphere of peace and plenty. On every side are comfortable homes and well-cultivated farms, the land appears good cotton land, which is the chief farming industry. The old churches and graveyards are many. Revolutionary events crowd thick along Fishing Creek; here is "Cornwallis' Road," there is where Tarleton defeated the Americans, here is a tree on which a Tory was hung.

"Hopping" John Miller and one Wylie were captured by the British while taking a message from Colonel Lacy to General Morgan, though Miller by the way was not captured. "As they rode along, they saw that they were being pursued by British troopers; after riding for some time, Wylie's horse gave out. Miller said to Wylie, "Let's fight," but Wylie said it was useless to make a stand against such large numbers. Miller then caused his horse to jump a wall and escaped; Wylie was captured." (See "Women of the Revolution," by Mrs. Ellet.)

The General Anderson named in the Revolutionary War was an ancestor of R. A. Anderson, now living upon a part of the "Old David Weir plantation." The grave of David Weir in Paul's graveyard is near the Anderson home, on the David Weir land. His gravestone is marked "David Weir, Born December 25th, 1730, Died January 13th, 1821, aged 90 years, 18 days. The David Weir home is now known as the Gasaway place, being a log house covered with weather boards.

Overlooking the valley of Fishing Creek are the cornerstones only of the Beaver Dam Church, built before 1788. It went out of existence in 1835. Family history says that this David Weir was brought home wounded from the battle field of Cowpens and recovered. This David Weir had a grandson David who was the son of William Weir, this grandson was wounded at Eutaw Springs and died soon afterwards from his wounds. Stub entries to Indents, issued in payment of claims against South Carolina, growing out of the Revolution, for Militia duty performed, says, "Paid to David Weir (Indexed Wier) 10 pounds sterling, for 100 days' militia duty, as per account audited. -- Issued 2nd November 1784, No. 470, Book L, by A. S. Salley, Jr., Secy. of the Historical Commission of South Carolina, Columbia, S. C.

William Weir, the son of David Weir the Covenanter, was born in County Antrim, Ireland, came to Fishing Creek in 1772 with the David Weir family. Married before 1777, to Susannah Miller, who was a sister of Revolutionary soldier, John Miller. William Weir and wife Susannah Miller are buried at Paradise, Kentucky. On her grave stone is inscribed "Susannah the best of Mothers."

William Weir at one time returned home from the Revolutionary army, to make shoes for his family and his son David took his place. David, son of William and grandson of the Revolutionary soldier, David Weir, was severly wounded in the battle at Eutaw Springs and was taken a prisoner to Charleston. His mother, Susannah Miller Weir went to Charleston and procured his release; she took him home in a cart seventy miles, but he died from the effects of his wounds several months afterwards. William Weir (indexed Ware) served in Capt. Isaac Ross' troop in 2nd Reg. State Dragoons, commanded by Charles Myddleton, Sumpter's Brigade. saw service in the "upper Country" engagements. - See in Congressional Library, Washington, D. C., documents relating to the History of South Carolina During the Revolutionary War, by A. S. Salley, Jr., Columbia, S. C., page 83. William (Ware) Weir. "Pay roll of Capt. Isaac Ross' troop, 2nd Reg. State Dragoons, commanded by Charles Myddleton, 18th April, 1782. William (Ware) Weir, Camden Dist. Privt. When commenced -- May -- time served ten months." Also see "Stub entries to Indents issued in payment of claims against South Carolina." Growing out of the Revolution. By A. S. Salley, Jr., Columbia, S. C., page 189, No. 419, Lib. M. "Issued 1st Oct. 1784 to Mr. William (Ware) Weir, late Private in Ross' troop, Myddleton Reg., Sumpter's Brigade of State troops, 94 pounds sterling being the amount of pay and bounty due him for services in troop." The name of Weir is pronounced Ware in South Carolina and Kentucky and spelled Wier and Ware.

Revolutionary soldier, William Weir had six children. William, Jr., was his eldest son. James Weir, another son, went from South Carolina to Greenville, Kentucky, in 1798. He was born in 1777, married Ann Cowman Rumsey on November 13, 1814. She was born in 1792, died 1838. James Weir died in Greenville, Kentucky, August 9, 1845, and is buried in the Weir cemetery there. He became very wealthy for that day. A merchant, banker, and most highly esteemed, Kentucky history states.

"Hopping" John Miller, who was lame of a leg, was born in County Antrim, Ireland. A Covenanter, he came to Fishing Creek in 1772 in the company headed by Rev. Wm. Martin. He was born about 1754, died after July 20, 1818. Married Mary McCown about 1782. She was the daughter of Revolutionary soldier Moses (Ferocious) McCown. Mary McCown was 94 years old when she died. They had three sons: John, whose descendants are in Paducah, Kentucky; Cyrus, whose descendants are in Mississippi; and Samuel Adolphus, the grandfather of the writer. This son John was a soldier in the War of 1812, and his widow received a pension.

"John Miller, of South Carolina, Chester District, joined the army of the Revolution at the beginning of the war, served until peace was declared. Came home with broken health, was ever after a disabled sufferer. Died after a number of years from the effects of hardships and exposures during the war, left a widow who lived until about 1852 or 3."

"Hopping" John Miller appears to have been somewhat of a humorist, and had a good deal of dash and dare-devil. Mrs. Ellet, in her "Women of the Revolution," speaks of him as "Brave 'Hopping' John Miller." He would load behind a log or tree and then step out, and after deliberately taking aim, would say, 'May God speed the bullet.'" He was a fine shot. "The British were in a log house. General Sumpter offered a reward of \$4000 to anyone who would fire the house. 'Hopping' John Miller, with confidence in Providence and the justice of the cause, assisted by a few others of his own stamp, piled brush against the house and 'Hopping' John set fire to it, but a rain came up, put out the fire, and Sumpter withdrew."

Mrs. Mary McIver of Elizabethton, Tennessee was kind enough to share these McKown cemetery inscriptions with us.

According to grave markers, Family Bible records, and word of mouth, William and Martha McKown were parents of the following children: Nancy, b. ca. 1773; James, b. ca. 1775; Jeff, b. ca. 1777; Sarah, b. ca. 1780; Margaret b. ca. 1784; Mary, b. ca. 1794; John, b. ca. 1795; George, b. ca. 1797; Francis, birthdate not known.

William and Mary may have had other children, also. Birth dates on tombstones do no coincide exactly with Camden Dist., York Co., 1790 Census report.

They were parents of (1) John Lockhart McKown, 22 Nov. 1824-22 Mar. 1887, unmarried. (2) Martha McKown, b. 26 Apr. 1826, md. _____ Maconson had 7 chn., bur. Maconson Cem. (3) Margaret Naomi McKown, b. 14 Apr. 1828, md. John Service & had 3 children. (4) William Michel McKown, b. June 1830-28 Jan. 1862 C. S. Army., md. Lavina Tate, daughter of Henry Howe Tate and Lavina Steen. They had 2 children. (5) Sarah McKown, 30 Oct. 1832, md. Tom Service, no children.

William Mitchell married Lavina Tate and moved to Marion Co., Al. about six miles from residence of John Bankhead, son of James of So. Carolina. Mitchell died within 4 mo. after induction into Mississippi's 24th Inf. (measles and exposure). Lavina died in 1868. George, 1858-1926, and Ora were brought to Union Co., S. C. where they lived with their grandmother. Ora Anna married James Foster Peeler in 1877 and they returned to Ala. George Th. McKown and Ora Anna Peeler, 1860-1928, are buried in the Lockhart Cemetery, Monroe Co., Miss.

The Revolutionary Services of Moses McCown of Fishing Creek, South Carolina

When on a visit to Chester, South Carolina, I obtained a great deal of information in regard to Moses (the Ferocious) McCown. Samuel Thomas McCown, a prominent citizen of Chester, is a descendant of Moses McCown.

Moses McCown appears to have been a "Bad man from Fishing Creek." A good man for the Tories and Hessians to let alone. At the same time a Christian of most honest convictions. He had enough sons (seven) to undertake most anything, and I think there was nothing he would not undertake for the American cause. He hated Tories and Hessians with most intensely healthy hatred, the only good ones to him were dead ones. The depredations of the Hessians justified his hatred and efforts to rid the county of them. He was known as "death to Hessians". In superlative expression, it was said that "Moses McCown had to be locked up to keep him from killing Tories and Hessians during the Revolution." One of the incidents are as follows: At that time the Hessians were doing great damage in that part of the country. Moses McCown was appointed local Provost Marshall: he and his seven sons, captured a little squad of Hessians (the number not now known) and took them home and locked them in the "smoke house". Moses then went and had family prayers, he being a most devout as well as a determined man. After reading a chapter in the Bible and offering prayer, his mind appears to have been made up and he went out and told the Hessians to prepare to meet their maker. As, when the hour arrived that spirits left the earth their souls would go home. As the day dawned he lined the Hessians up and said to his sons, "My sons thrust through" and his sons thrust them through and their souls went home.

Moses McCown was the father of Mary McCown, who became the wife of Revolutionary soldier John Miller. The grave of Moses McCown is on a hill in Chester County near Chester, South Carolina. His Revolutionary record is well known and remembered in Chester County.

David Weir, and his son William and Moses McCown and his son-in-law, John Miller certainly rendered an honorable account of themselves during the Revolutionary War, and should be given their place among American patriots.

WHITE'S MILL

WHITE'S MILL was a place of some importance during the American Revolution, but its location became lost over the years and only recently was rediscovered by this writer.

After the battle of Camden, Lord Cornwallis determined to invade North Carolina. He marched the main British army up the east side of the Catawba River, and sent Lt. Col. Banastre Tarleton up the west side. Notes made by his Lordship's aide-de-camp, Lt. John Money, contain these interesting entries (Cornwallis Papers, PRO 30/11/3, nos. 88-156).

Friday, 8 Septr. 1780, Hanging Rock. Colonel Tarleton with the Legion marched this morning from Camden & crossed the Wateree.

Saturday, 9 Septr. 1780, Berkeley's House, Waxhaw. The Army marched from Hanging Rock to this place.

Sunday, 10 Septr. 1780, Foster's House, Waxhaw. The Army marched to this place.

Tuesday, 12 Septr. 1780, Crawford's on Waxhaw Creek. The Army took a position at this place & halted. Two mills on the Catawba River at Blair's & another at Harper's, were employed in grinding wheat for the Troops.

Thursday, 14 Septr. 1780, Crawford's. Received a letter from Colo. Tarleton dated, Cross-Roads, Fishing Creek. He proposed marching to-morrow within about 20 miles of this Post, to White's Mill. Lord Cornwallis wrote to Colo. Tarleton . . . to request to see him.

Friday, 15 Septr. 1780, Crawford's. Colo. Tarleton came from White's Mill.

Saturday, 16 Septr. 1780. Colo. Tarleton returned to the Legion having received directions to take the earliest opportunity of attacking General [Thomas] Sumpter who had taken post on Alpine's Creek.

Monday, 18 Septr. 1780, Crawford's. Received an Account of Colo. Tarleton being dangerously ill of a Fever. I was sent off to him at White's Mill.

Tuesday, 19 Septr. 1780, Colo: Tarleton's Quarters at White's Mill on Fishing Creek. Colo: Tarleton being exceedingly ill I staid at this Post to-day.

Wednesday, 20 Septr. 1780, Crawford's. Returned from Colo: Tarleton.

Friday, 22 Septr. 1780, Crawford's. Went to Tarleton, to endeavor to remove him from the Post at White's Mill, having received Intelligence of Gens. [William Lee] Davidson & [Jethro] Sumner being between Charlotte & Sumpter's Post, with about 700 militia. Their intention was to endeavor to surprise the Legion if possible. Arrived at White's Mill about two o'clock, P.M. They had received Intelligence of Gen: Sumpter's Intention and that he proposed crossing the Catawba that evening. Tarleton was so dangerously ill, as to render his Removal impossible, with any degree of safety. The Post was such, that the cavalry in case of attack could not act, those who had carbines were dismounted & took Post in a Wood to the Right, and every other Precaution taken to strengthen the Post & prevent a Surprise.

Saturday, 23 Septr. 1780, Crawford's. Tarleton was so well as to be able to be removed from White's Mill, to Blair's House, across the Cawawba. The Legion marched & cross'd at Blair's Ford.

Sunday, 24 Septr. 1780, Crawford's. The Army began to march towards Charlotte.

During the Revolution there was an upper mill and a lower mill on Fishing Creek. The lower mill was at present Lando in Chester County and was owned and operated by Philip Walker who ground grain for both General Nathanael Greene and Lord Cornwallis (AA 8138, and Cornwallis Papers). The land on which it was located was granted on August 30, 1762, by South Carolina to Walker, and by him was sold after the war on September 24, 1784, to Hugh White, a miller who operated a mill on upper Fishing Creek during the war (Charleston Deeds, N-5: 290-292). White was granted on September 25, 1766, by North Carolina, a patent to 350 acres "on both sides of Fishing Creek, including his house and mill," joined on the north by lands sold him by Philip Walker, on northwest by John Neely, and on southwest by James Muldoon. Muldoon's 100 acre tract was granted by North Carolina in 1765, and his adjoining 200 acres, "a little below the mouth of Stony Fork of

Fishing Creek," was granted by South Carolina in 1764. October 14, 1797, White deeded 175 acres, "part of a tract lying and being in York County on both sides of the main branch of Fishing Creek, including the mill and other im-

provements whereon the said Hugh White now lives," to John McCants [McCance] (York Deeds, E: 231). From this we see that Hugh White owned the York County mill from 1766 to 1797, including September 1780 when Tarleton lay there dangerously ill of fever. Likewise, we see that Philip Walker owned the mill in present Chester County from 1762 to 1784, and that White did not come into possession of it until four years after

19. 1785, refer to "Philip Walker's Mill," and on January 18, 1786, to the same mill as "White's lowest mill." The old Walker mill, which became known in 1786 as "White's Mill," was owned by the White's until 1844 when they sold it to Nathaniel R. Eaves (Chester Deeds, EE:


Tarleton's illness. Chester County court minutes of April

185). About 1884 it was acquired by Matthew Simonton Lynn.

When Tarleton's CAMPAIGNS OF 1780 AND 1781 was published in 1787 a map by William Faden, geographer to the King, was used to illustrate the marches of Lord Cornwallis and the British army. Reference to this map shows roads leading from Land's Ford to both mills on Fishing Creek, simply designated as "White's" and "Walker's" and heavy lines showing the British at both locations. If one will measure the distance from White's to Walker's and refer to the scale of miles, it will be found that White's was about six miles up the creek from Walker's. Then take a modern map and measure a corresponding distance up the creek from Lando and it will be about one and one-half miles north of the York-Chester line in the former county.

It is this writer's considered opinion that the loss of this historic site may be attributed to the Chester County antiquary Daniel Green Stinson (1794-1879) who in 1871 misinformed the historian Dr. Lyman C. Draper, and Mrs. Elizabeth F. Ellet, who repeated the error in her WOMEN OF THE REVOLUTION. It was an honest mistake. By the time Stinson was old enough to note historic sites, Walker's Mill at Lando was well established as White's Mill.

The accompanying map shows not only the true location of White's Mill, and Fishing Creek Meeting House, but of lands of many of the persons mentioned by the Reverend John Simpson in his list of visits made in his congregation, 1774-1775.

THE BATTLE OF HANGING ROCK, AUGUST 6, 1780.

After the fall of Charleston in May 1780, the British established a string of posts and outposts across the state to effectively choke off all patriot resistance in the back country. One such outpost of Camden was located at Hanging Rock in Iancaster county and garrisoned with Maj John Carden's detachment of the Prince of Wales Loyal American Volunteers, part of Lt Col Banastre Tarleton's Iegion infantry under Col Kenneth McCulloch and Col John Rousselet, Col Samuel Bryan's N. C. Provincial Regiment, part of Col Thomas Brown's Ga. and S. C. Provincial Rangers, and Lt Col John Hamilton's N. C. Loyalists.

Gen Thomas Sumter recognized the threat posed by this garrison and determined to march against it with Maj Richard Winn's Fairfield regiment, Col Edward Lacey's Chester regiment, and Col William Hill's York regiment. He was assisted by Maj William Richardson Davie with Col Robert Irwin's troop of horse from Mecklenburg county, N. C. For four hours on the 6th of August 1780, was fought one of the most hotly contested actions of the Revolutionary War. Major Carden lost his nerve in the midst of the battle and resigned command of the British to Colonel Rousselet.

It is exceedingly difficult to trace the military activities of South Carolina militia officers and men owing to the absence of muster rolls. Before Charleston fell Col John Winn commanded the men of Fairfield and Chester, but he was captured when Gen Benjamin Lincoln surrendered the city, and was paroled by Lord Cornwallis on June 8th. Capt Philip Walker of Rocky Creek, who commanded one of his companies evidently was also paroled. Already missing one ear and probably not wishing to risk having his neck stretched by violating his parole, he resigned his commission. Colonel Lacey took command of the Chester regiment. Alexander Campbell, who had served under Walker as a lieutenant, was promoted to captain, and Philip's brother Robert Walker was elevated to lieutenant.

John McClure and Alexander Pagan each commanded companies of horsemen in Lacey's regiment.

The rebels lost 12 killed and 41 wounded; the British admitted a loss of 192. Colonel Hill was wounded and still carried his arm in a sling at the battle of King's Mountain on October 7th. Major Winn also was wounded. Captain McClure was mortally wounded and carried to Charlotte where he died on August 18th while Tarleton was hacking his comrades to pieces at Fishing Creek. Joseph Gaston, one of his men, was struck by a ball on the bridge of his nose that went under his left eye and out by his ear, fracturing the cheek bone and injuring the sight of his eyes and muscles of his jaw. According to Gaston, his brothers David and Ebenezer were killed, and Robert mortally wounded. Joseph Morrow, William Houston, Thomas Mays, John and Andrew Gray, Isaac Patton, Richard Martin, Samuel Hamilton, and Alexander Campbell were wounded. John Fairies, John McFadden, Henry Bishop, Samuel Craig, and Thomas Kelsey were killed. The Chester men acquitted themselves nobly and paid a heavy price for their bravery.

ANDREW FEASTER -- copied from FAMILY NOTES by Arthur Cornwall

Andrews Feaster -- the first settler of the name (the name was then spelled Pfesiter in 1740) emigrated to South Carolina from Lancaster County, Pennsylvania. His Father, Peter, died on the road and was buried somewhere in Virginia. From him was descended the family of FEASTERS OF THE BEAVER CREEK SECTION OF CHESTER COUNTY (SOUTH CAROLINA), better known as the Feasterville Township. He had a cousin, JOHN FEASTER, who came at the same time and settled in Edgefield County. He was the great grandfather

of Laurens Feaster of the "Dark Corner" section.

Andrew Feaster was twice married (first wife's name is not known) by the first wife only one child, MARTHA, was born. She married William Colvin of the Sandy River Section of Chester County, now known as the Halsellville Township and near where John Simpson lived (Martin Elam, who married Mary Phillips owned the plantation before it was bought by John Simpson (his Mother was Mary Colvin, daughter of John and Hannah Price Colvin). The Old Colvin cemetery is located on this property, just across from the old house, which was John Simpson's home. This Martha Feaster (widow of William Colvin), with some of her children, moved to Green County, Alabama. She lived to be quite an old lady -- over one hundred years old. Most of her children died before she did; several going farther West, into Louisiana and Texas. Her son, Thomas Colvin, married Savilla Mobley and their son, "Long" Thomas Colvin's daughter, Mary married Nehemiah Cobb; their son, Tom, married Dora Steele; their daughter, Fannie, married Hubert Gosa, great, great grandson of David Roe Coleman. (PETER PFEISTER)

Peter Pfeister came to America from the Canton of Berne, Switzerland, bring his wife and son, Andrew, and perhaps other children. This was before 1735. They settled in Lancaster County, Pa. Andrew changed the spelling of the name to its present form. About 1767 he married, in Philadelphia, a widow, Mrs. Peter Cooper (her maiden name was Margaret Frey (Fry)). She had three children: Adam, Even (or Elizabeth or Eliza, as she is named in the Will of her stepfather Andrew Feaster) and Peter. It is not known just when they left Pennsylvania, for the South; some tradition saying 1770, others nearer 1780. Peter Pfeister was then a very old man. There isn't anything known about his wife, Mother of Andrew. They feared the journey would be too much for him, and Andrew suggested waiting until his Father died before leaving Pennsylvania. But Peter insisted on their going and bringing him along, saying: "If I die on the way, bury me there, for Heaven is as near one place as another." They were six months on the way and Peter died in Virginia, and was buried there. They traveled on to Georgia; when they reached the Savannah River, news of the Indians being on the warpath further on, caused them to come back to South Carolina where they bought land. The first settlement we know of being the place known as Wyatt Coleman place, later where Mrs. Lizzie Lumpkin lived. Wyatt Coleman got the place through his wife, Ailsey Cockrell, who was a granddaughter of Andrew, and inherited the land after the death of her uncle, JACOB FEASTER, who married Margaret Connamore, and had no children.

(FEASTERVILLE IN BUCKS COUNTY, PA.)

Andrew Feaster's daughter, MARTHA, by first marriage. (Name of Martha's mother unknown). Martha married WILLIAM COLVIN when she was 16 years old and on that day she was told that Margaret was her stepmother, and not her real mother; she wept bitterly.

Andrew and Margaret FREY Cooper FEASTER'S children were: John, Jacob and Andrew (these three were born in Pa. Andrew, Jr. was killed by mistake, when he was thirty-two years old for Ezekiel Wooley, his brother-in-law, who was the Sheriff. The latter had summed a posse to assist in capturing a criminal, SHADROCK JACOBS, and Andrew Feaster was one of the number. It was after dark and Jacobs shot Andrew, who was riding the Sheriff's white horse and had on the Sheriff's hat. Twenty-five years afterward he was brought back from Texas and was hanged in Winnsboro (Fairfield County) South Carolina for the crime. He stated he had supposed the rider to be Wooley, whom he had sworn to kill, and he regretted, deeply, having shot Andrew Feaster, who was a silversmith, a cabinet-maker, a captain of the militia and a Free Mason.

Jacob Feaster married Margaret Connamore. They had no children. He left a good, solid estate to be divided among his brothers and sisters. JOHN married Drusilla Mobley. They had nine children: seven lived to be grown. The fourth child, Susan, married Moses Cockrell. Their children were: Margaret, who married a first cousin, Jacob Stone (son of Eve Cooper and Jacob Stone; John Feaster Cockrell married Susan Coleman.

The Fifth Child: Margaret, married Ezekiel Wooley and moved to Martin County, Georgia. They had one son, Col. Andrew Feaster Wooley.

The Sixth Child: Alice (or Ailsey) married Hundly McShone. They had several children: Ferdinand and Andy went to Mississippi and Arkansas. Judith married Isaac Coleman. She died in Mim County. Left three daughters: one married William Tucker, one married William Jeter, and the third married John Jeter.

(Mrs. Margaret Frey Cooper's children)

After the death of her husband, PETER COOPER, Margaret Frey Cooper married ANDREW FEASTER.

- 1. Eve Cooper, who married Jacob Stone, whose Mother was Frances Ruth Lyles, a member of the Chester branch of that family. Jacob Stone was a soldier in the Revolutionary war, and drew a pension as long as he lived. He married his first cousin, Margaret Cockrell (daughter of Moses and Susan Feaster Cockrell).
- 2. Adam Cooper. All of his descendants moved to Mississippi. His son, George, the crack rifle shot of his day married a Triplett of Chester County. His descendants all lived in Winston County, Mississippi. Adam Cooper's daughter, Margaret, married Capt. William E. Hill.

HISTORICAL RESEARCH MADE AND DATA COMPILED BY KATE (CATHERINE) N. WYLIE WHILE HISTORIAN OF THE MARY ADAIR CHAPTER OF D.A.R. CHESTER, S. C.

Sir John Yeamens and his wife, Lady Margaret Foster Berringer Yeamens, (1st husband being Lieut. Col. Berringer of the Barbado Islands,) came from the Barbadoes in 1663. He established himself on the Cape Fear, but later removed for convenience of pasturage to the Ashley and Cooper River. He was appointed Governor of the Carolinas in 1664 and served four years. Ramsey's History says he laid out the streets in Charleston and had comfortable houses built. His stepdaughter, and only child, Lady Margaret Berringer, married James Moore, 17th Governor, who was appointed Governor in Sept. 1700 to March 1703. He had ten children, his eldest son, James Moore, was elected Governor by election of the people in Convention in 1719. He married Elizabeth Neufville. They had seven children. Mary, his youngest daughter,

for whom we named our D.A.R. Chapter.

1719 Governor James Moore, the 24th Governor of Carolinas, his wife,
Elizabeth, (1st name mentioned in old Will).

married Baron William Adair from Scotland. She was the mother of Mary Adair

Mary Moore, daughter of James and Elizabeth Moore, married William Adair.

Mary Adair married John Nixon, who was killed September 8th, 1781. They had two daughters. She next married David McCalla. Their eldest son was James Moore McCalla, who first married Bethiah Hemphill. She had one daughter and died. The daughter, Bethiah McCalla, was raised by her Aunt Mary Nixon Hemphill and was my mother. His second wife was his own cousin,

Malinda Moore. She had five children. James Moore McCalla, who was educated at the Virginia University, died at Corinth, Mississippi. His family some in Texas - one in Idaho, Mary McCalla, married Isaac McFadden, only brother of Mrs. Mary McFadden Gaston, wife of Dr. John Gaston. Jane and Margaret McCalla married their cousins, Josiah and John Moore. They lived and died in York County, members of Bethesda Church. Francis Marion McCalla never married. Died at Cameron, Texas.

Judge Maurice Moore was the second son of the first Governor James Moore. Read his History in Wheeler's History of North Carolina. Also Alfred Moore, Judge of the Supreme Court, Grandson of the first James Moore.

Quaker Meetings and Records in South Carolina

The marriages of South Carolina Quakers have been taken from the Published minutes of the Quaker Meetings in South Carolina compiled and edited by William Wade Hinshaw in his seven books of American Quaker Records... The few Padget Creek records are from the private collection of the late Mrs. Mittie Owen McDavid of Birmingham, Alabama.

CHARLESTON, S. C. Meeting was organized in 1680 and it continued active until about 1815.

CAMDEN, S. C. Meeting was the second meeting in South Carolina and was begun by 1750 when a colony of Quaker from Ireland settled there.

PINEY GROVE in Marlboro County, S. C. was the third Quaker Meeting in South Carolina and was organized in 1755 and called Pee Dee Meeting.

BUSH RIVER Meeting in Newberry County was from 1755 to 1770 a branch of the Camden Meeting and no minutes show.

William Wylie, Chester Co. - will lists wife Margaret, daughters Elizabeth Kenmore, Margaret and Mary. Sons James, Joseph, William, Thomas, and Samuel. (Note - part of this family is buried at Old Stone Graveyard).

Thomas Garret, Chester Co. - will lists wife Hannah, son John Boatright (oldest son living in Hanover Co., Va.) Mary Jane, youngest daughter of John and Elizabeth Boatright, expecting to be living at Spirit Creek, Ga. - Thomas Garret Jaggers, son of John Jaggers of Sandy River, S. C. - Hannah Jaggers, daughter of Daniel Jaggers - Martha Jaggers, daughter of John Jaggers - Brother Elisha Garret - Heirs John and Elizabeth Boatright's oldest and youngest sons - Mary Garret, daughter of Elisha Garret - Thomas Garret, son of John Garret -

From the will of Hannah Garret, her heirs were Brothers John Jaggers - Nathan Jaggers, Jerimiah Jaggers, sister Martha Strong, niece, Elizabeth Walker.

William Rainey from Charles Atterberry, 20 Aug. 1794 - for 30 pounds - 30 acres of land from center of Welches Fork Creek - Branch of Sandy River - William Rainey purchased land from Nathan Atterberry on south side of above creek, except spring. Original grant to Martha Atterberry.

John Gill, Chester Co. - 2 Nov. 1790 - will lists wife Agnes, well beloved children - Samuel, Elinor, Elizabeth, Robert, Alexander, George Gill. If the child my wife is carrying lives, it is to have equal share - When Robert is 20, the plantation is to be sold and money divided.

Christopher Straight, Chester Dist., S. C. - (Blacksmith) 16 Dec. 1788 To George Straight of the same - for 30 pounds current money - This land was granted 28 Oct. 1765 by William Tryon, Esq., Dist. Gov. of N. C. to

same Moore as a plantation of 300 acres in County of Mecklenburg, but when line was resurveyed, found to be in York Co. on waters of South Fork of Fishing Creek on Crabtree Branch including a large meadow on the Wagon Road. James Moore sold to Christopher Straight 24 Feb. 1772 entered into the Auditor Generals office 24 Dec. 1772. Christopher now sells to George.

Christopher Straight and Rosannah, his wife, for \$33 by Jamison Cherry - do sell 54 acres on both sides of Rocky Mount Road, whereon the Widow Cherry now lives - being part of tract of 100 acres originally granted to Rosannah Wylie, now the wife of Christopher - 2 June 1802.

Christopher Straight (Farmer) for 15 pounds sells to William McKinney (yeoman) - land on East side of Fishing Creek, being 1/2 tract of 200 acres originally granted to Christopher Straight, 11 Aug. 1774, said half to be taken from N. E. and including the meeting house.

Note: the other half of Christopher Straight's original grant was sold to Pleasant William Ferguson-

John Price - 17 Nov. 1792 - daughters, Rachael Ramsey and Martha Moore. Grand-daughters, Rachael Ramsey, Margaret Ramsey, Neelet Moore, Mary Moore. Grand-sons, Wm. Ramsey, John Ramsey, James Ramsey and 2 other grandsons not named - Nephew John Carson - Sons-in-law, James Ramsey of Chester Co. and Thomas Moore of Spartanburg.

We notice that Editor Grist, of The Yorkville Enquirer, in looking around Rose Hill cemetery in York and in writing of some of the tombstones in the cemetery mentions Rev. William Crook, who was born in Chester county Sept. 3, 1806, and died near Fort Mill on Nov. 25th, 1866. Rev. Crook joined the South Carolina Conference in Dec. 1824, and was a minister of the gospel for 43 years. Mr. Grist says that Rev. Crook is the father of his good friend W. H. Crook of Fort Mill township.

Making note of the above article in The Enquirer we thought we might be able to locate an old will in Chester county which would show something of the Chester county family of the late Rev. Wm. Crook but we find no will which would throw any light on the matter. However, we do find administration papers but from them cannot connect the families since all members thereof are not shown on the estate papers.

The first administration papers of the Crook family in Chester county that we find are those of Soloman Crook, who apparently died in early 1800 or late in 1799. We find the citation notice was read on May 1st, 1800 and that it was witnessed by Thomas Neely. Elizabeth Crook was administratrix of the estate. We find a bill against the estate from James Massey and judging from the articles charged Massey must have been a merchant. This bill is dated October 1802. Without looking up deeds we are of the opinion that Solomon Crook was a resident of East Chester county judging by names mentioned in the papers.

Next we find the estate papers of William Crook, the appraisement being dated March 25th, 1817 and appraisers were John Culp, Wiley Crook and Elijah Hyatt. This paper was probated by Alexander Crawford, Justice of the Peace. Joseph and William Crook were administrators of the estate of William, Sr. A settlement of the estate of William Crook would indicate he left a widow and seven children. The children are not listed but we find receipts of John Wren for his wife's share of the estate, and also the receipts of Nancy Steel and Thomas Steel. We judge John Wren and Thomas Steel married daughters of William Crook. We also assume that in all probability Joseph and William Crook, who were administrators, were sons of the deceased.
