#### BIG "DOINGS" IN CHESTER THIS SPRING AND SUMMER!

If you are ever planning to visit Chester, the ideal time would be this spring or early summer. Our little town of 6500 people is all excited, aglow, and agog as it has never been before!

Chester was chosen by Highgate Productions out of a list of more than 60 small Southern towns as the site for the filming of Stuart Wood's best selling novel, the "Chiefs", which will be a six-hour miniseries on CBS and star that elusive-to-date personality (for the tube) - Charlton Heston. The filming is just beginning on this saga about a small Southern town and a series of killings that happen and are then investigated under a series of different regimes of 3 local police chiefs (to be played by Wayne Rogers, Brad Davis, and Billy Dee Williams). Heston will portray a banker. Also on board will be Keith Carradine and Stephen Collins. The man who directed "Shogun", Jerry London, is running this show for which CBS has only the highest expectations.

The major part of the filming will be done in downtown business area, portions of which have been closed to vehicle traffic for several weeks while utility poles, hydrants, parking meters, etc. have been removed, camouflaged and store fronts changed to look like those of 1919. Dirt now covers the pavement and curbs, living trees and shrubbery transplanted and a few cars of that era, as well as wagons, buggies, horses, and mules brought in to complete the desired appearance.

It's a great time to come to Chester! Come and find out more about your ancestors who were perhaps a part of this scene and times! Visit our Museum; the Caroliniana room of our public library; clerk of court's office where old deeds, etc. are recorded; Judge of Probates's office where wills, etc. are filed; the many historical sites, some of which go back into the 1700's; many of the preserved old churches with their well kept cemeteries; and of course; your own genealogical society!

#### A McFADDEN CHRONOLOGY - 1710 to 1900

The Scotch-Irish McFaddens of Chester County, S. C. have their roots in Ulster, North Ireland and in the lowlands of Scotland; however, both groups had their origins in Scotland.

The compilation of notes for this book which is authored by William T. Skinner of Matthews, N. C., a certified genealogist, records searcher, and a member and director of our society, as well as several others, is extremely well documented and indexed. It begins with the birth of Candour McFadden in 1710 who is said to be the first McFadden in Chester County and continues through the lines of the author to 1900 in Lamar County, Texas, where the 1900 census shows there were, at that time, more than 45 McFaddens in that county alone.

In all, there is some information on 436 McFaddens who had roots in Chester County prior to 1900, plus the allied names of Allen-Anderson-Ayers-Barham-Blair-Bolch-Brown-Buford-Crawford-Cooper-Culp-Dailey-Davis-Dawson-Erwin-Ferguson-Gates-Gill-Graham-Hyatt-Jones-Lane-Latta-Lewis-McCullough-McKinney-McKnight-Moses-Nunnery-O'Neil-Patton-Pitts-Silvertooth-Skinner-Smith-Steal-Steele-Taylor-Walker-Williams-Wilson-Wylie, plus 111 other surnames with McFadden connections.

The Chester County Genealogical Society is very proud to have been selected by Mr. Skinner to publish "A McFadden Chronology" which is now available for \$10, which includes postage and handling.

The following article was taken from the scrapbook of the late Arthur Cornwall.

#### SKETCH OF THE McCREARY FAMILY

Prominent in Early History of Chester County - Produced Many Distinguished Men. (By Arthur Cornwall)

Samuel and John McCreary.

Looking back through the years one finds two names, both linked with distinguished services to mankind, John McCreary and his brother, Saml. McCreary. Their father's name is not known, but their mother was a daughter of Justice John Gaston, a widely known patriot of the American Revolution. They had one sister, Margaret, who married a Mr. Telford. It may be truly said of her that she was not less distinguished in her sphere than her brothers in their respective callings. She lived to be very old, and died a most honored member of the Presbyterian church.

Samuel McCreary never married, but lived near Fort Lawn with his brother, John, who married a Gaston, a daughter of the Rev. Hugh Gaston, author of a most laborious and painstaking work called "Gaston's Concordance," a work that no doubt contributed greatly to his proficiency as a Bible scholar.

John McCreary was twice married. His second wife was a widow, Mrs. Powell of Virginia. By the first marriage the following children were born, John McCreary, who moved to Texas; William McCreary, a medical doctor, migrated to Mississippi; Esther, who married Dr. Kell, and Samuel McCreary, a planter, who lived and died at his plantation home near Great Falls. He built a large and handsome home, which he always kept open to his friends. There was much of interest in and around Beckhamville in those days and his house was the scene of many happy "get-to-gether" occasions. This house was destroyed by fire.

Children by the second marriage were Melissa, Martha, Monroe and Judson. Monroe died when young. Judson married Martha Barkley. Of this union two children survive, Mrs. Irene McCreary Peden, of Chester, and Sheriff John McCreary of Winston-Salem, N. C. Melissa married Dr. W. J. Hicklin. They had one daughter, Melissa. After his wife's death Dr. Hicklin married Martha, his first wife's sister, and a daughter was also born to them. Her name was Martha.

Both John McCreary and Samuel McCreary served in the Revolutionary War. After the war Samuel McCreary went into complete seclusion for a number of years during which time he was preparing himself for his life work. In notes on Pacolet church, Union county, mention is made that on October 14, 1788, the Rev. Joseph Camp administered baptism to William Gaston, Robert Elliott, Samuel McCreary and Mary Williams.

From the meeting in November, 1790, the following is taken: "Brother Samuel McCreary mentioned to the church, there were several brethren of the Baptist order in the vicinity where he lived in Chester county, on Fishing Creek, that were not united in the constitution of this church. But the distance being 40 miles could not attend the stated days of meeting. If the church would grant them supplies in preaching and administering the ordinances of the gospel at occasional opportunities they would consider it their duty and privilege to be in professed fellowship and members with this church. Agreed. Brethren Richard Woods, John Palmer, William Gaston, John Reid and Brother Fowler, being requested to attend the second Saturday and Sunday following to assist in the examination of those members in order to their reception as members of this church."

Thus the little band on Fishing Creek as an arm of Pacolet church, and remained as such for more than three years. The arm on Fishing Creek was organized as a church on September 22, 1794, as the following record shows: "This day Brother Fowler, with the assistance of Brother McDougal, is to constitute a part of this church on Fishing creek with whomsoever may unite with them." Samuel McCreary being one of the number on Fishing Creek, of course went into the new organization, and so we lose sight of him from the records of Pacolet church.

Mr. McCreary was a Calvinist and preached it with great boldness as he understood it. He was equally clear in his conviction that baptism by immersion was the only mode of Christian baptism and one who knew him wrote some years ago, "in all the years of the writer's life he has never heard one who could give better reasons for his conclusions." He lived and thought far in advance of his time. He was the author of the first temperance address ever delivered in South Carolina and in connection with the Rev. J. B. Davie, of the Presbyterian church, organized the first temperance society. It took place in the 'twenties' and near Hopewell Baptist church (destroyed by fire in the autumn of 1927,) near Bascomville.


It is said that all great men owe their greatness to their mothers and when in the providence of God Samuel McCreary was deprived of his mother's counsel and care at a very tender age, yet it is fair to presume he inherited from her his high qualities of mind and heart, patriotism, courage, intelligence, integrity, with a strong religious nature, qualities that of themselves command the respect and admiration of the wise and good. These qualities, when as they were in his case, brought under and controlled by the religion of love, constituted the Rev. Samuel McCreary, the highest style of man, and his life a blessing to the world.

No less remarkable in his achievements was John McCreary, his brother. A surveyor of much ability, a progressive planter, member of the State Senate, and at one time sheriff of Chester county. From March 4th, 1819, to march 3rd, 1821, he was a rember from Chester county to the Sixteenth Congress. Although, like his distinguished brother, he did not attend college, he received a splendid educational foundation at the home of his grandfather, Justice John Gaston—one of Chester county's most remarkable patriots of the Revolutionary period.

Rev. Samuel McCreary served Hopewell Baptist church for sixty years. During his ministry Harmony and Fort Lawn Baptist churches were established as colonies from this church. In person the Rev. McCreary was about six feet two inches in height, with a body formed for strength and endurance. His face reflected his leading characteristics; courage and intelligence. In his old age his long white hair gave him a patriarchal appearance and when leaning on the pulpit talking in a conversational way was said to bring to mind Jacob when he was old worshipping, leaning on his staff and blessing the sons of Joseph.

John McCreary was born in 1761 and died November 4, 1833. Samuel McCreary was born in 1760, and died in 1834. Samuel McCreary preached his first sermon at Hopewell in 1807, and his last in the same church in the spring of 1834. John and Samuel McCreary are buried in the graveyard at Old Richardson church (Burnt Church), near Wylie's Mill. In this same cometery lie many of the most faithful men and women produced in Chester county.

## JAMES HARBISON IMMIGRANT - PATRIOT - RULING ELDER By Mary D. Boulware

James Harbison was born in County Antrim Ireland. He was 6 years old when he arrived in Chester County with his parents, Patrick and Jane Harbison, in 1768. His grandparents, Dugal and Elizabeth Balentine came at the same time.

When a mere lad of 16 he entered the S. C. militia and served a tour of 3 months. His company was marched to within 6 miles of Charleston, changed course to Purysburgh on the Savannah River, proceeded up river very near Augusta, then returned home.

Within a few days James Harbison volunteered his services in Capt. Nixon's company. He marched to Augusta where his company camped for 5 weeks. They then crossed the river and went downward to join Gen. Lincoln's army and returned home.

About one year later he volunteered and was at the battle of Rocky Mount, Hanging Rock, and at Fishing Creek when Sumter was defeated. Shortly afterwards he was with a scouting party near Camden when they captured 96 Highlanders and 32 wagons laden with provisions.

In May or June 1781 he again volunteered under Capt. Adams and Col. Lacy. He described this tour thusly - "Our company joined Gen. Green's army on its march to Orangeburgh - there Gen. Green reconcitered the place and then marched a part of the forces to the High Hill of the Santee. Our company with other companies marched from Orangeburgh at Biggins Church. I was with a detachment at the destroying a bridge near the church. The enemy retreated from the church in the night-time - we pursued them and a skirmish ensued at Quimby's Bridge, we captured a number of prisoners belonging to the 19th Irish Regiment - we still pursued the main body of the enemy to Capt. Shubrick's Plantation where we engaged the enemy; the battle lasted about 45 minutes - we returned leaving the enemy in possession of the field and crossed at Nelson's Ferry and came home."

His final tour was of six months duration. His terms of service altogether exceeded two years.

On the occassion of the 101st anniversary of Catholic Presbyterian Church, Rev. William Banks in his address, speaking of James Harbison, Esq. said, "Although young, he bore an honorable part in the old Revolutionary War for American Independence. He was with Sumter's forces at the mouth of Fishing Creek, when they were surprised and routed by the British and Torics under Tarleton. As the troops of the enemy suddenly rushed into the camp of Sumter, and poured a deadly fire upon his men, Harbison sprang to his horse, which had been turned loose to feed, and without saddle or bridle, mounted and escaped. As his horse leaped the bars before him, a ball from the enemy cut off his cued hair. commemoration of this preservation from death, he ever afterwards wore his hair tied up in a long cue behind. Some persons present to-day may remember the venerable form of the Christian patriot, as, for forty years a ruling elder of Catholic, he bore to his fellow communicants around the sacramental table, the symbols of his Savior's dying love, and as in tall and dignified form, in the Precentor's stand, with that clear ringing voice which in days of yore had been often heard above the storm of battle, he led the congregation in celebrating the praises of God in the sacred songs of Zion."

He was once cited for contempt of Court when he refused to serve as a juror. Upon being questioned, he said it was against his religious principles to swear. He was excused.

James Harbison married Margaret McCrorey King, to this union was born the following children, James, Jr., Adam, William, Janet, John, and Thomas.

James Harbison, Jr. was also a ruling Elder of Catholic Church. He served for a number of years and it is said that he received the largest popular vote ever given in the congregation, in the election of an elder.

Margaret Harbison died in 1819. Four years later on Dec. 25, 1823, James Harbison, who was then 61, married 15 year old Jane Jamieson. They had two daughters, Sarah and Mary.

James Harbison died in 1835, after having lived his entire life, except for the first six years, on the same land his family settled on upon their arrival in Chester County. He was laid to rest in the Harbison Burying Ground. His tombstone was inscribed -

Sacred to the memory of James Harbison, Esq. Born 15th of August A. D. 1762

Died November 2nd 1835

Aged 73 years, 2 months and 18 days

A Soldier OF THE REVOLUTION, having served in the American Army more than two years and engaged in several battles that secured freedom for his country. He was one of the earliest members of the Presbyterian church of Catholic, of which he was for forty-two years a Ruling Elder. Blessed are the dead who die in the Lord.

In Feb. 1850 in the Minutes of Session of Catholic Church was recorded - "Upon application, certificates of dismission were granted to Mrs. Jane Harbison and her daughter, Miss Mary Harbison, who are about to move away to the North West."

In 1851, Jane Harbison applied for a widow's pension, at which time she was 43 years of age and a resident of Perry County, Illinois. She died in Pinckneyville, Illinois in 1890.

Note: Patrick Harbison, father of James Harbison, and q.q.q.qrandfather of the writer, served in Brandon's Reg't. during the Revolution.

Mrs. Martha Hawkins passed the following clippings along to us. They were published in 1935 and 1936 in the "Chester News".

#### HERE AND THERE

Many years ago John Alexander Marion came to Chester county from Ireland and located in the Richburg section. During his life he accumulated more than one thousand acres of land, which was divided among his children after his death.

Recently I noted where Mr. Marion bought a tract of 201 acres of land at a Clerk of Court sale and paid \$1,256.25 for it. The land was described as being on the waters of Rocky Creek and bounded by lands of J. R. Hicklin, J. M. McDaniel, O. Barber and others, and a full description of which appeared on a plat made by C. H. Ragsdale, December 1888 and on file in the office of the Clerk of Court in the case of Sarah S. Scoggins and Martha Howard vs. Leroy Smith, as administrator of the estate of John Smith, deceased. The land was sold for petition and bought by Mr. Marion on March 7th, 1889, almost fifty years ago.

By referring to the will of John Smith I found he had the following sons surviving: William Smith of Drew county, Arkansas; Hemphill Smith of Shelby county, Tennessee; and Leroy Smith of Tifton county, Tennessee, being residents of the above named places in 1872. Daughters surviving were Mrs. Nancy Kitchens, wife of Smith Kitchens, who lived in the Richburg section; Mrs. Sarah Scoggins, wife of James Scoggins, who lived in the Hickory Grove section of York county, and Mrs. Martha Howard, wife of Robert C. Howard, who lived at the home place of John Smith. The will also mentions a daughter of Lawrence Smith, deceased, another son.

From the records it is shown that John Smith made a will while his daughters Sarah and Martha were still single, leaving his property to

them. Following the making of this will both married and later John Smith made another will, dividing his property among all the children. I might add that several years before the death of John Smith his son, Riley Smith, died leaving 165 3/4 acres of land. Riley was not married and his surviving brothers and sisters deeded their interest in this land to their father, John Smith.

The records would indicate that there was some dissatisfaction about the two wills and the matter went into the courts. Judge J. H. Hudson was the presiding judge and decided that the property should be sold and the proceeds equally divided among the heirs. An appeal from this decision was taken and the case went to the State Supreme Court, which rendered a verdict upholding the decision of Judge Hudson, and the property went to sale.

A transcript of the evidence is a matter of record and Here and There read over it. Mrs. Sarah S. Scoggins testified that Riley Smith, her brother, died in 1871 and that he lived at the home of his father up until the time of his death and that he attended to his father's farming business from the close of the war (Civil) until his death. She testified that her father was 86 years of age when he died and that at the time of his death she was fifty-one years of age. She was married on May 12, 1882 to James Scoggins of York county and went to that county to live.

Mrs. S. J. McDaniel testified that she had lived close neighbor to the Smiths for 15 or 20 years and that Mrs. Scoggins and Mrs. Howard took care of Mr. and Mrs. John Smith during their last illness and death, both of whom were in bad health for some time before their deaths. She said that Hemphill McDaniel drew up the first will for Mr. Smith at "our house".

Another witness was R. R. Peeples, who lived near Pineville, N. C., and married a step-daughter of Mr. Smith. He told of Mr. and Mrs. Smith coming to see he and his wife, making the trip in a buggy, a distance of about thirty-five miles. Among the other witnesses we find P. B. McGarity and his wife, Mary Frances, and also her mother, Mrs. Lucy Watt. They lived on the Smith farm.

Riley Smith, above mentioned, was a Confederate Veteran, having been a member of Co. H, 24th Infantry. William Smith was also a soldier and was a member of Company F, 23rd Infantry.

Sanders and Whitlock were attorneys for the plaintiffs, and Hemphill and Brice for the defendants.

\*---\*

On the old Craig McFadden farm, located a mile or so from Knox's Station, is an old cemetery with some five or six tombstones in it. The cemetery is near the foot of a hill some distance from the site of the old McFadden house, which today is in a very dilapidated condition. This farm consists of 152 acres and was bought by the late R. Curtis Stewart in 1894, from E. J. Garrison. The deed, in part, says: "It being the identical land devised to the said E. J. Garrison by the late Ed. McFadden by his will of record in the Probate Court for said county, and inherited by the said E. J. Garrison from her father, the late J. Craig McFadden. Except a farily graveyard of one-half acre within the boundary of said premises known as the McHenry graveyard."

There are no McHenrys in Chester county at this time that I know of but in looking the records I find the estate papers of Hugh McHenry were filed in 1847. The citation notice is dated April 19th, 1847, and administration was being applied for by Alexander McLester, who spoke of Hugh McHenry as his son-in-law. The citation was read at a Company Muster on April 24th, 1847 and signed to this effect by H. Simpson. To know something of the membership of that company would be

of interest to many. The appraisers of the estate were Hance Wylie, Peter Wylie and James H. Pardue.

The sale of personal property was held on May 18th, 1847 and among the purchasers at the sale I note Thomas Harbison, John Hood, James C. Hicklin, Samuel McDaniel, John Agnew, Robert Dale, Mary McHenry, Alexander Walker, Samuel McCaw, James McGarity and Matthew McClintock. The total of the sale amounted to \$236.62.

Among the items paid out I note one to Jamieson for the coffin, \$4.50; Dr. A. Peay for services, \$15.00; and that Lilly Wylie received \$122.00. I have an idea that this family of Wylies were related to the McHenrys as Duncan Wylie is buried in the above mentioned cemetery.

On July 3, 1850 it is noted that Mary McHenry was appointed guardian for two children, Mary Jane and Elizabeth McHenry. No doubt Hugh McHenry was buried in the family graveyard but if so, there is no marker to him and it is also evident that he died young and left his widow and the two children mentioned above.

There are a number of unmarked graves in this old family graveyard and it might be added that years ago the section mentioned was rather thickly populated but today few people will be found in that section. The farm is on a road which at that time went from Knox's Station across to the Peden's bridge road, but I understand the road is almost impassable now. Among the boundary lines mentioned in 1894 were James Blainey, W. B. Agnew, Henry Torbit, W. F. Buchanan, Mrs. M. Gellespie, and Mrs. M. J. Knox.

#### DEATHS

Died in Union District, S. C. on the morning of the 23rd Dec. 1851, Mrs. Sarah Steen, at an advanced age. She was the daughter of Col. James Steen of Revolutionary fame, who was killed in the War. She was never married but had a number of children. Upon the whole was a good woman, a kind neighbor and warm friend.

Col. R. S. Sims, merchant, of Unionville, died at the residence of his father, Mr. Sims, on Broad River on the evening of July 16, 1855.

Mrs. Nancy McJunkin, relict of the late Joseph McJunkin, Esq., died Jan. 15, 1856 in the 60th year of her age. She was the daughter of the late William and Rebecca Sartor. She united with the Presbyterian Church at Cane Creek.

Died at her residence in Union District, S. C. March 15, 1856, Mrs. Lettice Brandon, in the 83rd year of her age. Mrs. Brandon was the daughter of the late William Kennedy, Esq. of Brown's Creek. Her husband was George Brandon, who died many years ago. She was the mother of 3 children, James K., Benjamin and Mary Brandon.

Died at his residence, Unionville, S. C., May 1st 1856, Dr. James McKibben Gage, a man of talent, generosity, and many good qualities of head and heart. But alas, he gave way to the fascination of the Destroyer and died in the midst of his age.

Died at his residence, Unionville, S. C. June 2nd 1856 - Capt. John Joiner. He is said to have been 68 years of age, to have been a resident in the district most of his life and for many years past in the village and a member of the Methodist church. He was a guiet, orderly, industrious citizen.

Died at her residence in Union District, S. C. Dec. 1st 1856, in the 89th year of her age, Mrs. Frances Dogan. Her maiden name was Crenshaw. She was first married to Mr. McDaniel and after his death James Dogan, Esq. Her life after her first marriage was spent 10 miles East of

Cook's Bridge on Tyger River. She was the step-mother of Mrs. Sarah Gist and the mother of Mrs. Elizabeth Gist, Robert McDaniel, Mrs. Matilda Jeter.

Died at residence of her husband, Stephen Johnson, Esq. in Union District, S. C., March 8, 1857, Mrs. Eliza Johnson, aged about 47 years. Mrs. Johnson was the daughter of Isaac Gregory and his wife Elizabeth, whose maiden name was Hawkins. She was a quiet, orderly, industrious woman, but was subject for many years to spells of insanity, which rendered her a terror to some of her friends. Her husband and six children survive her.

Died Jan. 30, 1858 at her residence, Union District, S. C.,  $\underline{\text{Mrs}}$ . Rachel MacBeth. Mrs. B. was old. She was a sister of Maj.  $\overline{\text{T.}}$  Young and C. Young.

On the same day at the home of F. Hobson, <u>John Beaty</u>, son of Col. John Beaty. He was an amiable young man, but had been sadly addicted to drink for a time past. His death probably had some connection with his habit.

Died in Union District, March 16 or 17th 1858, Mr. Aaron Crocker, an aged citizen. Mr. C. was considered a good miller and an orderly citizen.

Miss Isabelle Farr died May 1858.

William Cotton, son of Mr. M. Cotton died in May 1858.

Mrs. Askew, wife of Dr. W. N. Askew, died in same month.

Dr. Samuel Wright of York District died Aug. 1858.

Dr. G. M. Bobo died about Oct. 1858.

Six or seven Parham Hamilton family died in 58.

Died Dec. 5, 1858 near Brick Church Baptist, Miss Cornelia Wilson, daughter of William and Evaline Wilson.

William Numphries, Jr. died August 1858 of consumption.

Died Feb. 11, 1859, Mr. James Kennedy Brandon, son of George Brandon, Esq. and his wife, Lettice Brandon, who was the daughter of William Kennedy, Esq. He was born on Brown's Creek.

Died in Union District, S. C. Feb. 27th, <u>Mrs. Eleanor P. Means</u>, wife of Henry Means, and daughter of Charley Cunningham. She was first married to Mr. Baxter.

Died in Union District, about the 1st of March 1859, Mr. John Thomas, Sr. Ne resided near Tyger River in the region of Maybinton, was one of the oldest citizens and is said to have fallen dead.

In the course of the winter, <u>B. Davis</u>, another old citizen, resident in the vicinity of Unionville, died in a similar way.

Died March 5th 1859 at his residence - Bennettsville, S. C., the Rev. P. E. Bishop. Mr. B. was a native of Virginia.

Died at his residence on Brushy Creek, Union District, Abram McJunkin, Esq., April 29th 1859, in the 73rd year of his age. He was the third son of Major Joseph and Ann McJunkin. He married in early life Margaret, daughter of Capt. John and Sarah Savage, with whom he lived till her death in 1845. Ruling elder of Cane Creek Church for a long period. He was always a quiet and orderly man and esteemed citizen of sterling worth.

GATHERING GASTONS By Mary Kell Wade

Since publication in the December Bulletin of an article on Robert Gaston of Little Lynches Creek, I have received letters from members in sixteen states. These readers were either connected through Gaston or collateral lines. Thanks to those who sent information on Gaston, Carson, Hillhouse, Cunningham, McCreary, Kell, McCreight, and other early Gaston connections in this area of South Carolina. In future issues, documented information on early Gaston lines in upper S. C. will be given in my column entitled Gathering Gastons. This may not be easy, since the names John, James, Joseph, Robert, William, Alexander, and Hugh were contained in all early Gaston families.

What better way to begin gathering Gastons than at a Gaston Family Gathering. An article from the St. Louis Globe Democrat, 3 September 1890, describes such a reunion. "Centralia, Ill., September 2, 1890 - The annual reunion of the historical and patriotic Gaston family will begin tomorrow at Mt. Moriah Church, six miles east of this city, and will continue two days. This reunion, like all its predecessors, is attended by hundreds of the descendants of William Gaston who came to Illinois from South Carolina."

The article stated that William Gaston, born 10 July 1757 served his country for five years during the Revolutionary War, settled down in South Carolina until his children were grown, emigrated West, settled in Kentucky for several years and then came to Illinois, settling near his son Samuel Gaston. He died in 1838, having reached the ripe old age of eighty-three years. He was buried in the Old Covenanter Cemetery.

"His oldest son Samuel Gaston came to Illinois in 1819, and settled on a claim near where Walnut Hill now stands. While attending a house-raising, he contracted a severe cold which caused his death in 1826. He left a family of eight children, seven married and reared families.

William Gaston, Jr., the second son, was a soldier in the War of 1812. He was the father of thirteen children, twelve of whom reared families, and five yet living (1890).

John and Robert Gaston settled in Bond Co., Ill., where they lived as farmers in the pioneer days of Illinois. The former had two sons in the Mexican War where one of them fell and sleeps on Mexican soil.

Margaret Gaston, the oldest daughter married Thomas Kell in South Carolina. He followed his brother-in-law to Illinois in 1822. He reared twelve children, all of which are now dead except Thomas Kell of near Foxville and Alexander Kell of this city, who is now 83 years old."

Mrs. Margaret Kell, according to the newspaper article, is supposed to have selected the sight for the Old Covenanter Church and the sight of the cemetery in which she was the first person to be buried.

Thomas Kell, son of John and Jane Morton Kell, who emigrated from Ireland in 1772, was born on Rocky Creek, Chester District, South Carolina in 1774. He died 21 March 1844 and is buried in Old Covenanter Cemetery, Marion Co., Illinois.

Margaret Gaston Kell, daughter of William and Mary McClure Gaston, was born in S. C. in 1783. She and Thomas were married in S. C. circa 1799. She died 18 August 1831 in Illinois.

Thomas Kell was married to his second wife Mary Little in 1834, Marion Co., Ill. She died 14 December 1869 and is buried in the Old Covenanter Cemetery.

Thomas and Margaret Kell reared twelve children, ten remained in Illinois; two sons, William and John, returned to Chester County, S. C. There appears to be considerable communication between those in Illinois and South Carolina until the death of John in York County, S. C., in 1854. Then there were several years of separation because of war. In 1886, Dr. Samuel Alexander Kell of York County, S. C. (my grandfather) wrote to Centralia, Illinois, to find the brothers and sisters of his father, Dr. John G. Kell. The following is a copy of an answer to that letter.

Centralia, Ill. Marion Co. Feb. 22, 1886

"Dear Nephew-

The letter sent to Postmaster "Kell" - He wished me to reply as I could give you more information than he could.

Thomas Kell and family left Chester Co. S. C. Sept. 16, 1822, the whole family except brother William.

He attended lectures in Lexington, Kentucky the following winter. He was the oldest of the family born Aug. 3rd, 1800 - Jane Kell born Mar. 27, 1802 married James Telford - John Kell born Mar. 22nd, 1804 -It seems strange to me that you write his name with a G. must have adopted the G. in later years - as he and myself plowed corn and worked together as much as three or four years. Samuel G. was the next one born Apr. 13th, 1806. He died during the War of the Rebellion. next was Martha Ann Kell - born May 9, 1808. She married a Boggs, both dead. The next is myself Alexander Kell born May 19th, 1810. Will be in less than three months 76 years old, living with my wife 52 years. We are in good health at present. We have 6 living children, 4 boys and 2 girls. One son dead John Reiley Kell - 3 girls the oldest girl about grown Mattie Ann. The next Margaret Kell, born March 20, 1812. She married a "Storment" they had 5 children all living, they are both dead a number of years. The next Thomas Kell born Oct. 6th, 1814 - he has the largest family of any of the brothers some 4 or 5 dead. James Kell born Jan. 17th 1817 - had a family of 4 all living. He and wife and one son dead some time.

The next Eliza Kcll April 19th, 1819 - Married Reiley Little, lived but a few years died in 1842 leaving 2 girls. Reiley Kell born June 21st, 1821 was about ten months old when left the south, died about 1 year ago (1885) his wife died a number of years ago - Matthew Cannon Kell was born in Ill. Apr. 15, 1825 - youngest of the family, died 1 year ago in Centralia - he is the father of the postmaster and three living. The two youngest brothers Reiley and Matthew Cannon died with one month of each other, a year since.

Brother William after attending lectures in Kentucky came to Ill. in March following - practiced medicine in Randolph Co. in this state, attended lectures the next winter, then went south again. In the spring of 1825 he married his cousin Esther McCreary, living together but a short time - Wm. died Sept. 14, 1825.

John, your father studied with Uncle John Kell in Princeton, Indiana, one winter. In the early part of the fall John and father went back to S. C. He then studied under Dr. Joe Gaston for some time. John lost his health with liver complaint - Brother Samuel going to S. C. on business for father when leaving for Ill. in the spring, John

came with him - that was the spring of 1826. Your father in bad health and about ready to give up that he could get well. He however, kept round doctored some of the people and for recreation take the rifle and go to the woods - hunting he could keep fresh meat most of the time, by fall he was in good health, looked well and went back to South Carolina.

We would like for you and your brothers to write often. You have a good many cousins here. Would like to hear from you if you know anything about Uncle Alexander Kell or his son Alexander. I would like to hear from them.

Now in conclusion we would like for you and your brothers to visit us - you have lots of cousins here in Ill., but only 2 uncles living Thomas Kell and myself.

Very truly yours Alexander Kell"

Proof that John Kell did add the Gaston to his name as suggested in the letter appears in the estate settlement of Dr. William Kell in Chester Co. probate records. On 4 Oct. 1825, John Kell was appointed administrator of his brother's estate. On 4 May 1840, James Crain, an heir-at-law of Dr. William Kell, requested another accounting of payments made to Esther Kell. This accounting was given by the administrator John G. Kell. He probably added the G. to distinguish him from his cousin John F. Kell living in the same county.


The Dr. Joe Gaston referred to in Alexander Kell's letter may have been Dr. John B. Gaston, son of Joseph Gaston. According to family tradition, John Kell studied with him. The minutes of Old Catholic Presbyterian Church in Chester County refer in 1846 to Dr. John Kell and his wife Elizabeth. They remained on the church roll until the early 1850's when they moved to Bullock's Creek Presbyterian Church, York Co., S. C. Both are buried in that cemetery.

#### DEATH OF J. M. FUDGE (1911)

Aged citizen Passes away after Week's Illness-Buried today at Richburg.

Mr. J. M. Pudge, one of Chester's oldest and most respected citizens died at his home on Columbia Street Saturday evening at midnight, after one week's illness. The funeral services were held at the home yesterday afternoon by Rev. D. G. Phillips, assisted by Rev. J. II. Simpson, and the remains were taken to Richburg this morning for interment in Union graveyard.

The deceased was a native of the Lewisville section of Chester County, and was seventy-five years of age. He served throughout the War, and made as true and gallant a soldier as served in the armies of the Confederacy. He was often assigned to posts of particular danger and risk on account of his fearlessness and love of duty, and had the reputation of never shirking his duty. He was a consistent member of the A. R. P. Church; was honest, industrious, and upright; and leaves behind an honored name. He is survived by three sons: C. S. Fudge, of Chester; James Fudge, of Columbia; and Dr. Walter Fudge, of Catherine, Ala.

#### IN MEMORIAM.

J. M. Fudge, who died at his home in Chester at midnight on Saturday, the 18th inst. was born and reared in the Lewisville section of Chester County. He was the youngest of the four children of Charley Fudge by his first wife, who was before her marriage Rhoda Nunnery. A little more or less than a century and a quarter ago Lemuel Nunnery married Polly Culp, who was a sister of John Culp, the father of the late Col. John R. Culp. Lemuel and Polly Nunnery reared five children. four sons and one daughter, viz: Amos, Henry, Ben, John, and Rhoda.

Ben and John went to the West, Amos and Henry lived and reared large families, and died in old age not far from the place of their birth. Rhoda, as above stated, married Charley Fudge, and by this union there were four children, viz: Eliza, who was married to Abram Adams and after his death to C. R. Sibley, and is again a widow and still living, H. W., J. B., and J. M., the subject of this sketch. Charley Fudge's second wife was Rachel Kline, and they reared four children, one son and three daughters. Jane married J. D. Collins and died a good many years ago. Mattie died unmarried. Barbara married W. P. Ferguson, his second wife, and is still living a widow. W. A. Fudge married a daughter of Jamison Cherry, and he and his wife are both living.

J. M. Fudge, his half brother, and his brother-in-law, C. R. Sibley, on the 11th of April, 1861, enlisted in the company which afterwards became Co., "A", of the 6th Rgt., S. C. V., and served through the entire war and stacked arms at Appomattox, Va., on the 9th of April, 1865.

J. B. and H. W. Fudge served in Co. "A", 17th S. C. V. until the summer of 1862, when they were transferred to the 6th Rgt. These four brothers and their brother-in-law served through the war, and all of them lived to be old men. C. R. Sibley died three or four years ago well advanced in years, and now J. M. Fudge goes at the age of 75 years. H. W. at 80, and J. B. at 77, are still living.

After the War J. M. Fudge married Jane, a daughter of the late Jamison Cherry, who reared his family in the community of Union A. R. P. Church. He and his wife, who died about ten years ago, reared four sons: C. S., William, James, and Walter. William died several years ago. The other three survive to mourn the death of their father.

I would not use extravagant language in speaking of the life and character of my dear old friend and comrade. I have known him intimately from boyhood to old age, and am free to testify that he would not knowingly do or commit a wrong against his fellowman. He was honest and upright in his dealings with his neighbors, and no man despised meanness, littleness, and untruthfulness more than did J. M. Fudge. In early life he joined the A. R. P. Church and while he did not reach his own ideal of the Christian life, he could always be found on the right side of questions of civic righteousness. There was no better soldier in the Confederate army than he was. He was rarely ever sick, never shirked his duty, and was in nearly every fight in which his regiment was engaged, and these came quite frequently during those four years of strife and blood. He often served on the ambulance corps as a litterbearer. Our bravest men were usually chosen for this service, as men lacking in courage could not meet the requirements.

J. M. Fudge was a good soldier, a good citizen, a good husband, a kind father and a steadfast and loyal friend. He will be missed in his home, in his church, and in his community. His going away is like the removal of an ancient landmark. The Lord bless and comfort his bereaved loved ones, especially the dear little grandchildren that he loved so tenderly.

MS., Military Affairs, Petitions
Historical Commission of S. C. Columbia.

(December 10, 1792)

To the Honorables the Senate and the House of Representatives in General Assembly at Columbia met.

The PETITION of the SUBSCRIBERS humbly showeth that your Petitioners are much alarmed by a determination lately in the Court of Common Pleas in Charleston on a Tryal between John Christian Smith, Plaintiff, and Hugh Knox, Defendant, concerning a Negro captured from the British Army in the late war and Sold at Publick Sale by the order of the then commanding officer of Gen. Sumter's brigade and purchased by the said Hugh Knox and the Money arising from said sale was divided amongst the Captors as a reward for their extraordinary services. The property of which Negro was thought to be sufficiently secured to the purchaser by an Ordinance of the General Assembly passed on the 21st of March 1784 intitled, "An ordinance to Indemnify Brigadeer General Sumter and the Officers, etc." On Tryal it was determined - "That the Officers were indemnified in Making such Sales but the purchasers not indemnified nor Kustifiable in holding the property purchased at such Sales and Whereas many of your Petitioners are in possession of Negroes and other property which was disposed of or Sold by the Orders of General Sumter and his Officers and are as lyable to Law Suits for holding said property as the defendant in the case above recited and when prosecuted must expect the Judgment. Whereas the said Hugh Knox did apply by Petition to the Legislature at the last Session and no determination as yet has been given on said Petition, and several of your Petitioners being Lyable to Suits as the said Knox and must expect to share the same fate with him. Therefore humbly prays that their case with his may be taken into most serious consideration and that they be Quieted and secured in the possession of their property and such other redress granted as to your Honours shall seem most fit, and Your Petitioners as in duty bound shall ever pray.
