

# Membership Dues - 1984

All memberships are on the calendar year basis and become due Jan. 1. # 1984 Membership-Surname Book

As our membership grows so does the size of our membership-surname book, however, we are making it available again in 1984 for only \$3. Enclosed in this issue of the Bulletin is the form we want you to use in listing your surnames and it will help us greatly if you will mail it back to us along with your membership dues check.

There is no charge for submitting this form with up to 8 surnames (16 for couples) nor is there any charge for us listing your surnames under your name in the surname book. Every member's name and address, along with the surnames submitted, if any, will be printed in the book and, again, at no charge to any one.

For those who want a copy of the book, when published in June or July, the cost is \$3 and we hope you will order it now along with your membership renewal. There is no better way to contact others interested in the surnames you are working on than through this source. More than 450 1983 surname books were ordered last year and we have had many favorable reports on results obtained.

#### A Short Review of Two Published Items

In this and future Bulletins, we will select one or two items from our inventory of pamphlets or books usually listed on the back inside page of the Bulletin and give you more information on each item and its contents than can be conveyed in its listed title.

1 - A directory of "Official South Carolina Highway Markers". This 156 page glove compartment size book published in 1978 by the Confederation of South Carolina Historical Societies in cooperation with the Dept. of Archives and History contains 470 markers, their locations by counties and highways, and the texts on each marker.

The book provides the traveler an opportunity to visit each site where history was made. It provides answers in advance of sightings which could lead to stops which offer information, interest, and enjoyment. All too often historical markers are "transit teasers", glimpsed in passing, raising the question "What did it say?". For those not visiting in S. C., there is much history of places, dates, battlegrounds, and people.

Price: \$4 postage and handling included.

2 - "List of Visitations of Rev. John Simpson while Pastor of Fishing Creek Presbyterian Church".

This is a 6 page pamphlet which contains the names of the families and its members Rev. Simpson visited between Dec. 12, 1774 and June 8, 1775. The list is not a complete list of all members of the church only those he was able to visit and instruct in the Catechism during this brief period of his ministry. Its greatest value to a researcher may be the listing of members in each family and as proof an ancestor was in this vicinity and a member of Fishing Creek Presbyterian Church.

#### FORMS

From time to time we get requests to recommend or suggest the type of forms or system of documentation that will enable one to take it step-by-step through family research.

As a society, we are not in the forms business and we are not familiar with all the systems available. We believe we can best serve your interest by confining our activities to genealogy research and publications. We are happy, however, to pass on to you the following form, member W. T. Skinner, with whose system we are familiar:

"The G. R. System consists of 10 basic segments of Genealogical research: 1-Check list, 2-Collateral lines, 3-Research register, 4-Published sources, 5-Census, 6-Wills, 7-Estates, 8-Deeds, 9-Pedigree Chart, 10-Family sheet. Each segment is thoroughly documented by easy to use forms, accompanied by instructions and tips on  $8\frac{1}{2}$ " x 11" bond paper that is 3 hole punched.

A complete set consists of 50 pre-sorted forms with instructions, plus a free relationship chart with each order. The price is \$10 (N. C. residents add 40¢ sales tax). The above may be ordered only from G. R. Systems, Box 1278, Matthews, N. C. 28106-1278."

# MAJOR KENNEDY'S BIBLE by George L. Irwin, MD

CECILE HENRY IRWIN, daughter of the late DR. WILLIAM JOHN HENRY of Chester, and grand-daughter of the late JUDGE JAMES KILLOUGH HENRY of Chester, has in her possession a curious and interesting Bible, said to be a KENNEDY family Bible.

The Bible is called a "saddle-bag Bible," from its shape and appearance. It is small  $-3\frac{1}{2}$  X  $5\frac{1}{2}$  X  $2\frac{1}{2}$  inches thick. It is covered in leather, has a leather flap, and closes with a metal button. It is made of linen paper and has fine print. It was printed in Belfast, Ireland, in 1746 by JAMES BLOW. Though difficult to read, it would be convenient to carry when traveling, even in a saddle bag.

The Bible is the Authorized Version. The Book of Psalms is in its usual place but is repeated at the end of the book in metered version, to be sung.

On a blank page is written - "Given to me the 11th Aug. 1923 by Mrs. S. E. Babcock (it belonged to her grand-father Jno. Kennedy) to give to posterity. J.K. Henry.

On the margins of various pages are written names and on one of these pages is sewn a few strands of hair. I believe that a clipping of hair was originally placed on each of these pages at the time of death of these persons. Notations found are:

JOHN KENNEDY
RICHARD KENNEDY
GEORGE KENNEDYS hair
MARY ANN K.
CATHERINE KENNEDYS hair

On other blank pages are listed a number of births with no last names:

ANN was born June the 9th 1750 CATRIN was born October the 9th 1753 JOHN was born October the 16th 1755 WIL. was born October the 2nd 1756 MARY was born July the 11th 1759 AGNESS was born March the --, ---- MARGARET was born January the 2nd 1763 JAMES was born May the 28th 1765 JANET was born May the 27th 1767 ROBERT was born August the 28th 1770 (?HOPE) was born August the 9th 1774 JOHN FOSTER was born December ---

Next is written the familiar epitaph:
Remember me as you pass by.
For as you are so once was I,
And as I am so must you be.
Prepare for Death to follow me.

DR. SYDNEY EUGENE BABCOCK was a veteran of the 1861-1865 war and a Chester physician. He was born in 1829 and died in 1892. He is buried at Old Purity with his first wife, MARGARET WOODS BABCOCK, and a son. MARGARET died in 1864.

EUGENIA COLEMAN BABCOCK was the second wife of Dr. Babcock. She was born in 1842 and lived in a house at the corner of Saluda and Hudson Streets in Chester, where a service station has been during my memory. She lived until 1929 and is buried in Evergreen Cemetery with other family members.

The parents of EUGENIA C. BABCOCK were GEORGE W. COLEMAN and MARY ANN KENNEDY. Mary Ann was the daughter of MAJOR JOHN KENNEDY and his wife.

MAJOR JOHN KENNEDY was born on 12 February 1770 in County Antrim, Ireland, and came to America at age 14 years to live with his brother, GEORGE KENNEDY, near Old Purity and near what would become Chesterville. He later married CATHERINE EVANS of Abbeville and their known children are:

HENRY - ?
RICHARD - married SARAH DeGRAFFENREID
MARGARET - married JAMES FAUCETTE WOODS, an attorney
MARY ANN - married GEORGE W. COLEMAN. Parents of EUGENIA
COLEMAN BABCOCK

JOHN - went to Mississippi

CATHERINE - married REV. L.C. HINTON, minister of the Baptist Church, Chester, 1851-1858, and 1861-1883. Parents of the late MISS ANNIE HINTON, of Chester

ELIZA JANE - married DR. GIRARD HINTON

MAJOR JOHN KENNEDY built the second or third house in Chester. He has been described as the "father of Chesterville" and "the founder of the Baptist Church" of Chester. He gave the land for the church about 1830, aided in the construction of the church which was finished in 1836, and deeded the land to the church in 1859. He was a member of its first Board of Deacons.

He operated a boarding house and inn with attached grog shop, the latter presided over by one of his relatives. In that day society and the church accepted the use of alcohol by virtually everyone but drunkenness was not tolerated. MAJOR KENNEDY, according to all witnesses, was a fine man and a pillar of the church.

It was from this inn that MRS. KENNEDY witnessed the excitement when AARON BURR dismounted and asked for aid of the bystanders near the inn. The inn was quite near the site of the AARON BURR ROCK today, near the top of "the hill" in Chester.

MAJOR KENNEDY raised a company of men for service in the Mexican War and the title of Major was used thereafter. He was twice elected sheriff.

MAJOR KENNEDY built a home for his daughter CATHERINE who married REV. L.C. HINTON and this home was torn down within recent memory. It was on Hinton Street facing College Street at the site of the present-day elementary school. The home was on 40A of wooded land which extended from the "old Charleston road" (present-day Columbia Street) to the Southern RR tracks to the Tanyard Branch. There was a path to the Baptist Church where REV. HINTON preached.

MRS. GEORGE W. COLEMAN started the first Sunday School at the Baptist Church in 1852/3. MAJOR KENNEDY also built her a home and it has been torn down recently to make way for the headquarters of the Chester Building and Loan Association on Saluda Street. He built a third home for a third daughter, MARGARET WOODS, in the Springstein Mill Village area.

MAJOR JOHN KENNEDY died on 7 April 1867 and is buried with many other family members in the cemetery at Old Purity.

The home of the HINTONS passed into the hands of CHARLES H. BRICE, an attorney, and then into the hands of JUDGE JAMES KILLOUGH HENRY. The Bible, which precipitated this foray into Chester history, was passed down from JUDGE HENRY to his son, DR. WILLIAM J. HENRY, and to his daughter, CECILE HENRY IRWIN.

Now, back to the Bible. The front flyleaf is missing and the name of the original owner does not appear. We have the word of MRS. BABCOCK and JUDGE HENRY that this was the Bible of MAJOR KENNEDY but I do not believe it originated with him. The names on the margins of the pages correspond to the names of his children with the exception of GEORGE KENNEDY, which was the name of his brother. But the names and dates of the births listed are earlier in time and would correspond to births of

the era when MAJOR KENNEDY himself was born. However, his name and birthdate do not appear. I would expect them to if the Bible originated with his father. However, it most certainly did originate in the family of MAJOR KENNEDY and almost certainly in Ireland.

As JUDGE JAMES KILLOUGH HENRY recorded the wish of MRS. S.E. BABCOCK, the information in this old Bible is herewith passed on "to posterity."

I have examined the old Bible most carefully but for much of the other information in this essay, I am indebted to others. I used the following sources:

David Gwinn of Brighton, Tennessee sent the following items from his scrapbook collection. Most have roots in the "Carolina Cradle" and we appreciate his sharing this information with us.

Died - July 12, 1884 at the age of 81 years, 5 months, and 3 days, John Simpson, Jr. in Chester Co., SC. He was of Scotch-Irish descent and was the son of John Simpson who emigrated to SC in early life. The subject of this notice was the 2nd child by a 2nd marriage, but the 4th child of his father's family. His mother was an Adams. In early life he married Sarah Wylie and joind Union A.R.P. Church. Became an Elder at Union and resigned in 1857 when he removed to Chester C.H. Nine children were the fruits of his 1st marriage. Two of his children

are Elders and one is a minister in the Virginia Presbytery. Mrs. Sarah Wylie Simpson died May 15, 1866. On July 10, 1874, he married Miss Nancy Lathan of Hopewell A.R.P. Church.

<u>Died</u> at Troy, Tennessee, May 23, 1890 at the age of 44, Samuel Curry, son of William and Betsy Moffatt Curry. He was born Chester Co., SC and came to Obion Co., Tenn. in 1848 with his parents and his brothers, Stafford and Millen. He married Rispa Eury in Feb. 1868.

Died at Idaville, Tenn., July 12, 1890, at age 18, Henry Conner McCain.

Died August 10, 1890 at East Troy, Tenn., Berta, dau. of J. C. and Laura Hamilton in her 23rd year.

 $\overline{\text{Died}}$  in Troy, Tenn., May 23, 1885, Augustus Peden Moffatt, son of  $\overline{\text{James}}$  S. and Martha Moffatt. He was born in Greenville Co., SC near Fairview Church, March 3, 1830. Removed to Troy when a boy. He was a ruling Elder in the A.R.P. Church for 25 yrs. He was thrice married.

Died May 6, 1885 in Chester Co., SC at age 74 years, 5 months, and 21 days, Elizabeth McDill Smith, wife of Capt. John Smith. Member of Hopewell A.R.P. Church. INTERSTING ITEMS ABOUT VARIOUS POINTS IN CHESTER COUNTY By the late Arthur Cornwell in 1923

## Lando

Situated in the eastern part of Chester county, two miles south of Edgemoor, five miles north of Richburg, on Fishing Creek, is the manufacturing town of Lando. People were living there before the Revolutionary war.

Tradition has it that Lord Cornwallis and his officers spent the night there in a house on the hill when they marched thru a part of this county. The house stood for a long time, but was torn down some time ago to make room for a more commodious building.

There was a mill at Lando, owned and operated by a man White, considerably more than a hundred years ago. Major Eaves owned it after Mr. White, and had the mill operated for many years. He was an officer in the Mexican war, and a very influential man in the county.

Jess Williford bought the place from Major Eaves. Hon. F. H. Barber was the next owner. In 1880 he commenced collecting material and laying the foundation for the first cotton mill there and commenced operation in 1882. He was not successful and some years later it was sold to the present owners, the Manetta Mills, Inc., who have made many improvements all around the place.

#### Knox

Seven miles east of Chester is Knox's station on Chester and Lancaster railway. The road was completed to Richburg the latter part of 1877 or very early in 1778. It was named for the Knox family. William Knox lived and died there. He was one of the wealthiest men of the county in his day. He settled near where the station is around one hundred years ago.

#### Hollis

Hollis is not on a railroad, but is in a section ten miles east of Chester, and named for the Hon. P. T. Hollis, and his connection. Their ancestors have lived around there for years, and the indications are that their descendants will be there for years to come.

#### Wylie's Mill

Three miles east of Richburg on Fishing creek and right by the side of what was once known as the Chester and Lancaster highway is the mill from which Wylie's Mill post office and later the community got its name.

The mill was first built and operated by a man named Simpson more than a hundred years ago. It was later owned by William Caldwell (grand-father of R. B. Caldwell of Chester). After Mr. Caldwell it was owned by the wife of Capt. O. A. Wylie. Mrs. Wylie was a daughter of William Caldwell.

In 1891 C. M. Ferguson and brother bought the mill from Mrs. Wylie. It has been in possession of the Fergusons ever since.

Fudges

Three miles south of Landsford and two miles north of Fort Lawn is Fudges, which is situated on the Catawba Valley railroad.

Around a hundred years ago, Richard H. Fudge owned and lived near this place. His first wife was Martha Edwards, a sister of Joseph J., Exum, and other sisters and brothers. More than a hundred years ago Exum Edwards was accidentally killed at his mill on Fishing creek at Cedar Shoals.

W. D. Fudge, a son of Richard H. Fudge, lived, raised a family, and died near this settlement. His grandson, and namesake, Richard H. Fudge, lives only three miles away now. One of his great-grandsons is living right at the station.

When the Catawba Valley railroad was completed in 1906 the station at this place was named for the Fudge family. Richard H. Fudge was a very intelligent and prominent man.

#### Rowells

Situated in the north eastern part of Chester county, two miles south of the York County line, two miles west of the Catawba river, where, once was known as, the Yorkville and Lancaster Highway crosses the Columbia road is Rowells' station.

Ninety years and more ago a man named Jerry Rowell lived and died there. After him one of his sons, Isaac, spent the greater part of his life there. In 1906 the Catawba Valley railroad was built and the station at this place was named for the Rowell family.

Many of the descendants own land and live around there, but not one of the name can be found anywhere in the county today.

# Fort Lawn

Fort Lawn is on the Lancaster and Chester and Catawba Valley Railways, one mile west of the Catawba River and four miles north of where Fishing Creek runs into the river. Among the early settlers in and around Fort Lawn were: Alexander Walker and Esther Gaston (his bride), Frank Ingram, James Wilson, J. J. Edwards, Dr. Daniel C. Anderson, and Henry Culp. These and many others lived in the surrounding community.

A few years after the close of the Confederate War, Dr. Fort came into the community and married a daughter of John A. G. Walker. His wife did not live long and after a number of years he married a Miss Jefferies from Gaffney. He finally moved to Gaffney, but his daughter by his first wife was left a large part of her grandfather Walker's plantation. Dr. Fort was a good man and well thought of. In 1874, when the Lancaster and Chester railroad was surveyed and grading begun, and in 1878, the first train rolled into Richburg. In 1879, it came into the station between Fishing Creek and the river, so they named it Fort Lawn in honor of Dr. Fort.

The first Methodist church in the county east of Fishing Creek was near Fort Lawn. Methodist Union was its name, but this church and graveyard were abandoned in the 1850's and nothing remains to mark the place except a few tombstones and many graves of the noble men and women of that day.

\* \* \*

Rev. William Fowler's Meeting House was located about 500 yards from the west bank of Rocky Branch and about  $1\frac{1}{4}$  miles southeast of the present Calvary. This first church was also known as Sandy River Church and was organized in 1776. Some estate citations were read at Fowler's Meeting House in the 1790's. The site has a graveyard with some rock markers, but no gravestones.

"Erasmus Withers Allen, my mother's maternal great-grandfather. This book was sold with the estate of Erasmus Withers Allen and bought by my step-grandfather, Alexander Craig, in 1804. At his death, it passed into the hands of my grandmother, Mary W. Blakeney, who died in 1857. My mother, Amelia Haile, then inherited it. At her death, which occurred in 1880, it was purchased by myself." Signed Chas. E. Haile "Should my boy W. Allen Haile survive me, this Bible decends to

him." Dec. 22, 1882 C. E. Haile "This Bible was bought by Erasmus Withers Allen, Dec. 20, 1743. He was my mother's maternal great-grandfather, of the Episcopal Church, an Englishman by birth, died a Methodist, aged 75. His wife, also born in England, an Episcopalian, died a Methodist, aged 89. THE CHARLOTTE OBSERVER March 17, 1966

Rock Hill, S. C. - Many residents of this area still have bits and pieces of an infamous old tavern that used to stand in the Six Mile Creek community near here.

The tavern didn't mean much itself, but the man who owned it did. Part of the mystery of Milt Chaney still hasn't been solved.

Chaney, the story goes, was a swarthy giant with a heavy beard. He spoke with an accent, but its deriviation has been forgotten.

Early in the 1820's, Chaney operated a tavern that was frequented by traders driving cattle or carrying their goods from North Carolina, Virginia and Tennessee to the markets in Charleston, S. C.

Chaney's tavern offered a haven to the traders, but if the stories of the times are to be relied upon, many of the traders never left the tavern alive. Old newspaper files tell many stories of travelers disappearing after a stay at Milt Chaney's Inn. But none mention Chaney by name.

Suspicions nevertheless grew, when people from Virginia, Tennessee and North Carolina continued to report relatives missing after trips to the Charleston markets.

Many followed their loved ones' trails to Charleston and back to Chanev's Inn.

Yet with all eyes turned accusingly toward him, Milt Chaney, the sullen innkeeper was never called upon to answer for the suspected crimes.

Chaney's demise came a few years later, when he was convicted of stealing a slave from Dr. Mart Crawford. He was brought to trial and hanged.

Many years after Chaney's name had become a terror in the area and after he had been hanged, the first definite evidence of the murders came to light. Workmen excavating for a new road at the tavern site unearthed a human skeleton, then another and another. Terrified workmen fled from the spot. Old residents wagged their heads. The findings settled Milt Chaney's guilt in their minds.

## LYNN LETTER (Continued from the September, 1983 Bulletin)

Today, we will continue our trip on the roads in Lewisville Township around Richburg as started last month. This road turned off of Chester to Lando Road just below the Will Kitchen place to the left and goes to Fishing Creek Presbyterian Church. All the land on the right side of this road to the South Fork of Fishing Creek is a part of the Joseph Gaston Place still owned by the Porter Gaston family; the only house on this place belongs to James Gaston. On the left side of the road is what was known of as the McDaniel Place once owned by H. K. Sanders and his wife, Helen Reid Sanders. Off the road to north behind this place was the Sanders Place. This is now owned by the Campbell family, the rest of the McDaniel place did cross South Fork and goes to the Seaboard Railroad; was once owned by Rogers Reid and I think he still owns it, a two story house used to stand near the Railroad crossing, but it is no more. Across South Fork on the right is what was known as the Wylie Place owned by Joseph Alexander Gaston and his wife, Elizabeth Wylie. They were parents of my grandmother Hollis who was Victoria Gaston, wife of Peter Turner Hollis. This place was left to Uncle Porter Gaston and his wife, Nancy Dunlap. They had no children of their own, but used to welcome me along with my numerous Hollis and Gaston cousins to spend a good part of the summer at this old house to enjoy swimming and fishing in the creek; also Aunt Nancy's delicious food. They seemed to enjoy our visit, I think, "at least we did." This place is now owned by Fred Hambrite.

After you cross the railroad, the land on both sides of the road belonged to Mr. Cloud Hicklin, a big man in stature, he lost part of one of his arms in the Civil War. I remember him well. There was a railroad siding about 300 yards from the railroad crossing and a station

where you could flag the local train from Atlanta to Hamlet, N. C. My sister and I used to catch this train to go to Waxhaw, N. C. to visit my father's sister, Aunt Ellen Nesbet. I think it cost us 25¢ apiece one way. It was a pleasant ride to us since the train stopped at Van Wyck and Osceola and we had time to eat the candy pills in the glass pistol and train engine sold by the newsbutch as he passed through the train; the candy pistol and train engine cost 10¢ each. It was hot on the coach and the cinders came in the opened window and dirtied your white Sunday shirt.

Mr. Hicklin's fine old house still stands on the right side of the road, his land went on to join Fishing Creek Church property on the right and on the left to the Rader place which was on the left across from Fishing Creek Church. Two of my grandfather Lynn's sisters lived at the Rader place; they were Aunt Margaret Montgomery, wife of Greenberry Montgomery and her sister, Aunt Roseanna Lynn. These two ladies along with two other sisters are buried in Union Cemetery on the Lynn lot. They left 100 shares of stock in the Peoples Bank of Chester to help maintain the cemetery. This place is now owned by Harry Hicklin, Jr. The Cloud Hicklin place is owned by Mrs. Frank Hicklin.

Next month, we will travel the road from Fishing Creek Church to Rodman.

#### THIS AND THAT

The following article was written by a 9th grade student, Mary Curtis Hobbs of Charlotte, N. C. in 1929, for her school paper.

"This summer while I was in Wilmington, I was told about an old Southern plantation that my grandmother and her forefathers lived in, so I visited it.

The house is a huge old white mansion with a long back porch. Before the Civil War, it was the most widely known estate in the eastern part of North Carolina. It covered miles of pine forest and land. There was a broad avenue leading down to the Black River where a dock and boats stood. The plantation has a deer pack and large stable full of horses. There were 25 to 35 log cabins where slaves lived.

The home was furnished with beautiful antique furniture, mahongany, walnut, curly maple and other valuable wood. Some of the shelves contained books dating back to the 17th century with history of my forefathers.

Out in the yard were huge oaks that a wealthy Scotch woman, Betsy Kelsoe, planted from seeds brought from Scotland across the Atlantic with her in the 17th century. She had a romantic marriage. She fell in love with Daniel Kerr coming over on the ship and married him.

This large home was built by them. On the plantation is a graveyard where Betsy Kelsoe, Daniel Kerr, and other occupants of the plantation are buried.

Some of the Kelsoe china is still in existence, with some of the owners of the plantation. The gorgeous furniture was divided among different owners, and I regret to say here that my grandmother sold her share of the plantation, however; my aunt told me that the Kelsoe coat of arms is the most beautiful one that she has ever seen. I have been promised that I shoud see it, something I long to do. After eating our lunch, we had one last look at the house and left."

Marissa, Illinois Named by Chester Man
This article, sent to us by one of our Marissa, Illinois members, appeared in their paper in 1947.

James Wilson left Chester County during the time the Covenanters were leaving to go West because of the protest over owning Negro slaves. "Mr. Wilson, a self-educated man, who had studied Greek and Hebrew until he could read the original, found the name Marissa in the works of Flavius Josephus, a three-volume history of the Jews. He liked the name because of its musical sound and because of the interesting history connected with that city in ancient Judea, some 40 miles southeast of Jerusalem which was destroyed three times and rebuilt. The name Marissa was spelled in Josephus' history the same as it is today, although Mr. Wilson told relatives that the name also appears in the Second Book of Chronicles 14:9-10 in the Bible, spelled Mareshah. The city Mareshah can be found in most Bible maps, although earlier maps in a story of the Bible shows Marissa on the same spot. Josephus says Marissa was a colony of Jews in Judea which was destroyed three times and rebuilt during the wars to free the Jews to worship as they pleased. It was one of the cities of IIumea at one time that was inhabited by Phoenicians and Syrians, who later became Jewish converts.

So goes to James Wilson the honor of naming Marissa in 1846. Wilson was born of Irish parentage back in Chester, S. C., came to Illinois in 1832, then went back south, married and returned to St. Clair County, where he settled in 1841. He became the first postmaster and it was up to him to give the settlement a name. The site of the old post office

was the old John K. White farm where the old desk used by Wilson still remains in the possession of Joe White. Both Wilson and his wife are buried in the Marissa cemetery."

#### Heath Records - 1954

Thomas Coke Howze, 60 years ago, wrote a sketch of Methodism in Chester County. He states that Carter's Meeting House was the first Methodist church in that section, and was on Wateree circuit with William Capers as pastor. This was located 3 miles north of Fort Lawn, near Landsford. It must have been very soon thereafter that Heath's Chapel was set up below Fort Lawn near Great Falls. It may have been the same year William, James, Jesse, and Adam Heath had recently emigrated from Prince George County, Virginia and settled in Chester County.

Soon after 1820, Heath's Chapel and Carter's Meeting House merged on a site nearer to Carter's and the new church was called Union. This continued until 1853. Not long after this merger, Bethesda Church was formed near the Fairfield line, on a site called "Grant's Old Field".

Thirty years growth was such that Union was divided into two churches: El Bethel and Mount Prospect.

The present Heath's Chapel came into existence about 1892 or 1893. It appears for the first time in 1893 Journal. But the previous year reveals an expenditure of \$1,300 on new building. It was most appropriate that the name of "Heath" should be given to the new church, thus carrying on the hallowed tradition of our early Methodism there.

There is an old Heath private cemetery located just off the road that leads off the road from Heath's Chapel Church to Fort Lawn. This private cemetery lies back of "Doc" Barber's old home, just off the road that runs out at the creek. "Doc" Barber was a very religious man, attending camp meetings and revivals. Some of the Heath's are buried in that old cemetery. James Heath b. 1808, d. 1862, married Charlotte Blake in 1845, is buried in Danville, Kentucky, where they spent their married life. Charlotte came back to Chester County with her children: Carolina Virginia, James Blake, David, and Joshua.

Moses Heath was married twice, second wife a Miss Wrenn. She is buried at old Union cemetery.

Osgood Pierce Heath was born in Lancaster County, in 1856. His parents were Moses O. and Mary Morrow Heath. Osgood and his brother, E. J. Heath were successful business men, also in the partnership was brother, B. D. Heath. Osgood married Annie Lee Potts of Lancaster in 1878.

Elizabeth Heath b. 1807, d. 1880 is buried in Heath cemetery. She married James H. Barber b. 1812, d. 1850. James was a grandson of John Barber, immigrant from York County. James and Elizabeth had a son James Geddings Barber b. 1845, d. 1897, married 1869, Mary E. Stevenson b. 1844, d. 1883. She was the daughter of Daniel Roberson Stevenson and Elizabeth McCullough Stevenson.

Elizabeth Heath's father was Adam Heath b. 1759, d. 1837, wife Lucy Heath. Adam's father John Heath, d. 1765, Halifax County, N. C. His wife was Elizabeth.

Starnes Creek Baptist Church was organized in 1805 and located about one mile west of Fowler Meeting House near Starnes Creek. There was a graveyard there, but the gravestones were removed about 50 years ago and the cemetery destroyed.

Sanders Meeting House followed Starnes Creek Church, located at the same site, but it ceased to exist.

The following article was taken from "Migration of South Carolina" by Janye Conway Garlington Pruitt and was sent to us by Martha Hawkins.

"Who were the South Carolinians taking up land in Tennessee, Alabama, Mississippi, and what route did they travel? It is said that 40% of South Carolina's native-born had moved from the state by 1850-1860.

A great number crossed the Savannah River at Augusta or Ross's Landing. The "Georgia State Road" was used by many. The Natchez Trace or Chickasaw Road, was an old Indian Path, the southern portion extending from Nashville, Tenn. to Natchez, Miss., a distance of about 500 miles.

By 1820, the land ceded by the Choctaw Indians was divided into many

counties and rapidly settled.

Outstanding preachers were on the Trace before 1800, among them being James Hall of Salisbury District, N. C. and Lorenzo Dow of Connecticut. Those going from South Carolina before 1850 were: Henry Simmons, Zachariah Reeves Sr., Isaac Muse, S. P. Whitten, Francis C. Spraggins, Lewis R. Holloway, Samuel Thigpen, William Allen, Thomas Nixon, Stephen Herring, Seyan Mayfield, Frederick Weaver, William W. Nash, William Kitchens, Elam Waddell, Amos Lee, Joseph Robinson, G. W. Boggs, James P. Commander, Frederick Harmon, Enos Fletcher, G. W. Burt, G. H. Brown, Wilson Clark, James Smiley, G. P. Claughton, Lemuel E. Wall, A. B. Laurence, James Robin, William Young, William V. Frierson, Thomas C. Stuart, Lewis Ball, Martin Ball, Elijah Browning, V. W. Brock, James N. Carothers, G. W. Murray, Jonah Seale, Thomas Gore, James Laughridge, Alexander Rembert, Henry L. Sloan, Robert B. Campbell, Weyman Adoit, Jacob Mathews, S. I. Caldwell, James C. Terrant, and James Smith."

KNOW all men by these presents that we John McKown and Jane McKown of the County of Chester, State of South Carolina, for divers good causes and considerations as hereunto moveing, have made ordained authorised and appointed and by these presents do make ordain authorise and appoint George McKown of the County of Burton (Barbon) and State of Kentucky our true and lawful attorney for us in our names, and to our own use, to ask, demand, sue for, recover and receive from John McKown or Alexander McKown formerly of the County of Lancaster and State of Pennsylvania, Executors of the last Will and Testament of George McKown of the said County of Lancaster of State of Pennsylvania, deceased, or from any other person or persons whatsoever that may have the charge or care of said Estate, or be liable to be sued therefor at Law, all such sum or sums of Money Debts Legacies dues and demands whatsoever, which now are due and owing unto us the said John McKown and Jane McKown by and from the Estate of the said George McKown deceased, and to have and use and take all lawful ways and means in our names or otherwise, and to agree and compound for the same, and acquittances or other sufficient discharges for the same for us and in our names to make seal and deliver, or to do all other lawful acts and things whatsoever concerning the premises, as fully in every respect as we ourselves might or could do, if we were personally present, and Attorneys one or more under him for the purposes aforesaid to make and at his pleasure to revoke, ratifying and allowing all and whatsoever our said Attorney shall in our names lawfully do, or cause to be done in and about the premises by virtue of these presents.
